Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Tackle.io Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.



Notes to Financial Statements

1. Description of Plan:

The following brief description of Tackle.io Inc. 401(k) Plan (the Plan) is provided for general information purposes only. For more complete information, participants should refer to the text of the Plan document.

General:

The Plan is a defined contribution plan covering substantially all full-time employees of Tackle.io Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions:

Each year, participants may contribute a percentage of pretax annual compensation, as defined in the Plan. Additionally, participants age 50 or older may elect to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Contributions are subject to certain IRS limitations. The Plan provides for discretionary employer contributions and safe harbor matching contributions. The Company currently matches 100% of the amount of the Participant's Elective Deferrals that does not exceed 3% of the Participant's Compensation, plus 50% of the amount of the Participant's Elective Deferrals that exceeds 3% of the Participant's Compensation but does not exceed 5% of the Participant's Compensation.

Effective January 1, 2025, the Plan was amended to eliminate the safe harbor employer matching contribution and will provide only a discretionary matching contribution.

Participant Accounts:

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are vested immediately in all contributions and earnings thereon.

Investment Options:

Participants may direct contributions into various investment options offered by Fidelity Management Trust Company (Fidelity). Participants may change their investment options at any time.

Notes Receivable From Participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. Loan terms range from 1 to 5 years, unless the loan is used to acquire a principal residence. The loans are secured by the vested balance in the participant's account. The loans bear interest at a rate equal to 2% above the prime rate, which is fixed for the duration of the loans. Repayments on principal and interest are paid ratably through payroll deductions or check.

Payment of Benefits:

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over other allowed periods. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan allows for in-service withdrawals for active employees that have reached normal retirement age, as defined by the Plan. Additionally, hardship withdrawals are permitted if certain criteria are met.

2. Summary of Significant Accounting Policies:

Basis of Accounting:

The financial statements of the Plan are prepared under the accrual method of accounting.

Investment Valuation and Income Recognition:

The Plan's investments are stated at fair value (except for the insurance company general account, which is reported at contract value (see Note 3)). The registered investment company shares and money market fund are valued at unadjusted quoted market prices for identical assets in active markets.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Unrealized appreciation or depreciation on investments is charged or credited to the net assets of the Plan.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits:

Benefits are recorded when paid.

Use of Estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Subsequent Events:

The Plan has evaluated events and transactions for potential recognition or disclosure in the financial statements through October 2, 2025 (the date the financial statements were available to be issued).

Reclassification:

The financial statements for the year ended December 31, 2023 have been reclassified to conform with the presentation adopted for December 31, 2024.

3. Insurance Company General Account:

The Plan maintains an insurance company general account with Standard Insurance Company. Standard Insurance Company maintains the contributions in its general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Standard Insurance Company is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than one percent. Such interest rates are reviewed quarterly for resetting. Standard Insurance Company generally declares additional amounts above the guaranteed rate based on the performance of the invested assets.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, the liberalization of plan withdrawal or transfer rules, or prohibited participant communications. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

4. Financial Information Certified by the Trustee (unaudited):

In accordance with the Department of Labor's Regulation 2520.103-8, the plan administrator has obtained certified "Statements of Account" from Fidelity as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that the information summarized below is complete and accurate:

- Statements of Net Assets Available for Benefits - Investments.
- Statements of Changes in Net Assets Available for Benefits - Investment income.
- Supplemental Schedule of Assets (Held At End of Year) - all items and amounts, except for notes receivable from participants.

5. Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

6. Administrative Expenses:

Certain administrative expenses of the Plan are borne by the Company. Expenses relating to investments are paid by the Plan.

7. Tax Status:

The Internal Revenue Service issued a favorable opinion letter on the tax status of the Plan. Accordingly, no provision has been made for income taxes.

8. Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
