Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. ### Note 1. Description of the Plan

#### General

The following description of Borinquen Health Care Center, Inc. 401(k) Plan (the “Plan”) provides only general information regarding the Plan. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

The Plan, which started on January 1, 2005, is a defined contribution plan under Section 401(k) of the Code sponsored by Borinquen Health Care Center, Inc. (the “Organization”) covering all employees who have completed two months of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Empower Trust Company, LLC (“Empower”) is the custodian of the Plan. Empower Annuity Insurance Company of America is the record keeper of the Plan. Management of the Organization controls and manages the operation and administration of the Plan.

#### Contributions

The Plan permits eligible employees through a salary deferral election to have the Organization make annual pre-tax or Roth contributions up to 75 percent of eligible compensation. The maximum allowable contribution totaled \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively, subject to certain discrimination tests prescribed by the Internal Revenue Code. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions up to \$7,500 for years ended December 31, 2024 and 2023, subject to certain discrimination tests prescribed by the internal revenue code. Employee rollover contributions are also permitted.

For the years ended December 31, 2024 and 2023, the Organization contributed discretionary matching amounts of \$100,000 and \$102,432, respectively. Eligible employees must have completed a year of service for the plan year and be employed on the last day of the plan year to receive an allocation of the discretionary employer matching contribution.

Contributions are subject to certain limitations.

#### Participant Investment Account Options

Each participant has the option of directing their contributions into any of the separate investment accounts and may change the allocation daily.

#### Participant Accounts

Each participant’s account is credited with the participant’s contribution, the Organization’s contribution, and plan earnings and is charged with an allocation of administrative expenses.

### Note 1. Description of the Plan – continued

#### Participant Accounts - continued

Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their voluntary contributions and the Organization's matching contributions plus earnings thereon.

#### Payment of Benefits

Upon termination of service, a participant may elect to receive a lump-sum amount equal to the value of the participant's account. Withdrawals other than for termination are permitted under circumstances provided by the Plan.

#### Forfeitures

As of December 31, 2024 and 2023, unallocated accounts totaled \$2,614 and \$2,577, respectively. These accounts represent employer contributions made to and forfeited from certain participant accounts that will be used to reduce future employer contributions. No unallocated accounts were used in 2024 and 2023.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis, and related fees are recorded as administrative expenses when incurred. No allowance for credit losses has been recorded as of December 31, 2024, and 2023. Management believes the risk of loss is minimal; furthermore, no allowance was necessary in 2023 because the Plan did not have any participant loans outstanding. As of December 31, 2024, the Plan had outstanding notes receivable from participants with principal balances totaling \$102,011. As of December 31, 2023, the Plan had no outstanding notes receivable from participants.

Beginning January 1, 2024, participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or fifty percent (50%) of their vested accounts balance. Only one loan may be outstanding at a time, and participants are limited to one loan per calendar year. Loans are secured by the participant's vested account balance and bear interest at 1% above the prime rate published in the Wall Street Journal on the first business day of the month in which the loan is originated. Repayments are generally made through payroll deductions over a term not exceeding five years. Outstanding loans that are not repaid upon termination of employment are treated as deemed distributions and offset against the participant's vested account balance.

### Note 2. Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Mutual funds are recorded at fair value in these financial statements, as prescribed by Accounting Standards Codification No. 820, Fair Value Measurements, ("ASC 820"). ASC 820 defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Additionally, ASC 820 establishes a framework for measuring fair value and expands disclosures about assets and liabilities measured at fair value. For information related to the Plan's valuation methodologies under ASC 820, see Note 5 of these financial statements.

The Plan's interest in the collective trust funds is valued based on information reported by the investment advisor using the audited financial statements of the collective trust at year end.

The Plan's investments in fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. During 2024 and 2023, there were excess employee contributions of \$27,218 and \$23,449, respectively. The Plan distributed the 2024 excess contributions to the applicable participants during 2025.

#### Payments of Benefits

Benefit payments to participants are recorded upon distribution.

#### Administrative Expenses

Administrative expenses may be paid by the Organization or the Plan, at the Organization's discretion.

#### Reclassification/Comparative Data

Comparative data for the prior year has been reclassified to conform to the current year presentation in order to provide a better understanding of changes in the Plan's financial statements.

### Note 3. Certification of Plan Insurance Company and Trust Company

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC and Empower Annuity Insurance Company of America, qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, dividends and interest (which includes interest income on notes receivable), reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024 and 2023.
- Investment information included in the accompanying schedule of assets (held at year-end) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

The Plan has investments that are held in a guaranteed investment contract directed by each participant. The annuity contract has a guaranteed interest minimum. The aggregate value of the minimum guarantee is \$525,169 and \$503,083 as of December 31, 2024 and 2023, respectively.

During 2024 and 2023, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$400,192 and \$517,309, respectively.

### Note 4. Related Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan invests in a guaranteed investment contract managed by Empower Trust Company, LLC, as included in the supplemental information in Schedule H, Part IV, Line 4(i) - Schedule of Assets (held at end of year). Empower Trust Company, LLC is the custodian as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

The Organization provides certain administrative services at no cost to the Plan and pays certain other fees related to the Plan's operations. During the years ended December 31, 2024 and 2023, the Plan paid \$49,445 and \$42,299, respectively, in administrative expenses.

### Note 5. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

*Mutual funds:* Valued at the net asset value (NAV) of shares held by the Plan at year-end. The mutual funds held by the Plan are deemed to be actively traded and have a readily determinable fair value.

*Collective trusts:* Valued as determined by the custodian based on net asset values and recent transaction prices. Net asset values per share are generally obtained directly from the fund house or other investment provider.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **Note 6. Guaranteed Investment Contract**

The Plan holds a fully benefit-responsive deferred annuity investment contract with Empower Annuity Insurance Company of America (Empower) totaling \$525,169 and \$503,083 for 2024 and 2023, respectively. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. At the end of the year a renewal interest rate is established. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The fixed annuity account is fully benefit-responsive, therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) employer initiated events (including complete or partial plan termination or merger with another plan, spin-offs, or layoff of at least 20 percent of the workforce in any 12-month period), (2) changes to the Plan's prohibition on competing investment options unless mutually agreed upon by Empower and plan sponsor, or (3) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The fixed annuity account does permit the insurance company or the Organization to terminate the agreement with 90 days' notice.

### **Note 7. Plan Termination**

Although it has not expressed an intention to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts. The employer has the right to amend the Plan at any time.

### **Note 8. Tax Status**

The Plan operates under a volume submitter profit-sharing plan sponsored by The Retirement Advantage, Inc. The plan document has been pre-approved by the Internal Revenue Service according to an advisory letter dated March 31, 2014. Effective January 1, 2022, the Plan was restated and amended by adopting a non standardized profit sharing plan document sponsored by The Retirement Advantage, Inc. This plan document was preapproved by the Internal Revenue Service according to an advisory letter dated June 30, 2020. Therefore, the plan administrator believes the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdiction; however, there are currently no audits for any tax periods in progress.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.
