Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Stonetown Capital Group 401(k) Plan, f/k/a Stonetown Capital Group LLC 401(k) Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and the related statement of changes in net assets available for benefits for the year then ended and the related notes to the financial statements.

The following description of Stonetown Capital Group 401(k) Plan f/k/a Stonetown Capital Group, LLC 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of Stonetown Capital Group, LLC (the "Company") who have completed three months of service and are age 21 or older and was amended and restated effective May 10, 2024. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The Company is the trustee and plan administrator of the Plan. Effective May 10, 2024, Matrix Trust Company functions as custodian, and Human Interest, Inc. is the recordkeeper. Prior to this date, Mid Atlantic Trust Company functioned as the custodian and Paychex, Inc. was the recordkeeper.

Contributions

The Plan provides for employee salary deferral contributions up to a maximum of 90 percent of annual eligible compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan allows participants to contribute up to 50 percent of their eligible compensation on an after-tax basis. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. Eligible employees may elect to make catch-up contributions, as limited by the Internal Revenue Service (IRS). Employee contributions to the Plan are made through regular payroll deductions.

Certain participant contributions in 2024 were paid after the time frame required by the Department of Labor. The Company remitted these contributions during 2024 and remitted a portion of the related lost earnings to the Plan in 2024 and the remaining lost earnings in 2025.

The Plan provides for employer matching contributions of 100 percent of elective deferrals up to 3 percent of eligible compensation and 50 percent of elective deferrals between 3 and 5 percent of eligible compensation. Matching contributions are funded each pay period. The Company may make a discretionary profit-sharing contribution based on a pro rata ratio of each eligible participant's eligible compensation to the total eligible plan compensation. Participants are eligible to receive employer matching contributions after completing three months of service and are eligible for profit-sharing contributions after one year of service. There was no discretionary profit-sharing contribution for the year ended December 31, 2024.

Participant Notes Receivable

Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. Prior to the change in recordkeeper and resulting plan amendment effective May 10, 2024, participants could borrow from their vested accounts a minimum of \$1,000 up to a maximum equal to the lesser of 95 percent of one half of the vested account balances or 95 percent of the total vested account balances, excluding the Roth elective deferral balance and the loan amount could never exceed \$50,000. The notes receivable are secured by the balance in the participant's account and bear interest at rates that range from 4.25 to 9.50 percent, which are commensurate with local prevailing rates determined periodically by the plan administrator. Principal and interest are paid ratably through payroll deductions, and the notes receivable mature at various dates through October 2029.

Note 1 - Plan Description (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with plan losses and an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants are immediately 100 percent vested in employee salary, employer matching, and rollover contributions and any income or loss thereon. Vesting in the Company's profit-sharing contributions, plus actual earnings thereon, is based on years of service. Participants are 0 percent vested in profit-sharing contributions until they become fully vested after three years of service. A participant's account becomes 100 percent vested upon death or disability.

Benefit Payments

On termination of service due to death, disability, or retirement, a participant or his or her beneficiary may receive, at his or her election, a lump-sum payment, partial payment, installment payment, or annuity in the amount equal to the participant's vested balance. In the event a terminated participant's balance is less than \$5,000, the vested account balance will be distributed as a lump-sum payment to the participant. The Plan allows in-service distributions to participants age 59½ or older who have not terminated their employment with the plan sponsor.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future employer contributions or to pay administrative expenses of the Plan.

Party-in-interest Transactions

The Plan provides for loans to participants, held by the Custodian, which are party-in-interest transactions that are exempt from the prohibited transaction rules. These transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value based on quoted market prices. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Note 2 - Summary of Significant Accounting Policies (Continued)

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 13, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

In 2024, the Plan changed its custodian from Mid Atlantic Trust Company to Matrix Trust Company. Matrix Trust Company (the "Custodian") held the Plan's investments and executed all investment transactions subsequent to change during 2024. The investment balances as of December 31, 2024 and interest and dividend income of \$89,002 and net realized and unrealized gains and losses on investments of \$343,867 included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Custodian.

Interest and dividend income of \$46,291 and net realized and unrealized gains and losses on investments of \$527,640 included in the accompanying financial statements were uncertified.

Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Note 4 - Fair Value Measurements (Continued)

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
