Safeguards in place related to our financial statement preparation service include a review by an independent second partner, who is not part of the engagement team. In addition, management has reviewed and approved the financial statements prepared.

## 1. Description of Plan

The following description of the BOMAG Americas 401(k) Plan (the "Plan") provides only general information. Participants may refer to the Plan document for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution plan which provides retirement benefits to employees of BOMAG Americas, Inc. (the "Company"). All employees over 18 years old, except those that are residents of Puerto Rico, or interns, are eligible to participate in the Plan and receive matching employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective January 1, 2024, the Plan was amended and restated to align with the Company's business objectives. The Plan was amended to (1) institute an automatic enrollment feature for all employees accompanied by an automatic deferral election of 2%, (2) replace safe harbor matching contributions with non-discretionary employer matching contributions and (3) implement safe harbor nonelective employer contributions. The Plan was further amended on November 25, 2024, to (1) update eligibility provisions of the Plan such that interns are excluded from plan participation and all employees must be 18 years old to participate, (2) remove automatic enrollment and deferral provisions previously implemented and (3) convert safe harbor matching contributions to employer matching contributions.

### Contributions

The Plan allows contributions of up to 90% of a participant's pre-tax annual compensation, as defined in the Plan document and subject to contribution limitations specified by law. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified benefit plans.

Through December 31, 2023, the Company was required to make safe harbor matching contributions equal to the sum of 100% of the amount of a participant's elective deferrals that do not exceed 4% of the participant's pre-tax compensation. On January 1, 2024, the Plan was amended and through November 24, 2024, the Company was required to make safe harbor matching contributions equal to the sum of 50% of the amount of a participant's elective deferrals that do not exceed 6% of the participant's pre-tax compensation. In addition to these matching contributions, effective January 1, 2024, the Company is required to make safe harbor nonelective contributions equal to 3% of an employee's pre-tax compensation.

## **1. Description of Plan (continued)**

### **Contributions**

The Company may also make discretionary contributions. In 2023, the Company made contributions of 50% of each participant's voluntary contributions in excess of 4% of compensation up to 6% of compensation. In 2024, the Company made discretionary contributions of 50% of each participant's voluntary contributions up to 6% of compensation.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions, allocations of employer contributions, plan earnings or losses, and charged with an allocation of any administrative expenses paid by the Plan. Participants direct their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds, exchange-traded funds, common stocks, and an interest-bearing cash account as investment options for participants. Earnings or losses are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are 100% vested in their account balances at all times.

### **Participant Notes Receivable**

Participants may borrow from their accounts a minimum of \$500 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable are collateralized by the balance in the participant's account and bear interest at the prime rate (determined at the time of issuance of each note). Notes outstanding at December 31, 2024 bear interest at rates ranging from 3.25% to 8.50%. Notes are required to be repaid within five years, except for notes made for the purchase of a primary residence which must be repaid within a period of no more than ten years. A participant may have no more than one note due to the Plan at any time. Principal and interest are paid ratably through payroll deductions.

## **1. Description of Plan (continued)**

### **Payment of Benefits**

Upon termination of service due to death, disability, retirement, or termination, a participant may, subject to certain conditions, elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a specified period. If a participant's vested account balance does not exceed \$5,000, the Plan may automatically distribute the participant's vested account balance in a lump sum. Also subject to certain conditions, a participant may receive hardship withdrawals from his or her balance in the Plan while employed. Participants who have attained 59½ years of age are permitted to withdraw all or part of their vested accounts as in-service distributions.

### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from the accompanying financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA.

## **2. Basis of Presentation and Summary of Significant Accounting Policies**

### **Basis of Accounting**

The accompanying financial statements are prepared in accordance with accounting principles generally accepted in the United States ("US GAAP").

### **Estimates**

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements, and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

## **2. Basis of Presentation and Summary of Significant Accounting Policies**

### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Risk and Uncertainties**

The Plan invests in investment securities that are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for plan benefits.

### **Participant Notes Receivable**

Participant notes receivable are measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and is in default, the loan balance is reduced as a distribution to the participant.

### **Payment of Benefits**

Benefits are recorded when paid.

### **3. Fair Value Measurements**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for plan benefits. The methods used to measure fair value may produce amounts that may not be indicative of net realizable values or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

US GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs to the valuation methodology are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. All of the Plan's investments are valued using Level 1 inputs.

### **4. Trustee Certification**

Information disclosed in the accompanying financial statements as of and for the years ended December 31, 2024 and 2023, related to investments, participant notes receivable, cash, net appreciation in fair value of investments, and interest income and dividends, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Fidelity Management Trust Company, the trustee of the Plan effective November 25, 2024 through December 31, 2024, and Ascensus Trust Company, the trustee of the Plan through from January 1, 2023 through November 24, 2024.

### **5. Party-in-Interest Transactions**

Certain plan investments are managed by the Plan's custodians. All transactions with the custodians qualify as party-in-interest transactions. Fees paid by the Plan to the trustees for trustee, custodial, recordkeeping, and investment advisory services amounted to approximately \$28,000 and \$20,000 annually for the years ended December 31, 2024 and 2023, respectively. Participant notes receivable also qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules as defined by ERISA.

**6. Income Tax Status**

The pre-approved plan documents used by the Plan for the period from January 1, 2023 through November 24, 2024 and the period from November 25, 2024 through December 31, 2024 obtained their latest determination letter dated June 30, 2020 in which the Internal Revenue Service (“IRS”) stated that both non-standardized pre-approved profit sharing plan documents, as then designed, were in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). Although the Plan’s documents have been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt. No provision for income taxes has been included in the Plan’s financial statements.

US GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. No such liabilities were identified at December 31, 2024 and 2023. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**7. Subsequent Events**

Management evaluated events and transactions after December 31, 2024 through October 14, 2025, the date the financial statements were issued, for subsequent events, and determined that there were no subsequent events to report.
