**Opinion**

**Note 1 – Description of the Plan**

The following brief description of the Pinnacle Plastic Products Employee Stock Ownership Plan (the Plan and the ESOP) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

Pinnacle Industrial Enterprises, Inc. (the Company) established the Pinnacle Plastic Products Employee Stock Ownership Plan effective December 31, 2018, to provide employees with the opportunity to accumulate capital ownership in the Company. The Plan, which is a leveraged ESOP, is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (IRC), and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The main purpose of the ESOP is to hold shares of the Company and allocate benefits to participants. The Plan purchased Company common stock using the proceeds of a Company loan and holds the common stock in a trust established under the Plan. The borrowing is to be repaid over a period of approximately thirty years by fully deductible Company contributions to the trust fund. As the Plan makes each payment of principal, an appropriate percentage of stock will be allocated to eligible employees' accounts in accordance with applicable regulations under the IRC.

The borrowing is collateralized by the unallocated shares of common stock. The lender has no rights against shares of common stock once they are allocated under the provisions of the ESOP. Accordingly, the financial statements of the Plan as of and for the years ended December 31, 2024 and 2023, present separately the assets and liabilities and changes therein pertaining to:

1. The accounts of employees with rights in allocated common stock (Allocated); and
2. Common stock not yet allocated to employees (Unallocated).

Eligibility

Employees of the Company are generally eligible to participate in the Plan after one year of service, providing they worked at least 1,000 hours during the eligibility computation period and are 21 years of age. Once they become participants in the Plan, employees who have at least 1,000 hours worked during a Plan year or are employed on the last working day of such Plan year are generally eligible for an allocation of Company contributions for such year.

Use of Management's Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Payments on account of death, disability, or retirement commence no later than the Plan year following the event, unless the participant elects a later date. Payments for other separations from service commence no later than the sixth Plan year following the separation from service, unless the participant elects a later date. Payments are made in substantially equal installments, however, involuntary distributions of participant account balances of \$5,000 or less are made in a lump sum.

Payments can be made in cash or Company stock. Under the provisions of the Plan, the Company is obligated to repurchase participant shares which have been distributed under the terms of the Plan as long as the shares are not publicly traded or if the shares are subject to trading limitations. The Company did not repurchase any shares during 2024 or 2023.

Voting Rights

Each participant and/or beneficiary is entitled to direct the voting of any Company securities allocated to his or her account with respect to any vote required for the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, or sale of substantially all the assets of the Company. With respect to the unallocated Company securities, and in all other instances, the Trustee shall exercise the voting rights.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of shares of the Company's common stock released by the Trustee from the unallocated account and forfeiture of terminated non-vested accounts. Only those participants who are eligible employees of the Company will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation.

Put Option

Under Federal income tax regulations, employer stock held by the Plan and its participants that is not readily tradable on an established market or subject to trading limitations includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, a participant may diversify up to 50% of shares not previously diversified, as discussed in the Plan document.

**Note 2 – Summary of Significant Accounting Policies**

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Note 2 – Summary of Significant Accounting Policies (continued)**

Investment Valuation and Income Recognition

The shares of Company common stock are valued at fair value. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Allocations

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock ("allocated") and (b) stock not yet allocated to employees ("unallocated"), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

Plan Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from the financial statements.

Forfeitures

Forfeitures of terminated non-vested account balances allocated to remaining participants at December 31, 2024 and 2023, totaled \$33,486 and \$24,582, respectively.

Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

**Note 3 – Tax Status**

The Internal Revenue Service ruled on June 30, 2020, that the Non-Standardized Pre-Approved Profit Sharing/CODA/ESOP Plan (the underlying document upon which the Plan is based as of January 1, 2024) qualifies under the appropriate sections of the IRC and the related trust is, therefore, not subject to tax under present income tax law. The Plan has since been amended. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan and the related trust are tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions.

**Note 4 – Administration of Plan Assets**

The Plan's assets, which consist principally of the Company's common stock as of December 31, 2024 and 2023, are held by the Trustee of the Plan, Prudent Fiduciary Services, LLC. Company contributions are held and managed by the Trustee, which invests cash received and makes distributions to participants. The Trustee administers the payment of interest and principal on the loan, which is funded through contributions to the Plan made by the Company.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses for the Trustee's fees are paid directly by the Company. The Company acts as Plan Administrator utilizing Blue Ridge ESOP Associates for professional administrative services.

**Note 5 – Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at measurement date;

Level 2: Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability; and

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The fair value of the Company's common stock is based on an annual independent appraisal using level 3 inputs, and therefore, the Company's common stock is categorized as a level 3 investment. The December 31, 2024 and 2023, appraisals were based on a combination of the market and income valuation approaches. The appraiser considered historical and projected cash flow and net earnings, weighted average cost of capital, market comparables, and applicable discounts and premiums. The Plan Administrator, under the supervision of the Trustee, determines fair value measurement policies and procedures. These policies and procedures are reassessed at least annually to determine if the current valuation techniques are still appropriate. At that time, the unobservable inputs used in the fair value measurements are evaluated and adjusted, as necessary, based on current market conditions and other third-party information.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no purchases, issuances, or transfers into or out of level 3 within the fair value hierarchy for the years ended December 31, 2024 and 2023.

**Note 7 – Loan Payable**

On June 14, 2019, the ESOP purchased 600,000 shares of the Company's common stock from the Company's former stockholders for \$14,352,811. The purchase of these shares was funded by cash loaned by the Company to the ESOP in the amount of \$14,002,811 (ESOP Loan). All unallocated shares of the Company are collateral for the loan. The agreements provide for the loan to be repaid over 30 years in annual installments of \$683,081 each December 31, including interest at an annual rate of 2.76%. On September 1, 2024, there was a reduction in the ESOP Loan principal of \$750,000 due to circumstances further described in Note 9. As a result of this reduction, the ESOP Loan is currently projected to be repaid in full by the end of 2046.

**Note 8 – Employer Contributions**

The Company is obligated to make contributions in cash to the Plan which, when aggregated with the Plan's dividends and interest earnings, equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loan.

**Note 9 – Other Income**

During 2024, two significant transactions impacted the Plan in accordance with specific instructions from the Department of Labor (DOL) as part of their investigation. This included a \$750,000 reduction in the principal of the ESOP Loan effective September 1, 2024. In addition, the Trustee made a cash contribution of \$50,000 into the Plan during 2024. Both of these transactions were allocated to Plan participants as dividends. The \$50,000 cash contribution was allocated directly as cash, meanwhile the \$750,000 reduction in the ESOP Loan released an additional 22,294 shares which were then allocated. Both of these nonrecurring transactions are included in the Statement of Changes in Net Assets (Deficit) Available for Benefits as Other income.

**Note 10 – Related-Party Transactions and Party-In-Interest Transactions**

As more fully described in Note 1, the Plan invests in the Company's common stock and purchased such shares from the former shareholders. As more fully discussed in Note 7, as part of the purchase agreement, the Plan obtained a loan from the Company. Interest expense on this loan totaled \$330,400 and \$346,534 for the years ended December 31, 2024 and 2023, respectively.

The Company paid substantially all Plan expenses. The Company and service providers are parties-in-interest under ERISA.

**Note 11 – Risks and Uncertainties**

The Plan's investments are entirely in Company stock. The stock is exposed to a variety of uncertainties, including interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is possible that changes in the values of these assets could occur in the near term. Such changes could materially affect the amounts reported in the financial statements of the Plan.

During 2020, the Company was notified by the DOL that they were investigating the initial ESOP transactions. Note 9 describes the activity which the DOL required as part of their settlement. These are the only known impacts of the DOL investigation impacting the Plan's financial statements at this time, however, the DOL has not yet fully closed out their investigation. Besides the activity outlined in Note 9, the accompanying financial statements do not include any additional adjustments that might result from this continued uncertainty.
