Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the 403(b) Plan for Good Samaritan Boys Ranch, Inc., an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024

1. Description of plan

The following description of the 403(b) Plan for Good Samaritan Boys Ranch, Inc. provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

a. General

The Good Samaritan Boys Ranch, Inc. (the Ranch) was formed in 1960 as a Missouri Not-for-Profit Corporation under section 501(c)(3) of the Internal Revenue Code to establish a home for delinquent, neglected, or homeless boys and to provide guidance and education for them. The Ranch is funded primarily from contracts with the State of Missouri Department of Family Services. All permissible employees of the Ranch, as defined in the universal availability standards, are eligible to enroll and begin deferrals on their day of hire. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and the requirements of Section 403(b) of the Internal Revenue Code.

b. Contributions

Each year, participants may elect to contribute up to 100% of their annual compensation up to limits set forth by the Internal Revenue Service in the form of tax deferred salary reductions to the Plan. In addition, individuals who are at least age 50 by the end of the tax year are permitted to make "catch-up" contributions in accordance with the applicable Internal Revenue Service regulation. The catch-up contribution won't be matched by the Company. The employee contributions and earnings thereon are non-forfeitable.

The Company will make a non-forfeitable matching contribution equal to 100% of each participant's elective deferral contributions for the Plan year up to a maximum of three percent of each participant's total compensation for the Plan year. Employees who are twenty-one years of age or older and who have worked 1,000 hours in a specified 12-month period are eligible for the employer matching contribution.

The Plan also has an additional discretionary contribution of 2% of a participant's eligible compensation for any employee who meets the Plan's eligibility requirements.

1. Description of plan (continued)

d. Participants' accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Ranch's contribution and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

e. Vesting

Participants are immediately vested in their contributions, the Ranch match, and discretionary contributions plus actual earnings thereon.

f. Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Participants may borrow from their account a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%.

g. Payment of benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual, quarterly, or monthly installments if his vested account balance is at least \$5,000. If the vested account balance is less than \$5,000, the distribution will automatically be in the form of a lump-sum payment.

h. Parties-In-Interest

Ascensus, Inc. is the trustee/custodian of the Plan investments and executing transactions therein. Central Trust Company is the investment advisor. The Plan is administered by the plan sponsor (Good Samaritan Boys Ranch) in conjunction with Ascensus, Inc. serving as the third party administrator. RMMC is the Plan auditor. Each of these entities are classified party-in-interest with respect to the Plan.

i. In-Service Withdrawals

Certain participants may make withdrawals prior to termination of employment. Hardship withdrawals are available to Plan participants, as defined by the Plan and permitted by the IRC. Hardship withdrawals are limited to the participant's elective deferrals.

Participants who have obtained the age of 59½ are allowed to receive a distribution of all or any portion of their vested account balances in a single sum payment.

1. Description of plan (continued)

j. Participant Investment Rollovers

Participants are allowed to transfer or rollover funds into the Plan from other qualified plans.

k. Forfeitures

Forfeitures can be used to offset Ranch matching contributions or to pay Plan administrative expenses, as determined by the Plan Administrator. At December 31, 2024, there were \$1,002 of forfeited amounts and the Plan used \$424 of forfeitures to offset Ranch matching contributions and expenses.

2. Summary of significant accounting policies

The following are the significant accounting policies followed by the Plan:

Basis of accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

Payment of benefits

Benefits are recorded when paid.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and

2. Summary of significant accounting policies (continued)

are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

3. Plan termination

Although it has not expressed any intent to do so, the Ranch has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

4. Administrative costs

During the year ended December 31, 2024, administrative expenses of \$41,368 were paid by the Plan. All other administrative costs are paid by the Plan sponsor.

5. Tax status

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (Code). The Plan operated under a standardized adoption agreement in connection with a volume submitter retirement plan and trust document sponsored by Ascensus, LLC. This volume submitter plan document has been filed with the appropriate agency and has obtained its latest determination letter dated January 1, 2018. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and not subject to tax.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Information prepared and certified by Qualified Institution

The December 31, 2024 and 2023 Statements of Net Assets Available for Benefits, the investment activities included on the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the accompanying notes to the financial statements were prepared in part from information certified by the Trustee in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes investments in mutual funds and notes receivable from participants of \$4,150,841 and \$3,461,245 at December 31, 2024 and 2023, respectively, and related income of \$481,528, for the year then ended December 31, 2024.

7. Fair value measurements

ASC 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 Inputs to the valuation methodology include
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

8. Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. Separated participants

At December 31, 2024, \$379,771 of the net assets available for benefits are for those participants who have separated from active service with the Plan sponsor.

10. Subsequent event

The Plan has evaluated subsequent events through October 2, 2025, the date which the financial statements were available to be issued. There were no significant events noted that did not exist at the date of the statements of net assets available for benefits but arose subsequent to that date.
