INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
WLCFS Retirement Readiness Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of WLCFS Retirement Readiness Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's elections of ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the plan's ability to continue as a going concern for one year after the date that the financial statements were available to be issued.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting - WLCFS Retirement Readiness Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

Accounting estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Subsequent events - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through October 8, 2025, which is the date the financial statements were available to be issued.

Risks and uncertainties - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Key parties of the plan - Wisconsin Lutheran Child & Family Service, Inc. is the plan sponsor, employer and the plan administrator. Mutual of America Life Insurance Company ("MOA") is the investment agent, recordkeeper and third party administrator that maintains plan and participant records and tax counsel that performs various compliance tests. Mid Atlantic Trust Company ("MATC") is the custodian of plan assets and plan trustee. Wilshire Associates Incorporated is the plan's investment advisor.

Investments - The plan sponsor determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. Earnings on investments bought, sold or held during the years are reflected in the accompanying statements of changes in net assets available for benefits. Participants should refer to the investment account summaries and prospectuses for more information.

Fair value measurements - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodology used for investments measured at fair value.

Mutual funds - Valued at the daily quoted market prices as reported by the fund. Mutual funds held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily net asset value and are deemed to be actively traded.

2. DESCRIPTION OF PLAN

The following description of the plan provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

General - The plan was established as a defined contribution plan on January 1, 1989. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

Eligibility - Employees are eligible to contribute to the plan upon reaching age 21 and completing 90 days of service. Employees are eligible for employer contributions upon reaching age 21 and completing one year of service. An employee is allowed to enter the plan on the first day of each month immediately following meeting the eligibility requirements. Ministers of Gospel are not eligible to participate in the plan.

Contributions - Contributions are recorded in the year in which the eligible compensation is paid. Contributions to the plan can be made as follows:

- Participants may contribute a percentage of their compensation subject to certain limitations (employee elective deferral contributions). The plan also permits Roth elective deferral contributions.
- Employee rollover contributions are accepted by the plan from other qualified plans.
- Employer safe harbor matching contributions are made equal to 100% of the first 3% plus 50% of the next 2% of the employee compensation contributed to the plan as employee elective deferral contributions. Such contributions are remitted to the plan coinciding with each payroll.
- Employer nonelective contributions may be made at the employer's discretion. There were no such contributions in 2024 or 2023.

Participant accounts - Earnings, including the fair value appreciation (depreciation), are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's elective deferral and rollover contributions and an allocation of employer contributions. Participants are allowed to change their investment options on a daily basis and deferral percentages each pay period.

Vesting - Participants are always 100% vested in their account balances.

Payment of benefits - Benefits are recorded when paid. Lump sum, partial withdrawals or installment benefit payments may commence upon termination of employment, death, disability or attainment of normal retirement age (defined as age 65) while employed. Hardship withdrawals are permitted under certain circumstances.

Administrative fees - Certain administrative fees of the plan are paid by the employer and not included in these financial statements. Certain other administrative fees are paid by the plan from plan assets and recorded as administrative expenses in these financial statements. Such expenses include nonparticipant directed fees for service, administrative and advisory fees. Nonparticipant directed fees are allocated on an account value basis.

Notes receivable from participants - Loans to participants are not permitted under the plan.

3. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the employer has the right to terminate the plan at any time subject to the provisions of ERISA.

4. INCOME TAX STATUS

The plan is operating under a Mutual of America Life Insurance Company non-standardized pre-approved profit sharing/money purchase plan that received a favorable opinion letter on November 30, 2020. The letter provided by the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan. However, the plan administrator and tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.

5. PARTY-IN-INTEREST TRANSACTIONS

MOA is the investment agent for the plan and, therefore, investment transactions between MOA and the plan qualify as party-in-interest transactions. Administration and service fees paid to MOA by the plan totaled \$23,000 in 2024 and \$20,000 in 2023.

In addition, MATC receives revenue, in the form of indirect compensation, from mutual fund service providers for services MATC provides to the funds. This revenue is used to offset certain amounts that would otherwise be owed by the plan to MATC for administrative and investment services provided to the plan. Direct fees paid to MATC were insignificant in 2024 and 2023.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
WLCFS Retirement Readiness Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of WLCFS Retirement Readiness Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Key parties of the plan - Wisconsin Lutheran Child & Family Service, Inc. is the plan sponsor, employer and the plan administrator. Mutual of America Life Insurance Company ("MOA") is the investment agent, recordkeeper and third party administrator that maintains plan and participant records and tax counsel that performs various compliance tests. Mid Atlantic Trust Company ("MATC") is the custodian of plan assets and plan trustee. Wilshire Associates Incorporated is the plan's investment advisor.

Investments - The plan sponsor determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. Earnings on investments bought, sold or held during the years are reflected in the accompanying statements of changes in net assets available for benefits. Participants should refer to the investment account summaries and prospectuses for more information.

Fair value measurements - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodology used for investments measured at fair value.

Mutual funds - Valued at the daily quoted market prices as reported by the fund. Mutual funds held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily net asset value and are deemed to be actively traded.

2. DESCRIPTION OF PLAN

The following description of the plan provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

General - The plan was established as a defined contribution plan on January 1, 1989. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

Eligibility - Employees are eligible to contribute to the plan upon reaching age 21 and completing 90 days of service. Employees are eligible for employer contributions upon reaching age 21 and completing one year of service. An employee is allowed to enter the plan on the first day of each month immediately following meeting the eligibility requirements. Ministers of Gospel are not eligible to participate in the plan.

Contributions - Contributions are recorded in the year in which the eligible compensation is paid. Contributions to the plan can be made as follows:

- Participants may contribute a percentage of their compensation subject to certain limitations (employee elective deferral contributions). The plan also permits Roth elective deferral contributions.
- Employee rollover contributions are accepted by the plan from other qualified plans.
- Employer safe harbor matching contributions are made equal to 100% of the first 3% plus 50% of the next 2% of the employee compensation contributed to the plan as employee elective deferral contributions. Such contributions are remitted to the plan coinciding with each payroll.
- Employer nonelective contributions may be made at the employer's discretion. There were no such contributions in 2024 or 2023.

Participant accounts - Earnings, including the fair value appreciation (depreciation), are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's elective deferral and rollover contributions and an allocation of employer contributions. Participants are allowed to change their investment options on a daily basis and deferral percentages each pay period.

Vesting - Participants are always 100% vested in their account balances.

Payment of benefits - Benefits are recorded when paid. Lump sum, partial withdrawals or installment benefit payments may commence upon termination of employment, death, disability or attainment of normal retirement age (defined as age 65) while employed. Hardship withdrawals are permitted under certain circumstances.

Administrative fees - Certain administrative fees of the plan are paid by the employer and not included in these financial statements. Certain other administrative fees are paid by the plan from plan assets and recorded as administrative expenses in these financial statements. Such expenses include nonparticipant directed fees for service, administrative and advisory fees. Nonparticipant directed fees are allocated on an account value basis.

Notes receivable from participants - Loans to participants are not permitted under the plan.

3. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the employer has the right to terminate the plan at any time subject to the provisions of ERISA.

4. INCOME TAX STATUS

The plan is operating under a Mutual of America Life Insurance Company non-standardized pre-approved profit sharing/money purchase plan that received a favorable opinion letter on November 30, 2020. The letter provided by the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan. However, the plan administrator and tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.

5. PARTY-IN-INTEREST TRANSACTIONS

MOA is the investment agent for the plan and, therefore, investment transactions between MOA and the plan qualify as party-in-interest transactions. Administration and service fees paid to MOA by the plan totaled \$23,000 in 2024 and \$20,000 in 2023.

In addition, MATC receives revenue, in the form of indirect compensation, from mutual fund service providers for services MATC provides to the funds. This revenue is used to offset certain amounts that would otherwise be owed by the plan to MATC for administrative and investment services provided to the plan. Direct fees paid to MATC were insignificant in 2024 and 2023.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
