Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Solventum Retiree Welfare Benefit Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits and benefit obligations as of December 31, 2024, and the related statement of changes in net assets available for benefits and benefit obligations for the nine-month period ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Solventum Retiree Welfare Benefit Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. - the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Solventum Retiree Welfare Benefit Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. Note 1 - Plan Description

The following description of the Solventum Retiree Welfare Benefit Plan (the "Plan") provides only general information. Participants should refer to the Summary Plan Descriptions ("SPD") and plan document (collectively, "Plan Agreements") for a more complete description of the Plan's provisions.

General

The Plan was formed as a result of the separation of Solventum Corporation (the "Company" or "Solventum") from 3M Company and its subsidiaries ("3M") on April 1, 2024 (the "Spin-off"). Upon Spin-off, assets of approximately \$141,000, including a Voluntary Employees' Beneficiary Association ("VEBA") account for union participants ("Union VEBA") and a 401(h) account, transferred into the Plan from the 3M Retiree Welfare Benefit Plan (the "Predecessor Plan" or "3M RWBP"), along with postretirement benefit obligations of approximately \$259,000. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Eligibility and Benefits

As a successor plan to the 3M RWBP, the Plan covers United States regular full time and part time employees who were hired by 3M prior to the dates described below, who transferred to Solventum as active employees or retirees.

For employees hired before January 1, 2016, the Plan provides Retiree Medical Savings Account ("RMSA") credits, which accrue for each year of employment starting at age 40. Upon retirement, the RMSA credits are transferred to a Medicare or Non-Medicare Health Reimbursement Account ("HRA"), based on eligibility. Participants' HRA balances can be used to help pay for qualified medical and dental premiums and expenses.

For employees hired before January 1, 2009, who retired before August 1, 2019 the Plan provides post-retirement life insurance benefits up to \$8 per participant.

Contributions

Solventum contributes amounts required to provide the Plan with assets sufficient to fund the retiree medical, dental and life insurance benefit obligations. The yield on investments serves to reduce Solventum's future contributions that would otherwise be required to fund the Plan's benefits. During the year ended December 31, 2024, the Company paid \$507 for retiree life insurance premiums and \$360 for health benefits. The Company also paid \$1,040 to establish a prefunding deposit on behalf of the Plan to administer future retiree health benefits. No participant or retiree contributions are made to the Plan.

401(h) Account

The Solventum Employee Retirement Income Plan ("ERIP") includes a medical benefit component, in addition to normal retirement benefits, to fund a portion of the Plan's postretirement obligations for retirees and their beneficiaries in accordance with Section 401(h) of the Internal Revenue Code ("IRC"). A separate account has been established and maintained in the ERIP for such net assets. In accordance with IRC Section 401(h), the Plan's investments in the 401(h) account may not be used for, or diverted to, any purpose other than providing health benefits for retirees and their beneficiaries. The obligations for health benefits are not a component of the ERIP's accumulated plan benefits but are reported as obligations in the financial statements of the Plan. Any obligation of the ERIP is limited to the amount in the 401(h) account. Qualified transfers to the 401(h) account are determined annually and are at the discretion of Solventum.

Tax Status

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions of the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability and disclosure in the financial statements.

The plan administrator believes that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan has not yet received a determination letter.

Trustee

The Bank of New York Mellon/BNY Mellon N.A. (the "Trustee") is the Plan's trustee.

Plan Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to modify the benefits provided to participants and to terminate the Plan, subject to the provisions set forth in ERISA. If the Company terminates or partially terminates the Plan, the net assets of the Plan will be used to pay benefit obligations of the Plan.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Prefunding Deposit

The Plan maintains a prefunding deposit to administer benefit payments. As of December 31, 2024, the balance was \$1,040. The deposit is restricted for use in accordance with the contract with the third party benefits administrator.

Benefit Payments

Benefits are recorded when paid.

Benefit Obligation

The postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to employees' service rendered to the date of the financial statements. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with participating employers. The postretirement benefit obligation represents the amount that is to be funded by contributions from the Company and from existing plan assets. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to estimate future annual benefit costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The following were significant assumptions used in the valuation as of December 31, 2024:

Discount rate - Retiree life	5.60% as of December 31, 2024 and 5.20% as of the date of transfer from the 3M RWBP
Discount rate - Retiree medical/dental	5.65% as of December 31, 2024 and 5.23% as of the date of transfer from the 3M RWBP
Mortality basis	Pri-2012 white collar base mortality table projected generationally from 2012 with Scale MP-2021

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

Funded Status

The Plan's deficiency of benefit obligations over net assets as of December 31, 2024 relates to the postretirement benefit obligation. It is expected that the deficiency will be funded by the Company as the benefits become due and by investment income.

Administrative Expenses

The Company pays certain internal administrative costs of the Plan. External administrative costs, including trustee and disbursement fees, recordkeeping and customer service fees, and investment management expenses, are paid by the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The plan benefit obligations are reported based on certain assumptions pertaining to interest rates, inflation rates, and participant demographics. Due to the changing nature of these assumptions, it is at least reasonably possible that changes in these assumptions will occur in the near term and, due to the uncertainties inherent in setting assumptions, that the effect of such changes could be material to the financial statements. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. It is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 14, 2025, which is the date the financial statements were available to be issued.

Note 3 - 401(h) Account

A portion of the Plan's obligations is funded through contributions to the ERIP in accordance with IRC Section 401(h). Note 4 - Certification of Investments

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances whereby inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

Short-term Investment Fund

The short-term investment fund is valued at quoted prices reported in active markets.

Common/Collective Trust

The common/collective trust is valued at Net Asset Value ("NAV") as a practical expedient for fair value. The investment has a daily redemption notice period. There are no unfunded commitments related to this investment.

Note 6 - Related Parties

The Company provides certain administrative services to the Plan and does not charge the Plan for these services.

The Trustee and the investment managers are authorized under contract provisions and by ERISA regulations which provide administrative and statutory exemptions, to invest in funds under their control and in securities of Solventum. The Plan does not currently invest in any securities of Solventum.

The transfer into the 401(h) account of the Plan from 3M in the amount of \$141,086 as part of the spin-off described in Note 1 includes approximately \$1,914 of investment income earned between the initial transfer date and final transfer date.
