### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the financial statements of AP Therapy LLC 401k Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions, Empower Annuity Insurance Company of America and Empower Trust Company, LLC, as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

## NOTES TO FINANCIAL STATEMENTS

### AP Therapy LLC 401k Profit Sharing Plan

#### 1 Description of Plan

The following description of AP Therapy LLC 401k Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

##### *General:*

The Plan, which began January 1, 2023 is a defined contribution plan covering all employees of AP Therapy LLC (the “Company”) who meet the eligibility and service requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective January 1, 2023, the Plan was created following the spinoff from CHS Therapy, AP Rehab LLC. The assets of CHS Therapy, AP Rehab LLC were transferred into the Plan in March 2023.

##### *Eligibility:*

All employees at least 21 years old, other than non-resident alien employees of the Company, who complete 1,000 hours of service and are employed for 6 months are eligible to participate in the Plan. All prior years of service completed with CHS Therapy, AP Rehab LLC will be treated as service with the Company for purposes of determining eligibility with the Plan. Effective January 1, 2024, the Plan was amended to remove the age and service requirements for elective deferrals.

##### *Contributions:*

Employee Contributions - Participants may elect a portion of their compensation from 1% to 100% to be contributed to the Plan by the Company. The Plan also allows for employee Roth contributions. Participants age 50 and older may elect a catch-up contribution under Internal Revenue Service guidelines. There is also an automatic enrollment feature where 3% of compensation is contributed to the Plan. The employee deferral can be increased in 1% increments on an annual basis up to 8%, unless a participant opts out.

Employer Contributions – The Company may make contributions to each eligible participant's account by matching elective deferrals for the plan year in the amount of 50% up to the first 3% of employee deferrals.

The Company may also make additional discretionary contributions. Such additional contributions, if any, shall be allocated to each participant in proportion to his or her account for the calendar year. There were no such contributions in 2024 and 2023.

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Rollover contributions from other Plans are also accepted, providing certain specified conditions are met.

Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code as defined in the Plan agreement.

**1 Description of Plan, Continued**

***Participants' Accounts:***

Each participant's account is credited with the participant's elective contributions, employer matching contributions, employer discretionary contributions, earnings and losses thereon.

***Vesting:***

All participants are 100% vested in elective deferrals, qualified non-elective contributions and rollover contributions made to the Plan. The Plan also recognizes all previous vesting service met from CHS Therapy, AP Rehab LLC.

Vesting in employer contributions and discretionary contributions is based on years of service. A participant is vested as follows:

<u>Years of Service</u>	<u>Vested %</u>
Less than 1 year	25%
1 year but less than 2 years	50%
2 years but less than 3 years	75%
3+ years	100%

Effective March 1, 2024, the Plan was amended and restated to update the vesting in the employer contributions and discretionary contributions as follows:

Less than 1 year	0%
1 year but less than 2 years	25%
2 years but less than 3 years	50%
3 years but less than 4 years	75%
4+ years	100%

***Forfeitures:***

Forfeitures due to termination from the Plan before a participant is 100% vested shall be allocated in any manner at the discretion of the Plan Administrator. Forfeitures utilized, totaled \$-0- (2024) and \$12,930 (2023). The balance in the forfeiture account for the years ended December 31, 2024 and 2023 was \$29,083 and \$10,843, respectively.

***Notes Receivable from Participants:***

Loans are permitted under certain circumstances and are subject to limitations. Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loans are repaid over a period not to exceed 5 years with exceptions for the purchase of a primary residence.

## NOTES TO FINANCIAL STATEMENTS

#### **1 Description of Plan, Continued**

##### ***Notes Receivable from Participants, Continued:***

Loans are valued at unpaid principal plus accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

The loans are secured by the balance in the participant's account and bear interest at rates established by the Trustee. Principal and interest are paid ratably through payroll deductions.

##### ***Other Plan Provisions:***

Normal retirement age is 65.

##### ***Payment of Benefits:***

Upon termination of service by reason of separation of service, retirement, death or total and permanent disability, a participant receives a lump sum amount equal to the value of his or her account. Benefits are recorded when paid.

##### ***Hardship Withdrawals:***

Hardship withdrawals are permitted in accordance with Internal Revenue Service guidelines.

##### ***Investment Options:***

Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan.

#### **2 Summary of Significant Accounting Policies**

##### ***Valuation of Investments:***

Investments (except for fully benefit responsive contracts, which are recorded at contract value) are stated at fair value. Marketable securities are reported at fair market value as of the balance sheet date. Fair market values represent quoted market prices or, if quoted market prices are not available, estimated fair values as determined by the Plan's investment broker. The fair values of the collective trust funds are based on the underlying net asset values of the funds. The fair value of the fixed account is calculated by discounting the related cash flows based on current yields of similar instruments with comparable durations.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as held during the year.

#### **2 Summary of Significant Accounting Policies, Continued**

##### ***Use of Estimates:***

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

##### ***Administrative Fees:***

Substantially all administrative fees are paid by the Plan or the Company.

##### ***Plan Termination:***

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

##### ***Risks and Uncertainties:***

The Plan's investments include investments in mutual funds, collective trust funds and a fixed account with varying degrees of risk, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statement of Net Assets Available for Plan Benefits.

##### ***Basis of Accounting:***

The Plan's transactions are reported on the accrual basis of accounting.

##### ***Subsequent Events:***

Management evaluates subsequent events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements.

Effective May 1, 2025, the Plan updated eligibility service requirements for elective deferrals, as well as updated the definition of Plan Compensation.

Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued.

#### 3 Tax Status

On June 30, 2020, the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended; however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or that would require disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress.

#### 4 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

- \* Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.
- \* Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:
  - \* Quoted prices for similar assets or liabilities in active markets
  - \* Quoted prices for identical or similar assets or liabilities in inactive markets
  - \* Inputs other than quoted prices that are observable for the asset or liability
  - \* Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- \* Level 3: Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### ***Mutual Funds:***

The fair value of the mutual funds are based on quoted market prices.

**4 Fair Value Measurements, Continued**

*Collective Trust Funds:*

The fair values of the collective trust funds are based on net asset value as calculated by dividing the total fair value of the assets of the funds, less its liabilities, by the total number of units outstanding. The collective trust funds consist of separate funds with differing investment objectives. The funds hold investments in units of the underlying funds. The funds sell new units and repurchase outstanding units on a daily basis and there are no unfunded commitments. The funds have the ability to redeem their investments in the portfolio funds at net asset value without restrictions. The funds require the Plan sponsor to provide a five-day written notice for any withdrawals which may exceed \$1 million.

The following tables sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

#### **8 Benefit-Responsive Contract**

The Plan holds a benefit-responsive fixed deferred annuity contract with Great-West Life & Annuity Insurance Company (“Great-West”). The contract meets the fully benefit responsive insurance contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit responsive contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Great-West maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The fixed deferred annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) the Plan's failure to qualify under Section 401(a) or Section 401(k) of the Internal Revenue Code, (2) the establishment of a defined contribution plan that competes with the Plan for employee contributions, (3) any substantive modification of the Plan or the administration of the Plan that is not consented to by the wrap issuer, (4) complete or partial termination of the Plan, (5) any change in law, regulation, or administrative ruling applicable to the Plan that could have a material adverse effect on a portfolio's cash flow, (6) merger or consolidation of the Plan with another plan, the transfer of assets to another plan, or the sale, spin-off or merger of a subsidiary or division of the Plan sponsor, (7) any communication given to participants by the Plan sponsor or any other Plan fiduciary that is designed to induce or influence participants not to invest in a portfolio or to transfer assets out of a portfolio, (8) exclusion of a group of previously eligible employees from eligibility in the Plan, (9) any early retirement program, group termination, group layoff, facility closing, or similar program, and (10) any transfer of assets from a portfolio directly to a competing option. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants is probable.

The issuer may terminate the contract for cause at any time.
