Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of TGF Management Group 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of TGF Management Group 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about TGF Management Group 401(k) Plan 's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedules Required by ERISA

The supplemental schedule of Schedule H, Line 4i- Schedule of Assets (Held at End of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion—

- the form and content of the supplemental schedule, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Notes to Financial Statements

(1) Description of the Plan

The following description of the TGF Management Group (the "Company") 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

The Plan was established and became effective on January 1, 1990. The TGF Management Group 401(k) Plan Administrative Committee (the "Committee"), has general responsibility for the administration of the Plan, including, but not limited to, complying with reporting and disclosure requirements, establishing and maintaining Plan records and adopting amendments to the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The following description provides only general information about the Plan. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a self-directed defined contribution plan covering substantially all employees of TGF Management Group (the "Company"). An employee can participate in the Plan after completing 500 hours of service within the employee's first six months of employment and attain the age of 20 1/2. An employee will become eligible to receive employer contributions after completing 1,000 hours of service within 12 months from the eligible employee's employment commencement date and attained the age of 21. As of May 12, 2023, the Plan made changes to their eligibility requirements. An employee can make active elections upon hire. If the participant does not make an active election, they will be automatically be enrolled after 30 days. An employee can enter the Plan the first day of the month following the date of hire.

Contributions - There are three types of contributions that can be made to the Plan: voluntary salary reductions, employer contributions and rollover contributions. Voluntary salary reductions are limited in accordance with federal tax regulations. The limitation for the 2024 and 2023 Plan years was \$23,000 and \$22,500, respectively. Participants of at least 50 years of age may contribute an additional \$7,500 of pre-tax compensation per plan year for 2024. The Plan permits eligible employees to make voluntary salary reductions of not less than one percent and not more than 80 percent of their compensation for the year. The Company's contribution is discretionary. The Company chose to make contributions to the Plan not to exceed 2% of compensation per participating employee. The Company has made elective contributions of \$258,464 for the year ended December 31, 2024. Eligible employees may rollover contributions from a qualified retirement plan of a former employer to the Plan. These contributions are 100% vested and will automatically be invested in accordance with the participant investment election. For the year ended December 31, 2024, eligible employees transferred \$624,040 in rollover contributions from qualified retirement plans of former employers.

Investment Elections - The participant contributions and the Company matching contributions are allocated to the various investment options offered by the Plan as the participant directs.

Payment of Benefits - Upon termination of service due to death, disability or separation from service, a participant may elect to receive a lump sum amount equal to the vested value of his or her account or receive the benefit in installment payments. If the value exceeds \$5,000, no distribution will be made without employee spousal consent prior to reaching normal retirement (age 59-1/2). Payments should begin no later than April 1st following the calendar year in which age 70-1/2 is reached, unless the participant is still employed by the Company.

Participants' Account - Each participant's account is credited with the participant's and employer contributions, earnings on investments and any increase or decrease in the market value of investments. Allocations of investment earnings and market value changes will be based on individual participant account balances to the total of all participant account balances on the valuation date, as defined.

Notes to Financial Statements

(1) Description of the Plan (Continued)

Vesting - Funds held in the elective deferral account, rollover contribution account, and qualified non-elective contribution account are always fully (100%) vested and are non-forfeitable. The funds in the employer contribution account are fully vested after four years. Forfeitures of matching contributions will be used to reduce the employer's matching contribution. All participants are 100% vested upon retirement, death, or becoming disabled, or if the Plan is terminated.

Forfeitures - Upon termination of employment, participants forfeit their unvested balances. Forfeited balances of terminated employees' nonvested accounts can be used to reduce future Company matching contributions or to pay administrative expenses of the Plan, as determined by the Company at its sole discretion. The Plan had no unallocated forfeitures as of December 31, 2024 and 2023. During the year ended December 31, 2024, forfeitures used to reduce employer contributions were \$16,106.

Notes Receivable from Participants - Participants may borrow from their individual account a minimum of \$1,000 and a maximum amount equal to 50% of a participant's vested account balance, but not more than \$50,000, reduced by the participant's highest note balance, if any, during the preceding 12 months. The loans are secured by the balance in the participants account. The interest rate on the note is based on the prevailing rate determined by the plan administrator. The maximum note term is 5 years, except for notes used to purchase a principal residence. Principal and interest is paid ratably through monthly payroll deductions.

(2) Summary of Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared using the accrual method of accounting.

Adoption of New Accounting Standard - Effective January 1, 2023, the Plan adopted ASC 326 which changed how entities will measure credit losses for certain financial assets that aren't measured at fair value through changes in net assets available to benefits. The most significant change in this standard is a shift from the incurred loss model to the expected loss model. Under the standard, disclosures are required to provide users of the financial statements with useful information in analyzing the Plan's exposure to credit risk and the measurement of credit losses. The primary financial asset held by the Plan that are subject to the guidance in ASC 326 is employers' contributions receivable. The impact of the adoption was not considered material to the financial statements and primarily resulted solely in enhanced disclosures.

On July 30, 2025, the FASB issued Accounting Standards Update (ASU) 2025-05, Financial Instruments—Credit Losses (Topic 326): Measurement of Credit Losses for Accounts Receivable and Contract Assets. This standard allows entities to elect a practical expedient that assumes that current conditions as of the fiscal year-end do not change for the remaining life of the asset. In addition, the standard provides for consideration of subsequent collections in developing reasonable and supportable forecasts as part of estimating expected credit losses. The Plan elected to early adopt this standard in the reporting period ended December 31, 2024.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(2) Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information principally provided by the Plans custodian, as described in Note 4.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid directly by the Plan and are included in these financial statements as administrative expenses. Certain investment transaction related expenses are included in net (depreciation) appreciation of fair value of investments.

Subsequent Events - The Plan has evaluated subsequent events through October 13, 2025, the date these financial statements were available to be issued.

(3) Information Certified and Provided by Fidelity Management Trust Company (Unaudited)

The following is a summary of the Plan investment information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedule, that was prepared by, or derived from, information provided by Fidelity Management Trust Company (the "Custodian") and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Custodian that this information provided to the Plan Administrator by the Custodian is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information in Note 4 and supplemental schedule which appears throughout the financial statements and supplemental schedule related to the following assets:

(4) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust: Valued at their Net Asset Value (NAV) of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the collective trust less its liabilities. This practical expedient is not used when it is determined to be probable that the collective trust will sell the investment for an amount different from the report NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that security liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(a) The Fidelity Managed Income Portfolio's investment strategy is to seek the preservation of capital and to provide a competitive level of income over time that is consistent with the preservation of capital through investments typically in fixed income securities or bond funds, wrapper contracts issued by third parties, and cash equivalents represented by share in money markets.

(5) Transactions with Parties-in-Interest and Related Parties

Certain Plan investments are shares of mutual funds managed by the custodian. The custodian is the trustee as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Fees incurred by the plan for the investment management services are included in net appreciation in fair value of the investment rather than a direct payment. Certain administrative fees paid by the Plan directly to the custodian were approximately \$84,972 for the year ended December 31, 2024. The company pays directly any other fees related to the Plan's operations.

(6) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

(7) Tax Status

The Plan is based on a "volume submitter" plan document. The sponsor of the volume submitter document has received a favorable determination letter from the Internal Revenue Service (IRS) dated March 31, 2008, stating that the form of the Plan is qualified under Section 401 of the Internal Revenue Code ("IRC"). In accordance with Revenue Procedures, the Company has chosen to rely on the IRS determination letter issued to the sponsor of the volume submitter document as evidence that the form of the Plan is tax-qualified. The Plan is also required to be operated in conformity with the IRC to maintain its tax-qualified status. The Plan administrator believes that the Plan, which has been amended since the date of the determination letter, continues to be tax-qualified in both form and operation.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
