INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees
Wisconsin Health Fund

Opinion

We have audited the accompanying financial statements of Wisconsin Health Fund (the Fund), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

1. DESCRIPTION OF FUND

The following brief description of Wisconsin Health Fund (the Fund) provides only general information about the Fund's provisions. Participants should refer to the plan agreement for a complete description of the Fund's provisions, copies of which may be obtained from the fund sponsor.

General

The Fund is a Taft-Hartley, multiemployer Health & Welfare Trust Fund. The Fund was formed January 1, 1994 upon the merger of the Milwaukee Area Truck Drivers Health and Welfare Fund and the Wisconsin Area Health Fund. The Fund provides health and other benefits to eligible members and covered dependents. Retirees who meet certain age, service, and contribution requirements are eligible to receive benefits for themselves and eligible dependents until age 65.

Certain Fund assets are held in a voluntary employees' beneficiary association (VEBA) trust. The Fund is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits

The Fund provides health benefits (medical, vision, dental, and prescription drugs), life insurance, short and long-term disability benefits, and accidental death and dismemberment benefits. These services are provided in offices and facilities owned, leased, or operated by the Fund or in other offices, hospitals, and authorized medical, optical, or dental facilities. Retirees covered under this Fund are limited to medical and prescription drug benefits. In September 2014 the Trustees approved a fund change in that retiree benefits for new hires will be eliminated effective January 1, 2018. The Fund also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Insured Benefits

The Fund fully insures the life insurance benefits (basic, supplemental, and dependent), accidental death and dismemberment benefits (basic, supplemental, and spousal), and disability benefits. The Fund purchases annual insurance contracts for these insured benefits. Premiums for basic life insurance, basic accidental death and dismemberment, and disability insurance programs are paid to the insurance company from the assets of the VEBA trust.

1. DESCRIPTION OF FUND (Continued)

Self-Insured Benefits

All other Fund benefits are self-insured. The claims for self-insured benefits are processed either by the Fund or by the Fund's third-party claims processors under administrative services only (ASO) arrangements. The third-party claims processors pay claims directly to or on behalf of participants and are then reimbursed by the Fund's VEBA trust. Despite the Fund's utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Fund.

The Fund utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Fund based on the Fund's actual utilization pattern of specific drugs.

Contributions

The Fund is financed by the collection of employer payments based upon rates for each member as determined from time to time in the agreement between the employers and union organizations, or by a participation agreement. In addition, under certain conditions, the Fund allows for self-payment contributions from members. The costs of the postretirement benefit plan are shared by the Fund's participating employers and retirees. Retirees contribute a monthly premium. In addition to deductibles and copayments, retiree contributions for the years ended December 31, 2024 and 2023 ranged from \$415 to \$1,896 depending upon retirement date, type of coverage, and years of credited service. For the years ended December 31, 2024 and 2023, the retiree contributions are an estimated 31% and 37%, respectively, of the projected cost of providing their postretirement benefits.

Employer and participant contributions are received from employers and participants for the operation of the Fund. Employer contributions are recognized in the period that coincides with the completion of the related work hours. Participant contributions are recognized in the period of benefit coverage.

Other

The Fund is administered by a Board of Trustees consisting of a union group and an employer group of representatives, each having equal voting power.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Fund are prepared, and the books of record are maintained, on the accrual basis of accounting.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Cash

Cash is defined as currency on hand, in demand deposits.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (US GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, estimated health claims incurred but not reported (IBNR), postretirement benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates. Estimates that are particularly susceptible to significant change in the near-term are the liabilities for IBNR and postretirement benefit obligations and an allowance for credit losses. Although it is not possible to measure the degree of variability inherent in these estimates, management believes that the liabilities reported are adequate. Any adjustment determined to be necessary is reflected in current operations.

Revenue Recognition

Sales of pharmaceutical drugs – Revenue associated with sales of pharmaceutical drugs is recognized at the point of time when control transfers to the participant or non-member, generally when the pharmaceutical drugs are delivered to the participant or non-member.

Administrative Charges – Patient co-pays, self-pay service fees, and registration fees are due at registration. Fees for medical and physical therapy supplies are due upon receipt of the prescribed items. Revenue associated with clinic services is recognized at the point of time when the service is performed. The Fund's Billing Manager may approve subsequent billings for co-pays, or six monthly payments for medical or dental balances due on a case-by-case basis, though they are not a significant component of the administrative charges. The contractual terms and conditions associated with installment billings indicate that the patient is liable for the total contract price; therefore, mitigating the Fund's exposure to losses associated with nonpayment.

Other Third-Party Billings – Due to the uncertainty of subrogation collections, subrogation receipts are recorded and recognized when received. Non-member and Medicare receipts are from the patient's insurance plan or Medicare plan. The Fund records the revenue from the dental or medical service provided at the point in time the service is performed. The claims are sent to the non-member's insurance or Medicare plan for payment of the claims.

Other – Other revenue is recorded and recognized when received.

The Fund has determined that the nature, amount, timing, and uncertainty of revenue and cash flows are affected by the general economy.

Concentrations

Credit Risk -The Fund maintains its cash balance in financial institutions, which at times may exceed federally insured limits. As of December 31, 2024 and 2023, the Fund had \$334,284 and \$425,282, respectively, deposited in excess of the Federal Deposit Insurance Corporation insurance limits. The Fund has not experienced any losses in such accounts and believes it is not exposed to any significant credit risks on cash.

Employer Contributions – Employers remit contributions to the Fund based on the number of weeks worked by the participants. Therefore, employer contributions are dependent upon the construction and working environment of the area serviced by the unions. Two employers accounted for approximately 56% and 50% of the Fund’s contributions for the years ended December 31, 2024 and 2023, respectively.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Fund’s Board of Trustees determines the Fund’s valuation policies utilizing information provided by the investment advisers and custodians. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Fund's gains and losses on investments bought and sold as well as held during the year.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Retirees, Medical Billings, and Other Receivables

Retirees, medical billings, and other receivables are net of an estimated allowance for credit losses. Based on past experience and a review of delinquent balances at year end, an allowance for credit losses has been established at approximately \$276,000 and \$383,000 at December 31, 2024 and 2023, respectively. Actual credit losses incurred during the years ended December 31, 2024 and 2023 were \$2,765 and \$2,674, respectively.

Pharmaceutical Drug Inventory

Inventories consist of pharmaceutical drugs and supplies. All items of inventory cost are determined using specific cost as of year-end. Inventory is measured at the lower of cost and net realizable value.

Property, Equipment, and Leasehold Improvements

Property, equipment, and leasehold improvements are stated at cost, less accumulated depreciation. Depreciable assets are depreciated over their estimated useful lives using the straight-line method. Equipment and computer equipment are depreciated over a period ranging from 3 to 10 years, and the land improvements and leasehold improvements are depreciated over a period ranging from 7 to 15 years. When assets are retired or otherwise disposed of, the cost and related accumulated depreciation are removed from the accounts and any resulting gain or loss is recognized. Expenditures for maintenance and repairs are expensed as incurred, whereas additions and improvements that extend the life of the asset are capitalized.

Benefits

Premiums paid by the Fund are recorded in benefits paid to or on behalf of participants or beneficiaries in the accompanying statements of changes in net assets available for benefits.

Claim payments are recorded when paid by the Fund and the third-party claims processors. Claim payments are recorded as benefits paid to or on behalf of participants or beneficiaries in the accompanying statements of changes in net assets available for benefits.

Refunds

Prescription refunds due from the Fund's PBM are recorded when known and earned with the offset against benefits paid to or on behalf of participants or beneficiaries. Refunds due as of the financial statement date have been reported as a receivable in the accompanying statements of net assets available for benefits. Pharmacy rebates totaling \$1,423,580 and \$1,496,110 have been netted with benefits paid to or on behalf of participants or beneficiaries in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Leases

The Fund determines whether an arrangement is a lease at the inception of the arrangement based on the terms and conditions in the contract. A contract contains a lease if there is an identified asset and the Fund has the right to control the asset. As accounting policy elections, the Fund does not apply Accounting Standards Codification 842, *Leases*, to short-term leases (term of 12 months or less), and accounts for non-lease and lease components in a contract as a single component for all asset classes. Right-of-use (ROU) assets represent the Fund's right to use an underlying asset for the lease term and lease liabilities represent the Fund's obligation to make lease payments arising from the lease. ROU assets and liabilities are recognized at the commencement date based on the present value of lease payments over the lease term.

For the Fund's leases that the rate implicit in the lease is not readily determinable, the Fund has elected to apply a risk free discount rate to determine the present value of lease payments. Lease terms include options to extend the lease when it is reasonably certain those options will be exercised. Leases may contain rent escalations over the lease term, and operating lease expense is recognized on a straight-line basis over the lease term.

The Fund leases office space. Operating leases are to be included in operating lease ROU assets and operating lease liabilities on the statements of net assets available for benefits.

The Fund's lease agreements do not contain any material residual value guarantees or material restrictive covenants.

The Fund rents or subleases certain office space to third parties. The lease and sublease portfolio consists of operating leases for space within the buildings. Sublease income recognized and disclosed for those leases in 2024 and 2023 is \$29,028 and \$26,795, respectively, and have been netted with benefits paid to or on behalf of participants or beneficiaries in the accompanying statements of changes in net assets available for benefits.

Allocation of Fund Expenses

The Fund provides health benefits through a combination of direct services rendered at its own medical facility and claims from external providers. The Fund allocates its costs between benefits paid, salaries, administrative supplies, operating lease cost, employee benefits, depreciation, and other deductions on the statements of changes in net assets available for benefits based on the nature and purpose of the expenditures. The allocation of the Fund's medical facility costs is based on reasonable and consistently applied methodologies, including square footage usage, department, and functional roles. These allocations are reviewed annually for appropriateness and adjusted as necessary.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Postretirement Benefits

A postretirement benefit obligation has been recognized for retiree medical benefits for eligible participants and their dependents upon retirement. These benefit obligations represent the actuarial present value of the cost of those estimated future benefits that are attributed by the terms of the Fund to employee service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current retirees of the Fund. The obligations represent the amounts that are expected to be funded by contributions from the participating employers and members, retirees, and from existing assets of the Fund. Postretirement benefits include future benefits expected to be paid to or for (a) currently retired or terminated employees and their beneficiaries and dependents, and (b) active employees and their beneficiaries and dependents after retirement from service with the participating employers. Prior to an active participant's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributable to that employee's service with a participating employer or employers rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by the Fund's actuary and is the amount that results from applying actuarial assumptions to historical claims cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements, such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The foregoing assumptions are based on the presumption that the Fund will continue. Were the Fund to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligations.

Claims Incurred but Not Reported

Fund obligations at December 31, 2024 and 2023 for claims incurred but not reported are estimated in accordance with accepted actuarial principles based on claims data provided by the Fund. These amounts are paid by the Fund only if claims are submitted and approved for payment.

The postretirement benefit obligation is not vested and can be modified or eliminated by action of the Board of Trustees in accordance with the terms of the governing documents. It is expected that any deficiency of net assets over benefit obligations would be funded through a combination of retiree premium payments and employer contributions. The Fund's Trustees are responsible for developing and implementing the funding policy.

The weighted average health care cost-trend rate assumptions have a significant effect on the amounts reported as postretirement benefit obligations. If the assumed rates increased by one percentage point in each year, it would increase the obligation as of December 31, 2024 and 2023 by \$1,180,636 and \$1,266,547, respectively.

The December 31, 2024 actuarial gain of \$1,119,705 is the result from experience different than expected, flat retiree premiums combined with lower-than-expected claims experience, and raising the discount rate from 4.66% to 5.32%. The gains were partially offset by other assumption changes. The December 31, 2023 actuarial gain of \$953,344 is the result from experience different than expected and lowering the discount rate from 4.86% to 4.66%. The gains were partially offset by flat retiree premiums combined with higher-than-expected claims experience.

5. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Fund has the ability to access at the measurement date.

Level 2: Inputs to the valuation methodology other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- a. Quoted prices for similar assets or liabilities in active markets,
- b. Quoted prices for identical or similar assets or liabilities in inactive markets,
- c. Inputs other than quoted prices that are observable for the asset or liability,
- d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Cash equivalents: Valued at cost, which approximates the fair value of the net asset value of shares held at year-end.

Corporate bonds and municipal bonds: Valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing the value on yields currently available on comparable securities of issuers with similar credit ratings. When quoted prices are not available for identical or similar bonds, those bonds are valued under a discounted cash flow approach that maximizes observable inputs, such as current yields or similar instruments, but includes adjustments for certain risks that may not be observable, such as credit and liquidity risks.

5. FAIR VALUE MEASUREMENTS (Continued)

US Government securities and US Government asset backed securities: The fair values of US Treasury securities are based upon unadjusted market prices and are classified within Level 1. The fair value of US Government asset backed securities is generally determined using observable market inputs that include quoted prices for identical or similar assets in markets that are not active, benchmark yields, reported trades, bids, offers and credit spreads. Accordingly, the fair value of the US Government asset backed securities is classified within Level 2.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Fund are open-ended funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Fund are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Fund believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

7. DEFINED CONTRIBUTION PLAN

The Fund sponsors a contributory qualified defined contribution plan for all eligible employees of the Fund. The plan, which is administered by FASCore, provides for the purchase of mutual funds by eligible employees. All employees of the Fund who have attained age 21 are eligible for participation in the employee deferral feature of the plan on the first of the month following their date of hire. Employees must complete one year of service, as defined by the plan, to be eligible for employer contributions.

Participants may elect to make voluntary pre-tax and post-tax Roth contributions of their eligible compensation subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. After participants complete one year of service, as defined by the plan, the Fund makes a matching contribution equal to 100% of the first 1% of each participant's eligible compensation contributed to the plan. The Fund also makes a fixed contribution equal to 4% of each participant's eligible compensation for the year. These percentages are determined by the Fund each year.

Fund contributions to the plan for the years ended December 31, 2024 and 2023 were \$195,503 and \$198,576, respectively.

8. LEASES AND RELATED PARTY TRANSACTIONS

Teamsters Local Union No. 200 (Teamsters Local 200) and Teamsters Local Union No. 695 (Teamsters Local 695) appoint certain Trustees of the Fund. The Fund has operating leases for building space from Teamsters Local 200 and Teamsters Local 695. Leases have remaining lease terms of 10 months to 58 months. The Fund has recorded prepaid assets totaling \$62,521 and \$65,196 as of December 31, 2024 and 2023, respectively, related to rent paid to Teamsters Local 200 and Teamsters Local 695.

The lease with Teamsters Local 200 had a term of November 1, 2019 through October 31, 2024 with annual rent payments of \$733,200. Effective February 15, 2024, the lease with Teamsters Local 200 was temporarily amended to reduce the monthly rent by \$401.86 until the Fund was able to resume operations in all leased space in July 2024. The lease was renewed for November 1, 2024 through October 31, 2029 with annual rent payments of \$701,100. Rent paid to Teamsters Local 200 was \$723,367 and \$733,200 for the years ended December 31, 2024 and 2023, respectively, and is included in benefits paid to or on behalf of participants or beneficiaries and in operating lease cost on the statements of changes in net assets available for benefits.

The lease with Teamsters Local 695 was renewed for November 1, 2022 through October 31, 2025 with annual rent payments of \$49,151. Effective January 1, 2023, the lease with Teamsters Local 695 was temporarily amended to reduce monthly rent to \$0 until the Fund was able to resume operations in all leased space in September 2023. Rent paid to Teamsters Local 695 was \$49,152 and \$16,384 for the years ended December 31, 2024 and 2023, respectively, and is included in benefits paid to or on behalf of participants or beneficiaries and in operating lease cost on the statements of changes in net assets available for benefits.

10. TAX STATUS

The trust established under the Fund to hold the Fund's assets is intended to qualify pursuant to Section 501(c)(9) of the IRC and is therefore not subject to tax under present income tax laws. The trust has obtained a favorable tax exemption letter from the Internal Revenue Service (IRS), and the plan sponsor believes that the trust and the Fund, as amended, continue to qualify and to operate in accordance with applicable provisions of the IRC.

US GAAP requires management of the Fund to evaluate tax positions taken by the Fund and recognize a tax liability (or asset) if the Fund has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Fund is subject to routine audits by taxing jurisdictions. In December 2022, the DOL notified the Fund they will be conducting an ERISA compliance investigation. The investigation has not concluded as of the date of this report.

11. TERMINATION OF THE FUND

Although it has not expressed any intention to do so, the Trustees have the right under the Fund to modify the benefits provided to and contributions required of participants, to discontinue its contributions at any time, and to terminate the Fund subject to the provisions of ERISA. In the event of termination of the Fund, the Trustees are authorized and empowered to dispose of the funds remaining in accordance with any plan conforming to the purposes of ERISA and the objectives of the Trust Agreement.

12. RISKS AND UNCERTAINTIES

The Fund invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

13. SUBSEQUENT EVENTS

The Fund has evaluated subsequent events through September 29, 2025, which was the date that these financial statements were available for issuance and determined that there were no significant nonrecognized subsequent events through that date.


