Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Supreme Group Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN:

The following description of the Supreme Group Inc. (“Company”) 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. *General.* The Plan was established on October 1, 1999 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The Plan was adopted under the provisions of Section 401(a) of the Internal Revenue Code (“Code”) with a cash or deferred arrangement qualified under Section 401(k) of the Code. Pursuant to the requirements of Section 401(a) 27 of the Code, the Plan is also a profit sharing plan. The Plan is a defined contribution plan that covers all active full-time non-union employees of Supreme Group Inc., Supreme Industries, Inc., Supreme Forest Products, Inc., Quantum Biopower Holdings, Inc. and Quantum Biopower Southington, LLC.

The Plan is administered by the Company and third-party advised by Pension Consultants, Inc. The assets of the Plan are held and invested by Empower Trust Company, LLC (“Empower”).

2. *Plan Amendments.* Effective January 1, 2023, the Plan was completely amended and restated under a new prototype plan document and adoption agreement. The Plan changed the custodian and record-keeper of the Plan from Newport Trust Company (“Newport”) to Empower. All existing Plan assets were liquidated and transferred to Empower on February 23, 2023, where they were invested at the direction of the Plan participants in mutual funds and a guaranteed investment contract. Effective October 1, 2024, the Plan was amended to change the service requirement for eligibility to 30 days. An eligible employee who meets this requirement will become a participant of the Plan on the first day of the month after their eligibility is met.
3. *Contributions.* Contributions to the Plan include (i) salary reduction contributions authorized by the participants, (ii) safe harbor matching contributions made by the Company, (iii) discretionary non-elective contributions made by the Company, (v) fixed non-elective (Davis-Bacon) contributions made by the Company, (v) discretionary matching contributions made by the Company, and (vi) rollovers from new participants from other qualified plans.

Each participant may authorize the Company to contribute into the Plan on a pre-tax basis or on an after-tax basis as Roth contributions, a percentage of their annual salary, up to the maximum amount permitted by law for each Plan year. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Participants are eligible to participate in the elective deferral, safe harbor company match, discretionary company match and employer non-elective contributions (including Davis-Bacon) the first day of Plan year month following 30 days of service with the Company with the October 1, 2024 amendment. Prior to this, eligibility was on the first day of the quarter following six months of service. Additionally, unless waived, participants are automatically enrolled in a 2% deferral of compensation election on that entry date. Participants must be employed on the last day of the Plan year to participate in the discretionary non-elective Company contributions.

The Company shall annually contribute and allocate to each eligible participant’s account a safe harbor matching contribution in the amount of 100% of the first 4% of the participant’s elective deferral contributed for the year. Additional discretionary matching and non-elective amounts may be contributed at the option of the Company. There were no such discretionary contributions made during the Plan year. Total participant contributions in any calendar year are limited to the applicable limit under Internal Revenue Code Section 402(g). The Plan also provides that certain limitations may be imposed on participants’ contributions in order to comply with statutory requirements.

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN (CONTINUED):

4. *Participant Accounts/Benefits.* Individual accounts are maintained for each Plan participant to reflect the participants' contributions, related safe harbor matching contributions, and discretionary Company contributions. Income and loss is allocated to the participants' accounts based on the ratio of the account balances of the individual to the aggregate of all account balances within the Plan.

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

5. *Vesting.* Participants are immediately vested in their contributions, safe harbor match and discretionary matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary non-elective contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant vests in the Company's discretionary non-elective contributions according to the following schedule:

Less than 2 years	0%
At least 2 years, but less than 3 years	20%
At least 3 years, but less than 4 years	40%
At least 4 years, but less than 5 years	60%
At least 5 years, but less than 6 years	80%
6 years or more	100%

6. *Notes Receivable from Participants.* Participants may borrow from their fund accounts up to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant's account and bear interest at rates that range from 5.25% to 10.25% as of December 31, 2024, which is commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.
7. *Investment Options.* Upon enrollment in the Plan, a participant may direct employee and employer contributions in a variety of Empower mutual funds and a guaranteed investment insurance contract. Participants may change their investment options daily.
8. *Payment of Benefits.* Upon termination of employment for any reason, including death, disability or retirement, the participant or their beneficiary will receive an amount equal to the value of the participant's vested interest in his or her account. An election is made by the participant or their beneficiary as to the form of payment (direct rollover or cash payment). In the absence of an executed election form, the Plan distributes benefit amounts less than \$1,000 in cash while amounts between \$1,000 and \$5,000 shall be rolled over into an individual retirement account; amounts greater than \$5,000 remain credited to the participant's account until an election is made.
9. *Forfeited Accounts.* At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$6,365 and \$6,774, respectively. These accounts will be used to reduce future employer contributions and pay Plan expenses. During the years ended December 31, 2024 and 2023, no employer contributions were reduced from non-vested accounts.

2. SUMMARY OF ACCOUNTING POLICIES:

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

2. SUMMARY OF ACCOUNTING POLICIES (CONTINUED):

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Investment Valuation and Income Recognition - Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the asset custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Plan Expenses - The Plan's administrative expenses related to Empower are paid by the Plan, as provided by the Plan document. In addition, expenses related to the Plan's third-party administrator, legal and audit expenses may be paid by the Plan or paid in whole or in part by the Plan sponsor.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits - Benefits are recorded when paid.

Subsequent Events - The Company has evaluated events and transactions for potential recognition of disclosure through October 14, 2025, which is the date the financial statements were available to be issued.

3. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB Accounting Standards Codification 820, *Fair Value Measurements*, are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

3. FAIR VALUE MEASUREMENTS (CONTINUED):

The asset or liability fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. Assets valued using the net asset value practical expedient are not required to be reported within the hierarchy.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in mutual funds are valued at the net asset value of shares held by the Plan at year end using market prices on active markets (Level 1). Investments in common stocks (self-directed brokerage accounts) are valued at the closing price reported on the active market on which the individual securities are traded (Level 1). Level 1 instrument valuations are obtained from real-time quotes for transactions in active exchange markets involving identical assets.

The Company's policy is to recognize transfers in and transfers out of levels as of the actual date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no significant transfers between levels.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. INFORMATION CERTIFIED BY THE PLAN'S CUSTODIANS:

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower and Empower Annuity Insurance Company of America ("EAICA"), qualified institutions and the custodians of the Plan, have certified to the completeness and accuracy of investments (with the exception of the self-directed brokerage accounts) and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as December 31, 2024 and 2023 and the schedule of assets (held at end of year) for investment purposes as of December 31, 2024, and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024. Included in the statement of changes in net assets available for benefits for the year ended December 31, 2024 is net appreciation in fair value of investments, dividend income and interest income on notes receivable which were certified by Empower and EAICA.

The Plan has entered into a benefit-responsive guaranteed investment contract with EAICA. EAICA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. EAICA is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by EAICA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract is a traditional investment contract. The contract value of the investment contract at December 31, 2024 and 2023 was \$30,293 and \$11,297, respectively.

The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with Empower. Such events include the following:

1. Amendments to the Plan documents (including complete or partial plan termination or merger with another plan).
2. Changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions.
3. Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan.
4. The failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines.
2. A breach of material obligation under the contract.
3. A material misrepresentation.
4. A material amendment to the agreements without the consent of the issuer.

6. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.
