Independent Auditor's Report

To the Trustees of The Frederick
Motor Company 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Frederick Motor Company 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Frederick Motor Company 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Notes to Financial Statements

(1) Description of plan and significant accounting policies

The following description of The Frederick Motor Company 401(k) Profit Sharing Plan (the Plan), provides only general information. Participants should refer to the Plan document and any amendments for a more complete description of the Plan's provisions.

General: The Frederick Motor Company (the Company), established a defined contribution plan effective August 1, 1965, covering all employees of the Company who are eligible to participate based on the eligibility requirements listed below.

Eligibility: Employees of the Company age 18 or older are eligible to participate in the Plan and receive employer matching contributions after completing 90 days of service. In addition to these eligibility requirements, employees are eligible to receive a profit sharing contribution if they are employed at the end of the plan year and have worked 1,000 hours during the plan year.

Contributions: Each year participants may contribute up to 100% of annual compensation, as defined by the Plan or the maximum allowed by law, as pre-tax or Roth elective deferrals. For the year ended December 31, 2024, a participant may elect to defer a maximum of \$23,000 on a pre-tax or Roth basis. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions, in excess of standard limits. Such additional contributions were limited to \$7,500 in 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a variety of registered investment companies (mutual funds), collective investment trusts and pooled separate accounts as investment options.

The Company may make discretionary matching contributions. For 2024, the Company funded a discretionary match allocated as a 100% match up to 2% of pay, plus an additional match capped at \$801.53 per participant. Discretionary matching contributions totaled \$150,388 for the year ended December 31, 2024.

In addition, the Company may also make a discretionary profit sharing contribution. Discretionary profit sharing contributions are allocated based on a ratio of each participant's compensation to the total compensation of all eligible participants for the specific plan year. There were no discretionary profit sharing contributions for the year ended December 31, 2024.

Contributions are subject to certain limitations.

Participant accounts: Each participant's account is credited with the participant's contributions, the Company's discretionary matching contributions, if any, and an allocation of (a) the Company's discretionary profit sharing contribution, if any, and (b) Plan earnings/losses, and may be charged with an allocation of administrative expenses for certain transactions. Allocations are based on participant earnings, account balances or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

The Frederick Motor Company 401(k) Profit Sharing Plan Notes to Financial Statements

(1) Description of plan and significant accounting policies (continued)

Vesting: Participants are immediately vested in their elective and rollover contributions plus actual earnings, thereon. Vesting in the matching and profit sharing contributions plus actual earnings, thereon, is based on years of service. A participant is 100% vested after 6 years of credited service as follows:

<u>Years of Vesting Service</u>	<u>Vested Percentage</u>
Less than One Year	0%
One Year but less than Two Years	10%
Two Years but less than Three Years	20%
Three Years but less than Four Years	40%
Four Years but less than Five Years	60%
Five Years but less than Six Years	80%
Six or More Years	100%

Participants become automatically fully vested when they reach normal retirement age while employed, or terminate employment due to total disability or death.

Notes receivable from participants: Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance reduced by the highest outstanding loan balance during the one-year period ending on the day before the loan is made. The loans are secured by the balance in the participant's vested account and will bear a commercially reasonable rate of interest on the date each loan is taken, as established by the Plan. Principal and interest are paid ratably through weekly payroll deductions. Loans must be repaid within five years or longer if the loan is for the purchase of a principal residence. The term for a "home loan" will be established by the Plan Administrator at the time of the loan. Interest rates on outstanding loans range from 5.25% - 10.50% as of December 31, 2024.

Payment of benefits: On termination of service, death, disability, or retirement, a participant or beneficiary is eligible to receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account. For accounts that are more than \$5,000, the participant must consent to the distribution before it may be made. Hardship distributions are permitted if certain conditions are met. In-service withdrawals are also permitted for participants who have reached age 59½. Cash distributions are generally subject to federal and state income tax withholdings.

Forfeited accounts: Non-vested employer contributions from withdrawing participants can be used to reduce current year employer matching contributions or pay administrative expenses of the Plan. The forfeitures are from previous year's employer contributions. As of December 31, 2024 and 2023, forfeited accounts totaled \$160 and \$8,233, respectively. Forfeitures totaling \$65,824 were used towards employer contributions during the year ended December 31, 2024.

A summary of the Plan's significant accounting policies follows:

Basis of accounting: The accompanying financial statements of the Plan are presented on the accrual basis of accounting.

(1) Description of plan and significant accounting policies (continued)

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: The Plan's investments, except for the fully benefit-responsive investment contract, are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

The Plan's fully benefit-responsive investment contract is reported at contract value. See Note 4 for discussion on the fully benefit-responsive investment contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Participant contributions and employer safe harbor matching contributions are recognized on the pay date to which they relate. Employer discretionary matching contributions are recognized in the year designated by the Company.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. The Plan has not identified any delinquent loans at December 31, 2024.

Funding policy: Contributions are funded as accrued.

Administrative expenses: Investment expenses, loan fees associated with notes receivable from participants and other administrative and recordkeeping fees may be paid for by the Plan. Administrative expenses of the Plan can also be paid by the Company, as provided in the Plan document. Certain accounting and administrative functions of the Plan are performed by employees of the Company at no cost to the Plan. Administrative expenses paid by the Plan totaled \$62,243 for the year ended December 31, 2024.

Investment related expenses are included in the net appreciation in fair value of investments.

Payment of benefits: Benefit payments to participants are recorded when paid.

FASB Accounting Standards Codification 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB Accounting Standards Codification 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies (mutual funds): Valued at the net asset value of shares held by the plan at year end. The mutual funds held by the Plan are mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Collective Investment Trusts and Pooled Separate Accounts: The fair value of the collective investment trusts and pooled separate accounts is based on net asset value (NAV). The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investments for an amount different than the NAV. Participant transactions (purchases and sales) may occur daily. The fund provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund's net asset value per unit. If the Plan initiates a full redemption, the issuer reserves the right to require twelve months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments at December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(4) Fully benefit-responsive guaranteed investment contract

In 2016, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Principal Financial Group (Principal). Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issued is contractually obligated to repay the principal at a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

(4) Fully benefit-responsive guaranteed investment contract (continued)

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$99,453 and \$100,541, respectively.

Certain events limit the Plan's ability to transact at contract value with Principal. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

(5) Related party and party-in-interest transactions

Plan investments were managed by Principal Financial Group for the year ended December 31, 2024, the custodian as defined by the Plan. Due to this relationship, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for recordkeeping and investment management services amounted to \$56,271 for the year ended December 31, 2024. Fees paid by the Plan for contract administration, transactions considered as party-in-interest transactions, to Tiger's Eye Benefits Consulting, amounted to \$5,972 for the year ended December 31, 2024.

(6) Plan termination

Although it has not expressed any intent to do so, the Company has the right under the terms of the Plan to discontinue its match and discretionary contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

(7) Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

(8) Tax status

The Plan is a qualified cash or deferred arrangement established under Section 401(k) of the Internal Revenue Code. The Plan Sponsor has executed an adoption agreement for volume submitter plan and relies on the determination letter dated June 30, 2020. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is currently designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has an uncertain tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan Administrator has evaluated the Plan's tax positions and has concluded that there are no uncertain positions taken or expected to be taken that would require adjustments to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by federal, state, or local tax authorities for years before 2021.

(9) Subsequent events

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 14, 2025, the date the financial statements were available to be issued. There were no subsequent events that required recording or disclosure in these financial statements.
