Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of SG360 Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Note 1 - Plan Description

The following description of SG360 Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of SG360 (the "Company") who have completed at least three months of service.

Contributions

Participants can contribute a portion of their compensation as a pretax or post-tax contribution to the Plan up to the maximum allowed under the Plan and the Internal Revenue Code. Eligible employees are automatically enrolled into the Plan with an employee deferral contribution rate of 3 percent of the employee's eligible compensation unless the employee elects a different deferral rate or affirmatively elects not to participate in the Plan. This deferral rate increases by 1 percent annually up to a deferral rate of 10 percent of eligible compensation unless an election is made to decline participation or an alternate deferral rate is elected. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan provides for employer discretionary matching contributions and discretionary profit-sharing contributions for all eligible employees, including those covered under a collective bargaining agreement (union employees). The Company's discretionary matching contributions are allocated as of the last day of the plan year and are based on a percentage of participant contributions and total compensation for all eligible participants. The allocation of any discretionary profit-sharing contribution is based on a percentage of a participant's eligible compensation. There were no discretionary profit-sharing contributions made in 2024.

During 2024, the Company elected to make a discretionary matching contribution on 50 percent up to the first 2 percent of employees' deferrals (or up to 1 percent of eligible compensation) for union employees. Additionally, the Company elected to make a discretionary matching contribution on 4 percent of eligible compensation for union employees.

During 2024, the Company elected to make a discretionary matching contribution on 100 percent up to the first 2 percent of employee deferrals and 50 percent up to the next 4 percent of employee deferrals (or up to 4 percent of eligible compensation) for nonunion employees.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's discretionary matching contributions, and allocations of any additional discretionary contributions and plan earnings (or losses) and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants are immediately fully vested in participant contributions, any profit-sharing contributions, and rollover contributions plus the actual earnings thereon. The portion of the participants' accounts attributable to the employer discretionary matching contributions becomes 33 percent vested after one year of service and continues to vest at the rate of 33 percent for each successive year until 100 percent vested after three years of service. In the event of death, disability, or retirement at designated ages, participants become fully vested.

Note 1 - Plan Description (Continued)

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to 50 percent of their vested account balances, not to exceed \$50,000. The notes receivable are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates determined periodically by the plan administrator. The notes receivable must be repaid within five years unless the purpose is for a primary residence. Principal and interest are paid ratably through regular payroll deductions.

Benefit Payments

Distributions are payable upon retirement, death, disability, or termination of employment in the form of a lump-sum amount equal to the vested balance of a participant's account. In-service withdrawals are also permitted for participants over the age of 59½, as well as from rollover funds at any time.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Voya Retirement Insurance and Annuity Company (Voya) or its affiliates. Voya is the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value except as noted below. The fully benefit-responsive investment contract is valued at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

The pooled separate accounts and common collective trust funds are valued at net asset value per share or its equivalent of the funds, which is based on the fair value of the funds' underlying assets. See Note 5 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Note 2 - Summary of Significant Accounting Policies (Continued)

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 14, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Voya Retirement Insurance and Annuity Company (the "Custodian") holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Custodian.

Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

There were no unfunded commitments or redemption restrictions on the investments described above.

Note 6 - Investment Contracts

The Plan has a benefit-responsive investment contract with Voya Retirement Insurance and Annuity Company. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The interest crediting rate is based on a formula agreed upon with the issuer but may not be less than 2 percent. Such interest rates are reviewed on an annual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the insurance company. Such events include the following: (i) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provision, (iii) bankruptcy of the plan sponsor or other plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator believes that the occurrence of any such events that would limit the Plan's ability to transact at contract value with participants is not probable.

As described in Note 2, because the contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets attributable to the insurance contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

Note 7 - Corrective Contributions

The plan sponsor failed to allow eligible leased employees who met eligibility requirements to make contributions to the Plan from 2011 through 2023. The plan sponsor has received an acceptance letter from the IRS to make a corrective contribution for 2011 through 2015 through the IRS Voluntary Correction Program. As of December 31, 2023, the 2011 through 2023 corrective contribution had been funded to the Plan. The plan sponsor funded the 2023 corrective contribution in 2024. There were no corrective contributions included in receivables as of December 31, 2024, and corrective contributions totaling \$584,021 have been included in employer contributions receivable for the year ended December 31, 2023.
