Independent Auditors' Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Komatsu Mining Corp. Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

Basis for Opinion

1. Description of the Plan

The following description of the Komatsu Mining Corp. Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). United States employees of Komatsu Mining Corp. (the Company) and certain of its affiliates whose compensation is reported on the Internal Revenue Service (IRS) Form W-2 are eligible to participate, except any employee who is temporary, leased, contracting or part of a collective bargaining agreement, unless the collective bargaining agreement states they are eligible to participate in the Plan, and any employee who is accruing benefits under the target benefit plan sponsored by Komatsu America Corp. An eligible employee may become an active participant in the Plan on the first day of the payroll period beginning after the employee's commencement date.

Administration

The Company, along with its parent company, Komatsu America Corp. (collectively, the Companies), established the Komatsu Plan Sponsor Committee to act on behalf of the Companies as plan sponsor to the employee benefit plans maintained by the Companies, including the Plan. In addition, the Companies established the Komatsu Pension and Investment Committee (the Committee) to serve as the plan administrator for their employee benefit plans. Fidelity Management Trust Company (the Trustee) serves as the trustee of the Plan, while Fidelity Investments, an affiliate of the Trustee, serves as the recordkeeper of the Plan.

Contributions

Each year, participants may contribute up to 25% of pre-tax annual compensation and up to 5% of after-tax annual compensation (10% for certain collectively bargained employees). Participants may also contribute to the Plan up to 25% of their after-tax earnings as Roth deferral. Each dollar of the Roth contribution reduces the amount that a participant is able to contribute on a pre-tax basis. Participants aged 50 or over may make additional catch-up contributions. Participants may also contribute amounts representing distributions from eligible retirement plans (rollover contributions). The Plan requires an automatic enrollment of a 6% pre-tax salary deferral contribution for new hires, but employees can opt out or change their contribution percentage at any time. The Plan has an automatic escalation of 1% annually (up to a maximum of 10%) for all newly hired non-union employees and for certain union employees. Contributions are subject to certain limitations.

The Company matches 50% of all employee contributions up to 6% of the participant's compensation. The Plan allows for Company matching true-up contributions for non-union participants who do not terminate employment prior to the last day of the applicable plan year in which the true-up is calculated.

The Company is required to contribute a fixed contribution to certain employee groups of 5% of eligible employee compensation, depending on the employee group. The 5% Company fixed contribution is comprised of a safe harbor contribution on behalf of each non-union participant in its employ equal to 3% of the participant's compensation and a non-safe harbor contribution on behalf of each non-union participant in its employ equal to 2% of the participant's compensation.

The Company is also required to contribute a retirement contribution of specific dollar amounts per participant based on specific contribution formula for each eligible employee group. These Company contributions comply with safe harbor requirements under the Internal Revenue Code (IRC).

Participants direct the investment of their contributions and Company contributions into any combination of available investment options offered by the Plan.

Participant Accounts

Separate benefit accounts are maintained for each participant. Each participant's account is credited with the participant's contributions, rollovers, Company contributions and an allocation of investment earnings or losses based on the investment funds selected and charged with an allocation of administrative expenses and any specific participant transactions such as loans, distributions and the related transaction expenses. Allocations are made to participants' accounts based on the proportion that each participant's balance bears to the total of all participant account balances within each investment fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately and fully vested in their voluntary contributions, rollovers, Company matching contributions and earnings thereon. Company fixed contributions to salaried and non-bargaining union employees and certain collectively bargained employees are considered 100% vested. All other participants who receive Company fixed contributions are considered 100% vested after three years. Participants who leave the Plan because of death, early or normal retirement, plant closings or disability retirement, as defined in the plan document, are fully vested.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$104,158 and \$49,818, respectively. These accounts will be used to reduce future Company contributions. During 2024, Company contributions were reduced by \$50,080 from forfeited nonvested accounts.

Payment of Benefits

Benefits may be paid to the participant or beneficiary upon death, long-term disability, retirement or termination of employment. Participants may be permitted to make withdrawals from the Plan in the event of financial hardship, as defined in the plan document. The Plan provides for normal retirement at age 65. The total vested portion of a participant's account balance is distributed in the form of a lump-sum payment, installments over a period not to exceed 15 years or a combination of the two. If no election is made and the participant's vested account balance is less than \$5,000, the plan administrator will distribute the balance to an individual retirement account or annuity for the participant's benefit, and if the participant's vested balance is less than \$1,000, the balance is automatically distributed to the participant. If a participant's account balance exceeds \$5,000, the participant may elect to defer payment. Automatic distribution commences when the participant turns age 73 or when the participant terminates employment.

Termination of Plan

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Notes Receivable from Participants

Participants may borrow from their accounts at a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are collateralized by the balance in the participant's account. The notes bear interest at rates ranging from 4.25% to 9.50% as of December 31, 2024 and 2023. These rates are commensurate with the prevailing prime rate plus 1%, as of the origination date. Principal and interest are paid ratably through payroll deductions. Terms range from one to five years or up to twenty years for the purchase of a primary residence.

Recent Regulatory Pronouncements

The SECURE 2.0 Act of 2022 (SECURE 2.0) was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the years ended December 31, 2024 and 2023. Plan management is evaluating the optional SECURE 2.0 provisions. The application of SECURE 2.0 did not have a material effect on the Plan's financial statements. The Plan will be amended to reflect any changes made in response to SECURE 2.0 prior to the deadline set by law or applicable regulations.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the Trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income is recorded on the accrual basis. Delinquent loans are reclassified as benefit payments based on the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Administrative Expenses

The Company pays substantially all administrative fees associated with the Plan. Certain participant transaction charges are paid by the Plan. Expenses that are paid by the Company are excluded from these financial statements.

Benefit Payments

Benefits are recorded when paid.

3. Information Certified by the Plan's Trustee

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, the Trustee has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the supplementary schedule Form 5500, Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from the information certified as complete and accurate by the Trustee, a qualified institution.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market fund - Valued at the published market price, which is a constant net asset value (NAV) of \$1 per unit.

Collective trust funds - Valued at the NAV of units of the collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV. Participant transactions (issuances and redemptions) may occur daily. Were the Plan to initiate a full redemption of a collective trust, the investment advisor reserves the right to temporarily delay withdrawal from that trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Registered investment companies - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts - Include common stock, certificate of deposits, corporate and government bonds, exchange-traded funds, and mutual funds that are valued at the quoted market price of the respective security held within the accounts. All securities within the accounts are traded on an active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the plan administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Tax Status

The Plan obtained its latest determination letter dated July 22, 2013, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. The plan administrator believes that the Plan, as amended, is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Risks and Uncertainties

The Plan invests in various investment securities that, in general, are exposed to various risks, such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of certain investments will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

As of December 31, 2024 and 2023, the Plan held two investments with significant concentration as a percentage of net assets available for benefits totaling \$291,716,769 and \$249,973,508, respectively.

8. Subsequent Events

The Plan has evaluated subsequent events for recognition or disclosure through October 14, 2025, the date the financial statements were available to be issued.
