NOTE A--PLAN DESCRIPTION

The following brief description of the Chiesi USA, Inc. 401(k) Retirement Plan ("the Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's terms and provisions.

General: The Plan is sponsored by Cornerstone BioPharma, Inc. and administered by an affiliate, Chiesi USA, Inc. (the "Company"). The Company is a wholly-owned private subsidiary of Chiesi Farmaceutici S.p.A ("Chiesi"). Effective January 1, 2015, the name of the Plan changed to the Chiesi USA, Inc. 401(k) Retirement Plan. Effective June 21, 2016, the Plan was amended to allow eligible employees of The Medicines Company to participate in the Plan. Empower Trust Company, LLC serves as the "Trustee" for the Plan.

The Plan is a defined contribution plan effective January 1, 2005.

Merger: Effective April 2023, the Company acquired AMRYT Pharmaceuticals, Inc. The Company's management approved the merger of the AMRYT Pharmaceuticals, Inc. 401(k) Plan ("Retirement Plan") with the Plan. The assets of the Retirement Plan (\$17,040,143) including notes receivable from participants (\$59,578) were transferred into the Plan on February 1, 2024.

Eligibility Requirements: Effective January 1, 2016, employees are eligible to participate in the Plan sixty days after date of employment and date age twenty-one is attained. The Plan provides an automatic enrollment feature whereby employees are automatically enrolled in the Plan on the first day of the following month upon meeting the eligibility requirements. Effective February 1, 2024, the auto deferral rate increased to 5% from 4%. If an employee terminates employment after becoming a participant and is later re-employed, he becomes a participant on his re-employment date.

Directed Investment Accounts: The Plan permits every participant to direct the investment of his account balance under the Plan. Refer to Note B herein for the various investment options available.

Participant Accounts: Each participant's account is adjusted for the Participant's contribution and allocations of the Company's contributions, investment earnings (losses), and certain administrative expenses.

Allocations of investment results are based on defined Participant earnings (losses) or account balances. The benefit to which a Participant is entitled is the benefit that can be provided from the Participant's vested account balance. In the event of a Participant's termination, as defined, unvested account balances are forfeited by the Participant and remain in the Plan to reduce future Company contributions.

Contributions: All employees can contribute a specific percentage or flat dollar amount of annual compensation up to the Internal Revenue Service ("IRS") maximum allowance. The IRS maximum allowance was \$23,000 for 2024. Annual compensation is limited to the employee's defined eligible compensation. Certain eligible Participants (age 50 and older) could contribute an additional \$7,500 as a catch-up contribution for 2024. This results in total pre-tax contributions of \$30,500 for 2024. Participants' contributions are collected by the Company through payroll deductions and forwarded to the Trustee. Contributions withheld from salaries and not yet forwarded to the Trustee are reflected as contributions receivable, if any.

Effective January 1, 2024, the Company must make mandatory matching contributions for all participants equal to 100% of 5% of eligible employee compensation. The Company made mandatory matching contributions of \$4,083,178 in 2024.

These mandatory matching contributions allow the Plan to be considered a "safe harbor" plan; thus, requiring no discrimination testing of deferral and matching contributions.

The Company may also make a discretionary additional matching contribution. The Company made no such additional matching employer contributions in 2024.

Forfeited Accounts: At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2 and \$141, respectively. This account will be used to reduce any matching contributions after the forfeiture is determined. The forfeitures used to reduce the Company matching contributions for the year ended December 31, 2024 were \$11,805.

Vesting: Participants are immediately vested in their elective and rollover contributions, employer matching contributions, as well as actual earnings thereon, and such amounts are non-forfeitable upon termination.

Funding Policy: Employer Safe Harbor Matching contributions and employee elective contributions accumulated through payroll deductions shall be paid to the trustee as of the earliest date on which contributions can reasonably be segregated from the employer's general assets, but in any event, within the time prescribed by law. Furthermore, any additional employer contributions which are allocable to participants' accounts for a Plan year shall be paid to the Plan no later than the twelve-month period immediately following the close of such Plan year.

Payment of Benefits: After Participants reach age 59-1/2, they may withdraw all or a portion of their account balance at any time and for any reason. Prior to age 59-1/2, in-service withdrawals from the Plan are allowed for unusual financial hardships. Termination withdrawals are a result of disability, termination of employment, retirement, or death.

Distributions are paid directly to an eligible retirement plan specified by the Participant (or designated beneficiary) in a direct rollover or to an Individual Retirement Account. Distributions can also be paid directly to the Participant, if so elected.

Rollover Contributions: The Plan provides for rollover contributions from other qualified retirement plans.

Notes Receivable from Participants: Effective February 1, 2024, the Plan was amended to allow participant loans. Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Transactions are treated as a transfer between the investment options and the participant's note fund. Loans bear a reasonable rate of interest as determined by the Plan Administrator. The entire amount of the participant's account serves as collateral for the loan. All loans must have a definite repayment period not to exceed five years unless it is for the purchase of their principal residence when the repayment period may be longer. Principal and interest are paid ratably through payroll deductions. A participant may only have one loan outstanding at any given time. Interest rates range from 4.25% to 8.50% at December 31, 2024 and mature at various dates through 2034.

Administrative Expenses: During 2024, all of the Plan's expenses were paid by the Company; however, the Plan reserves the right to have certain Plan expenses to be paid directly from the assets of the Plan. During 2024, the Plan paid administrative expenses of \$232,311 which included \$12,853 of distribution fees paid by Participants. There are certain expenses necessary to administer the Plan (including but not limited to, retaining necessary professional assistance from an attorney, accountant, or an investment advisor) that are paid by the Company. Certain investment related expenses are recorded in investment results and are not readily determinable.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The accompanying financial statements have been prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America.

Investment Options: Participants direct the investment of their accounts into the following investment options offered by the Plan: Blackrock High Yield Bond Portfolio K Fund, PIMCO Commodities Plus Strategies Fund, Vanguard 500 Index Admiral Fund, Vanguard Growth Index Admiral Fund, Vanguard Inflation Protected Securities Admiral Fund, Vanguard Mid-Cap Index Admiral Fund, Vanguard Mid-Cap Growth Index Admiral Fund, Vanguard Mid-Cap Value Index Admiral Fund, Vanguard REIT Index Admiral Fund, Vanguard Small-Cap Growth Index Admiral Fund, Vanguard Small-Cap Index Admiral Fund, Vanguard Small-Cap Value Index Admiral Fund, Vanguard Target Retirement Income Fund, Vanguard Target Retirement 2020 Fund, Vanguard Target Retirement 2025 Fund, Vanguard Target Retirement 2030 Fund, Vanguard Target Retirement 2035 Fund, Vanguard Target Retirement 2040 Fund, Vanguard Target Retirement 2045 Fund, Vanguard Target Retirement 2050 Fund, Vanguard Target Retirement 2055 Fund, Vanguard Target Retirement 2060 Fund, Vanguard Total Bond Market Index Admiral Fund, Vanguard Total International Bond Index Admiral Fund, Vanguard Total International Stock Index Admiral Fund, Vanguard Value Index Admiral Fund, Vanguard Emerging Markets Stock Index Admiral Fund, Vanguard FTSE Social Index Admiral Fund, Key Guaranteed Portfolio Fund, American Funds International Vntg R6 Fund, PGIM Global Real Estate R6 Fund, PIMCO Income 12 Fund, and Galliard Retirement Income Fund.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Contributions: Employer and employee contributions are accrued in the Plan year to which they relate.

Payment of Benefits: Benefit payments are recorded in the period in which they are paid to Participants.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Date of Management's Review of Subsequent Events: Plan management has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

NOTE C--FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are as described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none"><li>• quoted prices for similar assets or liabilities in active markets;</li><li>• quoted prices for identical or similar assets or liabilities in inactive markets;</li><li>• inputs other than quoted prices that are observable for the asset or liability;</li><li>• inputs that are derived principally from or corroborated by observable market data by correlation or other means.</li><li>• If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.</li></ul>
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust fund:* Valued at the NAV of units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There are no unfunded commitments and participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust or pooled separate account, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. The common collective trust funds and pooled separate accounts are not required to be classified within a level on the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE D--RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

For the year ended December 31, 2024, there were no investments of the Plan that were in an investment fund maintained by the Trustee.

NOTE E--PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE F--TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the nonstandardized prototype profit-sharing plan with a cash or deferral arrangement and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE G--RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE H--CERTIFIED INVESTMENTS

Information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC (the trustee of the Plan).
