### Note 1: Description of Plan

The following description of the Rubb, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering substantially all employees of Rubb, Inc. (the Company), who are age 18 or older. There is no minimum service requirement to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Contributions

Each year, participants may contribute a percentage of their eligible compensation, as defined by the Plan, as either pretax or after-tax Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of contributions into various investment options offered by the Plan. The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan at 6%, unless they affirmatively elect not to participate in the Plan. Contributions are automatically invested in a designated fund until changed by the participant.

The Plan follows the Qualified Automatic Contribution Arrangement Safe Harbor provision. Under this provision, the Company match is 100% of the first 1% of compensation that a participant contributes to the Plan, plus 50% of the participant's contributions between 1% and 6% of compensation. Contributions are funded on a payroll period basis. The Company Safe Harbor matching contributions for the year ended December 31, 2024 were \$168,007.

The Company also contributes a wage rate (Davis-Bacon) contribution to employees who work on federally funded projects in an amount equal to the the fringe benefit amount determined according to the prevailing rate schedule. Contributions are funded on a payroll period basis. Davis-Bacon contributions were \$248,050 for the Plan year ending December 31, 2024.

The Company may make discretionary matching contributions to the Plan. There were no discretionary matching contributions for the year ended December 31, 2024. Additional nonelective contributions may also be contributed at the discretion of the Company. To be eligible for the additional discretionary nonelective contribution, employees must have worked at least 1,000 hours of service during the Plan year. The Company made an additional discretionary contribution of \$206,329 for the year ended December 31, 2024.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

### Note 1: Description of Plan (Continued)

#### Participant Accounts

Each participant's account is credited with the participant's contributions, Company Safe Harbor matching contributions, Davis-Bacon contributions, discretionary matching contributions, if applicable, and allocations of the Company's discretionary nonelective contribution, if applicable, and plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are vested immediately in their voluntary contributions, Safe Harbor matching contributions, and Davis-Bacon contributions, plus actual earnings thereon. Vesting for discretionary matching contributions and nonelective contributions, plus actual earnings thereon, is based on years of continuous service. Participants become fully vested after two years of credited service, as defined by the Plan.

#### Notes Receivable From Participants

Participants may borrow from their Plan accounts. The minimum permitted note is \$1,000 and the maximum permitted note is the lesser of \$50,000 or 50% of their vested account balance, as defined. Notes may only be granted in the case of financial hardship and a maximum of three notes are allowed to be outstanding at any time. Notes must be repaid, with interest, over a period normally not to exceed five years. If the note is for the purchase of a principal residence, a longer repayment period may be permitted. The notes are secured by the balance in the participant's account and bear interest at the prime rate, plus 1%. Interest rates on notes outstanding at December 31, 2024 ranged from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

#### Payment of Benefits

On termination of service, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. The Plan also allows for in-service distributions upon attaining age 59½. Hardship distributions may also be made subject to certain requirements and Plan provisions. The Plan will also make mandatory distributions following severance from employment to participants with a vested balance under \$7,000 (\$5,000 before January 1, 2024).

#### Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$719 and \$1,259, respectively. These accounts will first be used to pay administrative expenses of the Plan. If any forfeitures remain after paying these expenses, they will be allocated to all other eligible Participants as additional contributions. During the year ended December 31, 2024, forfeitures in the amount of \$1,259 were allocated to participant accounts. No forfeitures were used to pay administrative expenses during the year ended December 31, 2024.

### Note 2: Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in total investment income.

#### Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described, as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Stable value collective trust fund:* A stable value fund that is comprised primarily of guaranteed investment contracts that are valued at the NAV of the units of the collective trust. The NAV is used as the practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. The objective of the fund is to provide stability of principal and high current income. The stable value fund can be redeemed by participants on a daily basis at the NAV. Participating trusts are required to provide written notice 12 month in advance for any withdrawal that results from an employer-initiated event. The fund has no unfunded commitments.

### **Note 5: Party-in-Interest Transactions**

Charles Schwab Trust Bank is defined as the trustee of the Plan. EPIC Advisors, Inc. is the recordkeeper for the Plan and Bigelow Investment Advisors, LLC is the investment advisor for the Plan. Recordkeeping fees and investment advisor fees are included in administrative expenses. Investment management fees paid during the year ended December 31, 2024 are offset against investment income in the statement of changes in net assets available for benefits.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

### **Note 6: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in Company discretionary matching and nonelective contributions.

### **Note 7: Tax Status**

The Company adopted a pre-approved adoption agreement with an IRS notification letter which states the pre-approved adoption agreement is in compliance with the applicable sections of the Internal Revenue Code (IRC). The plan has been amended since receiving the notification letter; however, the plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
