NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN

The following description of the **Mountain Laurel Medical Center (Employer/Sponsor) 403(b) Plan** (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General: The Plan is a retirement savings plan covering all employees meeting certain eligibility requirements as outlined in the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors is responsible for oversight of the Plan including determining the appropriateness of the investment offerings and monitoring investment performance.

Contributions: Each year, participants may contribute up to the maximum percentage of annual compensation allowable, as defined in the Plan. Roth contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover).

The Plan contains a provision for discretionary non-elective (profit-sharing) and matching employer contributions. These contributions are discretionary based on a non-integrated formula based on eligible compensation to receive any discretionary non-elective or matching contributions. The Plan made a total of \$380,496 non-elective employer contributions for the year ended December 31, 2024.

Investment options: Participants direct the investment of their account balance into various investment options offered by the Plan. Participants may change their investment directions at any time, subject to such restrictions and procedures as established by the record-keeper, Plan, and Employer/Sponsor.

Participant accounts: Each participant's account is credited with the participant's contribution and allocations of the employer's contribution, plan earnings, charged with an allocation of administrative expenses that are paid by the plan, and a participant service fee, if applicable. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Plan's discretionary non-elective and matching contributions, plus actual earnings thereon is based on years of continuous service. The standard measure for one year of service is the completion of 1,000 hours during the Plan year.

In addition, participants become automatically fully vested when they reach normal retirement age, become disabled, or upon death while employed.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates. Principal and interest is paid ratably through payroll deductions.

Payment of benefits: Benefits are payable upon disability, death, or termination of employment. Hardship withdrawals and in-service withdrawals at age 59½ are also permitted, subject to provisions described in the Plan document. Withdrawals from rollover contributions are permitted at any time. Benefits are payable in a lump sum payment.

Forfeited accounts: At December 31, 2024 forfeited non-vested accounts totaled approximately \$1. These amounts will be used to reduce certain future employer contributions or used to pay Plan expenses. During 2024 \$15,349 in forfeitures were used to offset employer contributions.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of accounting: The accompanying financial statements are prepared in conformity with the modified cash basis of accounting. Under this basis of accounting, certain revenues are recognized when received rather than when earned and certain expenses are recognized when paid rather than when incurred. Investments are recorded at fair value.

Use of estimates: The preparation of financial statements in conformity with the modified cash basis of accounting, which is a comprehensive basis of accounting other than generally accepted accounting principles, requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates. Significant estimates include fair value determinations provided by the trustee or custodian.

Investment valuation and income recognition: Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The accounts are credited with actual earnings on the underlying investments charged for Plan withdrawals and administration expenses charged by Alerus Financial, N.A.. Since the Plan provides for participant directed investment programs, Alerus Financial, N.A. also maintains an account record for each participant. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Participant contributions are recognized on the pay date to which they relate. Employer contributions are recognized in the year designated by the Sponsor.

Administrative expenses: Investment management expenses, loan fees associated with notes receivable from participants and other administrative and recordkeeping fees may be paid for by the Plan. Administrative expenses of the Plan can also be paid by the Sponsor, as provided in the Plan document. Certain accounting and administrative functions of the Plan are performed by employees of the Sponsor at no cost to the Plan. Investment-related expenses are included in the net appreciation (depreciation) in fair value of investments. Administrative expenses paid by the Plan totaled \$20,364 for the year ended December 31, 2024.

Payment of benefits: Benefits are recorded when paid.

3. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

4. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Valued at the net asset value of shares held by the plan at year end. The mutual funds held by the Plan are mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Transfers between levels: For the years ended December 31, 2024 and 2023, there were no significant transfers between levels 1 and 2 and no transfers in or out of level 3.

The investments use the net asset value per share as determined by investment managers under the so called “practical expedient”. The practical expedient allows net asset value per share to represent fair value for reporting purposes when the criteria for using this method are met. These investment funds are held as units or interest in institutional funds or limited partnerships, which are stated at net asset value (NAV) or its equivalent. The NAV is used as a practical expedient to estimate the fair value, unless it is probable that all or a portion of the investment will be sold for an amount different than NAV.

5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan holds an investment contract that comprises a traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The following represents the contract value by type of investment contracts held by the Plan as of December 31:

The traditional investment contract held by the Plan is a guaranteed investment contract, which for the years ended December 31, 2024 and 2023 was backed by Alerus' general accounts. Due to the nature of the contract, it does not have specific underlying assets assigned. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Such events include (1) the Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under section 501(a) of the Internal Revenue Code, (2) premature termination of the contracts, (3) Plan termination or merger, (4) changes to the Plan's prohibition on competing investment options, or (5) bankruptcy of the Plan sponsor or other Plan sponsor events that significantly affect the Plan's normal operations. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreements without the consent of the issuer.

6. ROLLOVER CONTRIBUTIONS

Rollovers into the Plan for the period ended December 31, 2024 were \$279,456.

7. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by affiliates of Alerus Financial, N.A. Alerus Financial, N.A. is the custodian as defined by the Plan. These transactions qualify as exempt party-in-interest transactions.

8. PLAN TERMINATION

Although it has not expressed intent to do so, the Employer/Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts. Any unallocated asset of the Plan shall be allocated to participant accounts and distributed in such a manner as the Employer/Sponsor may determine.

9. TAX STATUS

The IRS has determined and informed the Company by a letter dated March 31, 2017, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC; and therefore, believe the Plan is qualified and maintains tax-exempt status for Plan participants under Section 403(b) of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service and Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

10. CERTIFIED INVESTMENTS

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Alerus Financial, N.A. has certified as to the completeness and accuracy of all investments reflected in the accompanying Statement of Net Assets Available for Benefits as of December 31, 2024 and 2023, the Schedule of Assets (Held at End of Year) as of December 31, 2024, the related investment activity for the year ended December 31, 2024 that is reflected in the Statement of Changes in Net Assets Available for Benefits. The contract value of the guaranteed investment contract was also certified by the custodian.

11. SUBSEQUENT EVENTS

The Plan has evaluated events and transactions subsequent to December 31, 2024 through October 14, 2025, the date these financial statements were available to be issued. Based on the definitions and requirements of accounting principles generally accepted in the United States of America, management has not identified any events that have occurred subsequent to December 31, 2024 through October 14, 2025, that require recognition or disclosure in the financial statements.
