Scope and Nature of the ERISA 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Capper Foundation Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Basis of Accounting

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements and supplemental schedule are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

Notes to the Financial Statements December 31, 2024 and 2023

1. Description of the Plan

The following description of The Capper Foundation Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of The Capper Foundation (the Organization) who have completed four consecutive months of employment and are age 18 or older. Effective April 15, 2023, the Plan was amended to cover all employees of the Organization who have completed three consecutive months of employment and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974. The Organization's board of trustees is responsible for oversight of the Plan. The board fiscal committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the board of trustees.

Contributions

Each year participants may contribute a portion of their annual compensation as pretax 401(k) deferrals and/or Roth 401(k) deferrals, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contribution into various investment options offered by the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Effective April 15, 2023, the Plan added an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation and their contributions invested in designated target funds until changed by the participant.

The Plan allows for discretionary profit sharing and employer match contributions each year. The board of trustees approved an employer match contribution of 100% of the participant's deferral up to 4.0% of compensation in 2024 and 2023, totaling \$136,937 and \$122,577 for the years ended December 31, 2024 and 2023, respectively. Employer contributions are paid into the Plan in the year following approval. To be eligible for the employer's contribution, a participant must have completed three consecutive months of employment. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution, employer match contributions, allocation of the Organization's discretionary contribution and net appreciation in fair value of investments and is charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on net appreciation in fair value of investments or account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective deferrals including catch-up contributions, rollover contributions from other plans, plus actual earnings thereon. Vesting in the Organization's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service. A participant becomes fully vested, regardless of the years of service, upon attainment of retirement age or due to total and permanent disability or death.

1. Description of the Plan (continued)

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$7,569 and \$326, respectively. Forfeited balances are used to reduce future employer contributions. Employer contributions were reduced by \$363 and \$0 from forfeited nonvested accounts in 2024 and 2023, respectively.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is lower. The loan is secured by the balance in the participant's account. The loan interest rate is set at 1% above the prime rate as defined. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

The Plan provides for payment of benefits upon death, disability, retirement, or termination of employment. A separated participant with a vested balance exceeding \$5,000 may elect to receive a lump-sum distribution, to receive a partial withdrawal, or to receive their balance in installments. If a separated participant has a vested balance that does not exceed \$5,000, they will receive a lump-sum distribution rather than receiving installments.

Expenses

The Plan's expenses are paid by either the Plan or the Organization, as provided by the Plan document. Expenses are paid directly by the Organization and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Plan Amendments

Effective April 15, 2023, the Plan was amended as follows:

- Employees of the Organization are eligible for pre-tax and/or Roth 401(k) deferrals, discretionary profit sharing, and employer match contributions after completing three months of service.
- The Plan entry date for all contribution types was modified to be the date an employee satisfies the eligibility requirement.
- An automatic salary deferral feature was added to the Plan. Upon completion of eligibility requirements, a pre-tax 401(k) employee deferral of 2% will go be automatically withheld each payroll period, unless an employee makes an affirmative election otherwise. The automatic deferral provisions apply to all participants, except those who have a salary deferral agreement in effect as of April 15, 2023.

1. **Description of the Plan** (continued)

SECURE Act 2.0

On December 29, 2022, the Consolidated Appropriations Act of 2023 was signed into law, which includes the package of retirement provisions referred to as "SECURE Act 2.0." These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting more participants into the retirement system, finding ways for them to accumulate more assets, and then ensuring they get connected with those assets when retirement comes. Plan management is monitoring the SECURE Act 2.0 provisions, which began to go into effect during the Plan year 2024 and beyond.

2. **Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared on the modified cash basis of accounting. The modified cash basis is used for the Plan's financial reporting under ERISA. The modified cash basis of accounting adopted by the Plan differs from the accrual basis in that revenues, except for unrealized gains and losses on investments, are recognized when received rather than when earned, and expenses are recognized when paid rather than when the obligation is incurred. Gains and losses on investments are recognized as revenue or expense whenever fluctuations in the market value occur.

Use of Estimates

The preparation of financial statements in accordance with the modified cash basis of accounting requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Organization's board fiscal committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income and dividends are recorded when received. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded when received. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- a. Quoted prices for similar assets or liabilities in active markets.
- b. Quoted prices for identical or similar assets or liabilities in inactive markets.
- c. Inputs other than quoted prices that are observable for the asset or liability.
- d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

4. Fair Value Measurements (continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

- *Money market account* – Money market fund whose stated objective is to maintain a \$1 net asset value.
- *Mutual funds* – Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- *Exchange-traded funds (ETFs)* – Valued at the daily closing price. ETFs are investment companies whose shares are traded intraday on stock exchanges at market-determined prices, which may be greater or less than NAV. ETFs are registered with the SEC, and generally are structured as open-ended investment companies or unit investment trusts.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

We evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the years ended December 31, 2024 and 2023, there were no significant transfers in or out of Levels 1, 2 or 3.

5. Related Party Transactions and Transactions with Parties-in-Interest

A related party is any party who can control or significantly influence Plan management or operating policies. Parties-in-interest are defined under Department of Labor regulations as any employees of the Plan, fiduciaries of the Plan, service providers to the Plan, the employer whose employees are covered by the Plan, and certain significant owners of the employer and their relatives. Service providers may include, but are not limited to the custodian, trustee, third-party administrator (TPA), investments managers, investment advisors, legal counsel, and Plan auditor.

The Plan made direct payments to certain parties-in-interest for administration and investment advisory fees, as allowed by ERISA of \$15,854 and \$11,027 during the years ended December 31, 2024 and 2023, respectively. The Plan sponsor pays directly any other fees related to the operation of the Plan.

Fees incurred by the Plan for investment management services are included in the net appreciation in fair value of the related investment, as they are paid using investment earnings rather than a direct payment.

Notes receivable from participants are managed by the TPA and are also considered party-in-interest transactions.

6. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

7. Tax Status

The Company adopted a Volume Submitter Profit Sharing Plan with CODA (cash or deferred arrangement) which received a favorable opinion letter from the IRS on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has since been amended. However, the Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt as of December 31, 2024. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

9. Subsequent Events

The Plan has assessed subsequent events through October 13, 2025, the date that the financial statements were available to be issued.
