Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Annie E. Casey Foundation 403(b) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by banks or similar institutions or insurance carriers that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by banks or similar institutions or insurance carriers in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter — Supplemental Schedule Required by ERISA

The supplemental schedule H, line 4i – schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial



statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. 1. DESCRIPTION OF THE PLAN

The following brief description of The Annie E. Casey Foundation 403(b) Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

Effective March 31, 1988, The Annie E. Casey Foundation (AECF or the Foundation) established a tax-deferred annuity plan under Section 403(b) of the Internal Revenue Code (the Code) of 1986, covering all eligible employees of the Foundation as defined by the Plan called The Annie E. Casey Foundation Tax Deferred Annuity Plan. A second tax-deferred annuity plan called the Casey Family Services 403(b) Retirement Plan was set up on January 1, 1989, and was created specifically for employees of the Casey Family Services (CFS) division. A third tax-deferred annuity plan called the Mutual of America 403(b) Plan was established and funded through Mutual of America Life Insurance Company annuity contracts. The Plan was established as a result of a merger of the prior plans.

The Plan was amended and restated effective January 1, 2020. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA) of 1974. The Plan is sponsored by the Foundation.

The Plan excludes from participation independent contractors, leased employees, any person who serves only as a director or consultant, student interns, and employees who normally work fewer than 20 hours per week.

Recent Legislation

The Setting Every Community Up for Retirement Enhancement (SECURE) Act 2.0 was signed into the 2023 Consolidations Appropriations Act under the Securing a Strong Retirement Act on December 29, 2022, with retirement provisions designed to increase retirement savings, facilitate access to retirement savings, encourage employees to save for retirement, and lower employers' cost of offering and funding retirement plans. The Plan's management and those charged with governance have a policy to incorporate these legislative changes in its Plan document by the prescribed deadlines.

THE ANNIE E. CASEY FOUNDATION 403(b) SAVINGS PLAN

Notes to the Financial Statements December 31, 2024 and 2023

1. DESCRIPTION OF THE PLAN (continued)

Contributions

The participants may elect to contribute to the Plan, on a pre-tax or Roth basis, a certain amount of their annual compensation as defined in the Plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all eligible employees hired after March 1, 2008 are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Participants hired after April 1, 2013 are subject to the 3% auto enrollment rate and participants hired after March 1, 2008 and before April 1, 2013 were subject to the 2% auto deferral rate. Participants with contribution rates less than 10%, unless they elect out or meet other criteria as specified in the Plan, will be subject to an automatic annual increase of 1% until the 10% maximum is reached. Contributions are subject to certain Internal Revenue Service (IRS) limitations. The Foundation can make discretionary contributions.

Compensation

As defined by the Plan, compensation eligible for contribution includes W-2 earnings including short-term disability pay, commissions and over-time pay, and excludes bonuses, fringe benefits (cash, noncash and imputed income), tuition reimbursement, moving expenses, and severance packages.

Participant Accounts

Each participant's account is credited with the participant's contribution, company discretionary contributions, and allocations of investment income (loss) based on the number of shares of each investment held by the participants and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or participant-initiated transactions, as defined by the Plan document. The participant is entitled to a benefit that cannot exceed the participant's vested account.

Vesting

Participants are immediately vested in their voluntary and employer contributions plus actual earnings thereon.

1. DESCRIPTION OF THE PLAN (continued)

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or one half of a participant's account, reduced by the highest outstanding balance of loans during the one-year period ending on the day before a new loan is made.

The loans are secured by the balance in the participant's account. Principal and interest is paid through payroll deductions. It is the participant's responsibility to continue to make loan repayment after termination of employment.

Payment of Benefits

Upon death, disability, retirement, in service and hardship or termination of employment, a participant (or designated beneficiary in the case of death) may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, periodic installments as defined by the Plan or one of the annuity options as defined by the Plan.

If a participant's account does not exceed \$5,000, and the participant does not timely return completed distribution forms, the account balance will be paid in a single lump sum to an individual retirement account designated by the Foundation as soon as administratively practicable.

Plan Termination

Although it has not expressed any intent to do so, the Foundation has the right under the Plan to terminate the Plan subject to the provisions of ERISA. Participants are 100% vested in their accounts and employer contributions, as defined by the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except for its fully benefit-responsive investment contracts, which are valued at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee, in conjunction with T. Rowe Price Trust Company, one of the Plan's custodian, determines the Plan's valuation policies utilizing information provided by the investment advisors and Trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document. Interest income is recorded on the accrual basis.

Contributions

Employee contributions are recorded in the period that the Foundation processes payroll deductions from the participant's earnings.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Expenses

Certain expenses for maintaining the Plan are paid directly by the Foundation and are excluded from these financial statements. Fees related to the administration of notes receivable and other distributions from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/(depreciation) of fair value of investments.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Expenses (continued)

The Plan has administrative budget and fee credit accounts. On a quarterly basis, certain revenue sharing payments (e.g., 12b-1 fees, etc.) received from certain of the Plan's investment options are deposited into the dedicated administrative budget and fee credit accounts of the Plan. The deposits are recorded as administrative fee reimbursements, net in the accompanying statement of changes in net assets available for benefits. Amounts deposited in the administrative budget and fee credit accounts are used to pay on-going administrative expenses of the Plan and any excess revenue is allocated to participants at year end in accordance with ERISA and guidance issued by the U.S. Department of Labor. For the year ended December 31, 2024, \$56,577 was deposited into the dedicated accounts. Additionally, during the year ended December 31, 2024, the account disbursed \$56,531 to be allocated to eligible participants in additional fee credits, and the accounts earned \$46 in interest. As of December 31, 2024 and 2023, the balance was \$53,801 and \$53,709, respectively.

Subsequent Events

The Plan's management evaluated subsequent events and transactions through October 10, 2025, the date these financial statements were available for issue, and have determined that no material subsequent events have occurred that would affect the information presented or require additional disclosure.

3. CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation/(depreciation) in fair value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by T. Rowe Price Trust Company, VOYA Retirement Insurance and Annuity Company, State Street Bank and Trust Company, and Mutual of America Life Insurance Company, the custodians of the Plan.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

4. FAIR VALUE MEASUREMENTS (continued)

The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the entity has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Interest bearing cash: Valued at cost plus credited interest earnings.

Mutual funds: Certain mutual funds are valued at the current trading value of shares held by the Plan at year end and are rendered Level 1. The separate accounts are valued at the net asset value of the underlying assets per share at the close of each business day as reported by each fund, which is then adjusted for dividends and separate account fees and are rendered Level 2.

5. FULLY BENEFIT RESPONSIVE INVESTMENT CONTRACTS

The Plan invests in certain traditional insurance company annuity contracts. The contracts maintain the contributions in respective general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

As described in Note 2, because the contracts are fully benefit-responsive, contract value is the relevant measurement attribute for these investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. The following represents the minimum crediting interest rate of investment contracts held by the Plan for the year ended December 31, 2024.

Such interest rates are reviewed periodically, but not less than annually.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its contractual obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following:

1. Amendments to the Plan documents (including complete or partial Plan termination or merger with another plan);
2. Changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions;
3. Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan;
4. The failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; and/or
5. Premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Such events include the following:

1. An uncured violation of the Plan's investment guidelines;
2. A breach of material obligation under the contract;
3. A material misrepresentation; and/or
4. A material amendment to the agreements without the consent of the issuer.

6. RELATED-PARTY TRANSACTIONS AND PARTY- IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by the custodians of the Plan, and, therefore, these transactions qualify as party-in-interest transactions for which a statutory exemption applies.

The Plan loans funds to its participants according to the applicable provisions of the Plan document. Certain officers and employees of the Foundation (who may also be participants in the Plan) provide certain accounting, administrative, and investment management services to the Plan for which no fees are charged. All such transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate risk, market risk, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

8. TAX STATUS

The Plan has adopted a pre-approved plan document that has received an opinion letter from the IRS dated March 31, 2017, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the Code. Although, the Plan has been amended since adopting the pre-approved Plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code, and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2018.
