**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Innovative Consulting & Management Services, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a participant-directed defined contribution and profit-sharing plan covering substantially all full-time employees, excluding union employees of Innovative Consulting & Management Services, LLC (the Plan Sponsor or the Company). Employees can enter the Plan after completing two months of service with entry dates every first day of each quarter of the year, and must be at least 21 years old. The Plan was originally effective January 1, 2016 and was restated effective January 1, 2021. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On March 27, 2020, Congress passed the Coronavirus Aid, Relief, and Economic Security Act ("CARES Act") which included several relief provisions to tax qualified plans and their participants that were put into operation by the Plan at that time. Formal adoption of such provisions of the CARES Act provisions is required to occur on or before December 31, 2025.

The Plan is administered by the Employer and the assets of the Plan are held and invested by John Hancock Life Insurance Company (the Custodian). The Board of Trustees is responsible for oversight of the Plan, determining the appropriateness of the Plan's investments and monitoring investment performance.

**Contributions**

Participants may elect to make any combination of the pre-tax deferral and Roth deferral contributions through salary reduction up to 90% of their compensation as defined by the Plan, subject to the limitations of the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined-benefit or defined-contribution plans (rollovers). The Plan provides for a safe harbor non-elective employer contribution equal to 3% of Plan compensation to all participants. The Employer may also make discretionary employer match contributions up to 4% of Plan compensation, subject to the provisions of the Plan. On an annual basis, the Employer may contribute a discretionary profit-sharing contribution to eligible participants. The discretionary profit-sharing contribution allocation is based on the ratio that each eligible participant's compensation bears to the total of such compensation of all eligible participants. For the year ended December 31, 2024 safe harbor non-elective employer match contributions were \$299,776 and \$0 was contributed as profit-sharing contributions. There were no discretionary employer contributions during the year ended December 31, 2024.

**Contributions** (Continued)

Participants direct the investment of their contributions and the Employer contributions into various investment options offered by the Plan. The Plan currently offers various pooled separate accounts as investment options for the participants.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, the earnings/losses on the participant's account, the Employer matching contribution, and the allocations of the Employer's discretionary profit-sharing contribution, if any. Participant accounts are charged for any withdrawals, distributions, and an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Participant Loans**

Participant loans are not permitted.

**Vesting**

Participants are immediately vested in their contributions (including rollover contributions) plus actual earnings thereon. A participant's account attributable to the safe harbor non-elective employer contributions becomes 100% vested immediately. Vesting in the Company's discretionary employer match and profit-sharing portion of their accounts, plus actual earnings thereon, is based on years of continuous service. The participants become vested based on continuous service in 20% increments starting upon completion of two years of service and become 100% vested upon completion of their sixth year of service.

**Payment of Benefits**

Participants or their beneficiaries are entitled to receive a distribution of their vested accounts in the Plan upon termination of their employment, their retirement, death, or disability. The participant may elect to receive either a lump-sum amount equal to the value of the participant's account balance or receive partial withdrawals. For termination of service due to other reasons, a participant may receive the value of his or account as a lump-sum distribution. A terminated participant's account balance of less than \$5,000 does not require the participant's consent and is automatically rolled over to an IRA selected by the Plan Administrator.

In-service distributions without penalty are allowed if the participant has attained age 59 1/2. Upon financial hardship, a participant is entitled to the value of his or her fully vested accounts, which is payable immediately in a lump-sum distribution. The Plan, in line with the IRS rules, also requires the participants to receive Required Minimum Distributions once they are 72 years old.

**Payment of Benefits (Continued)**

Amounts allocated to participants who have withdrawn from the Plan but have not received a payout of benefits amounted to \$142,964 at December 31, 2024.

**Forfeitures**

Forfeitures of non-vested Employer contributions are used to offset Plan expenses, reduce employer contributions or be reallocated as employer contribution. The Plan's forfeiture account was \$0 as of December 31, 2024 and 2023.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors and the Custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation included in the fair value of investments includes the Plan's gains or losses on the investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits payments to participants are recorded when paid.

**Operating Expenses**

Certain administrative functions are performed by officers or employees of the Employer. No such officer or employee receives compensation from the Plan. Selected administrative expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Certain other expenses, such as recordkeeping fees, are recorded in the accompanying statement of changes in net assets available for benefits as administrative expenses. Fees related to the administration of participant loans and payments of benefits are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

**NOTE 3 - UNAUDITED INFORMATION CERTIFIED BY THE PLAN TRUSTEE**

The Statements of Net Assets Available for Benefits at December 31, 2024 and 2023, the related Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024 and the accompanying notes to the financial statements were prepared in part or entirely from information certified by the Custodian, John Hancock Life Insurance Company, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information includes total investments of \$3,549,418 and \$2,621,526 at December 31, 2024 and 2023, respectively, and related net investment income of \$401,451 for the year ended December 31, 2024.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Gains and losses included in changes in net assets available for benefits for the year ended December 31, 2024, are reported in net appreciation or depreciation in fair value of investments.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available.

The three levels of the fair value hierarchy under reporting and accounting standards are described as follows:

Level 1: Fair values are based on unadjusted quoted prices for identical assets or liabilities in active markets. Active markets are defined as a market in which transactions take place with sufficient frequency and volume to provide pricing information on an ongoing basis.

Level 2: Fair values are based on inputs other than quoted price included within level 1 that are observable for valuing the asset or liability, either directly or indirectly (i.e. interest rate and yield curves observable at commonly quoted intervals, default rates, etc.). Level 2 inputs include quoted price for similar assets or liabilities in active or non-active markets, inputs other than quoted market prices that are observable and inputs that are derived principally from or corroborated by observable market data through correlation or other means.

Level 3: Fair values are based on price or valuation techniques that require inputs that are both unobservable and significant to the overall fair value measurement. These valuations, whether derived internally or obtained from a third party, use critical assumptions that are not widely available to estimate market participant expectations in valuing the asset or liability.

Following is a description of the valuation methodologies used for the assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Pooled Separate Accounts: The pooled separate accounts (PSAs) invest mainly in domestic stocks, the majority of which have observable Level 1 inputs. While the underlying asset values are quoted prices, the net asset value ("NAV") of a separate account is not publicly quoted. Accounting Standard Codification (ASC) 820 allows NAV per share to serve as an estimate of fair value as long as certain requirements are met, and it is the Plan Custodian's assessment that these conditions have been met. These PSAs can be redeemed at NAV.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

**NOTE 5 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of pooled separate accounts managed by affiliates of the Custodian. Therefore, these transactions qualify as party-in-interest transactions. Investment and administrative expenses paid by the Plan to the Custodian or its affiliates totaled \$38,256 for the year ended December 31, 2024. Certain employees of the Employer who participate in the Plan perform administrative services to the Plan at no cost to the Plan.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

**NOTE 7 - FEDERAL INCOME TAX STATUS**

The Plan has adopted a volume submitter profit sharing plan. The Internal Revenue Service (IRS) has issued an opinion letter, dated June 30, 2020, which stipulates that an employer who adopts this volume submitter plan will be considered to have a plan qualified under Section 401(a) of the Code provided all terms of the Plan are followed. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently being operated in compliance with the qualified volume submitter plan. Therefore, the Plan was qualified and the related trust is tax exempt.

**NOTE 7 - FEDERAL INCOME TAX STATUS** (Continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan did not have any uncertain tax positions as of December 31, 2024 and 2023. The Plan is subject to routine audits by taxing jurisdictions; however, management has stated that there are currently no audits for any tax periods in progress.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan provides for investments in a variety of investment alternatives offered by the Plan. In general, such investments are exposed to various risks, including interest rate, market volatility, and credit risks. Due to the level of risk associated with such investments and the level of uncertainty related to changes in the value of such investments, it is at least reasonably possible that changes in the values of the Plan investments will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.
