Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have audited the accompanying financial statements of Convergys Corporation Retiree Benefits Program, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of benefit obligations and net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in benefit obligations and net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Convergys Corporation Retiree Benefits Program's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Notes to Financial Statements

December 31, 2024 and 2023

1. Description of the Plan

General

The Convergys Corporation Retiree Benefits Program (the Plan) provides eligible retired employees with the opportunity to participate in subsidized or pension benefits to cover pre-65 medical, dental and life insurance programs of their choice for their benefit and the benefit of their dependents. A retiree's eligibility to participate in the Plan is based upon their date of hire.

Convergys Information Management Group, Inc. established The Flex Benefits Plan on January 1, 1991. Convergys Corporation (Convergys) assumed The Flex Benefits Plan on January 1, 1999, as part of its spin-off from Cincinnati Bell, Inc. Through November 30, 2010, the Flex Benefits Program covered both active and retired eligible employees of Convergys and its subsidiaries. Effective December 1, 2010, The Flex Benefits Plan was amended such that no further benefits would be provided to eligible retirees and their dependents. With the effectiveness of this amendment, benefits due to eligible retirees and dependents are provided under the Plan. As a result of this amendment, obligations for benefits to retirees and assets held in trust for retirees were transferred to the Plan.

In October 2018, Convergys was acquired by Concentrix. In connection with the acquisition, Convergys was renamed Concentrix CVG Corporation (the "Company"), the Plan Sponsor, and up until December 1, 2020, was a subsidiary of Synnex Corporation (NYSE: SNX).

On December 1, 2020, the separation of Concentrix from SYNnex Corporation was completed through a tax-free distribution of all of the issued and outstanding shares of Concentrix common stock to SYNnex stockholders. As a result of the spin-off, Concentrix became an independent public company and Concentrix common stock commenced trading on the Nasdaq Stock Market ("Nasdaq") under the symbol "CNXC".

The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). A more complete description of the Plan's provisions is contained in Summary Plan Descriptions, copies of which are available from the Company.

Administrative Expenses

Administrative expenses consist primarily of fees paid to the Plan's third-party claims administrators and benefit providers.

Funding Policy

The Company uses two Voluntary Employee Benefit Association (VEBA) trusts (the Convergys Retirees Life Insurance Trust and the Convergys Corporation Health and Welfare Trust) to fund a portion of the benefit payments of the Plan. The remaining portion of benefit payments is made from the general assets of the Company. The amount of funding to the VEBA trusts is subject to Internal Revenue Service (IRS) regulations. The Plan utilizes U.S. Bank National Association as the trustee. The Concentrix CVG Corporation Compensation and Benefits committee is responsible for the general administration of the Plan.

Benefits

Payments for medical, dental and vision benefits are funded by the Plan for certain participants depending on their location. Claims for participants in other locations continue to be provided under group insurance contracts for which the Plan funds the premium payments.

Contributions

Contributions to the Plan consist of (1) Participant contributions based on the coverage the participant has elected under the Plan, and (2) amounts the Company pays to the Plan that are in excess of the participant-directed deductions. Pursuant to the plan document, the participant contribution amount is determined at the sole discretion of the Plan Sponsor. Generally, the Plan Sponsor sets the participant premium rates annually at a level to where the Company contribution is capped at an average maximum per participant.

The funding of postretirement benefit obligations is not covered by present contribution rates. The Company intends to fund the excess of benefit obligations over net assets through future contributions.

2. Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation

Investments consist of temporary cash investments in money market funds managed by U.S. Bank National Association (U.S. Bank). Temporary cash investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an

exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

Purchases and sales of investments are recorded as of the trade date. Interest earned on investments is recorded on an accrual basis. Investment assets of the Plan are held in any of the two trusts described above.

Postretirement Benefit Obligations

The postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to employee service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current retirees of the Plan. Postretirement benefits include future benefits expected to be paid for currently retired or terminated employees and their beneficiaries and dependents.

The actuarial present value of the expected postretirement benefit obligation is determined by applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims-costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

Health care cost-trend rates, and other significant assumptions used to measure the expected cost of benefits covered by the Plan, are as follows:

Assumed health care cost-trend rates are capped for all participants.

The foregoing assumptions presume that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

Payment of Claims and Premiums

Claim payments are recorded when paid by the claims administrator. Amounts due to the claims administrator for claims that have been paid but not yet reimbursed by the Plan are

recorded as claims payable in the accompanying statement of net assets available for benefits.

Certain premiums and claims are paid from the general assets of the Company; however, all premiums and claims are recorded in the accompanying statement of changes in net assets available for benefits, regardless of whether they were paid from plan assets or from the general assets of the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in money market funds. Money market funds, like other investment securities, are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect the amounts reported in the statement of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumption processes, it is at least reasonably possible that changes in these estimates and assumptions in the near term could materially affect the amounts reported and disclosed in the financial statements.

Accounting for Medicare Subsidy

The Plan's postretirement benefits obligation does not reflect an amount associated with the Medicare subsidy allowed under the Medicare Prescription Drug Improvement and Modernization Act of 2003, as the Plan is not directly entitled to the Medicare subsidy.

Claims Incurred but not Reported

Plan obligations as of December 31, 2024 and 2023, for incurred but not reported claims, are estimated by the Plan's third-party administrators and reviewed by the Company. These amounts are paid by the Plan only if claims are submitted and approved for payment.

Subsequent Events

Management has evaluated subsequent events for the Plan through October 10, 2025, the date the financial statements were available to be issued. Management is not aware of any

subsequent events that would require recognition or disclosure in the Plan's financial statements.

3. Investments

All investment information disclosed in the accompanying financial statements, including investments held as of December 31, 2024 and 2023 and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by U.S. Bank, the trustee of the Plan in accordance with Section 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

4. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1), and the lowest priority to

unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

- Level 1: Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.
- Level 2: Inputs other than quoted prices in active markets for identical assets and liabilities that are observable, either directly or indirectly, for substantially the full term of the asset or liability. Level 2 inputs include the following:
- Quoted prices for similar assets and liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in markets that are not active
 - Observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (i.e., interest rate and yield curve quotes at commonly quoted intervals)
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means
- Level 3: Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumptions about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There were no transfers of assets within levels of the fair value hierarchy in 2024 or 2023.

The assets held in the Plan are comprised entirely of money market funds. Interest-bearing money market funds have a carrying value that approximates fair value. There have been no changes in methodologies used at December 31, 2024. The Plan's investments in money market funds have been estimated using the net asset value per share of the fund as of December 31, 2024 and 2023, based on actively quoted market prices, and are classified in Level 1 of the fair value hierarchy.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuations methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement.

5. Income Tax Status

The Retirees Life Insurance Trust and the Health and Welfare Trust funding the Plan have received an exemption letter from the IRS, dated June 19, 2002 and October 27, 1992, respectively, stating that the trusts are tax exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code (the Code) as a VEBA. The Plan and trusts are required to operate in conformity with the Code to maintain the tax-exempt status of each VEBA trust. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the related VEBA trusts are tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods pending. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

6. Priorities Upon Termination of the Plan

It is the intent of the Company to continue the Plan indefinitely; however, the Company reserves the right to terminate the Plan at any time subject to the provisions of ERISA and the Internal Revenue Code. In the event the Plan terminates, the trustee shall apply the net assets to pay any and all obligations of the Plan in an order of priority determined in accordance with ERISA, applicable regulations, and the plan document.

7. Related-Party Transactions

The Plan's assets are invested in a fund managed by the trustee of the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA.
