INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of  
the Plant Maintenance Service Corporation Retirement Plan

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

I have performed an audit of the accompanying financial statements of Plant Maintenance Service Corporation Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Plant Maintenance Service Corporation Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note E and L to the financial statements, is complete and accurate.

**Opinion**

In my opinion, based on my audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

**Basis for Opinion**

Notes to Financial Statements

NOTE A - DESCRIPTION OF PLAN

The following description of the Plant Maintenance Service Corporation Retirement Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General*

The Plan is a defined contribution profit sharing plan and 401(k) plan to cover all full-time nonunion employees of the Plant Maintenance Service Corporation ("the Company") who have at least one year of service. It is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

*Contributions*

The Company may contribute to the Plan out of profits any amount set by the Company's board of directors. The employees may elect to have the employer contribute on their behalf to the Plan, instead of including such amounts as compensation, an amount not to exceed the statutory limit. The employer will match 50% of the first 6% of the employees' elective deferral.

*Participant Accounts*

Each participant's account is credited with an allocation of (a) the Company's contribution, (b) 100% of the employee's contribution and, (c) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting*

- A. Defined Contribution Profit Sharing Plan.  
Vesting in participant accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.
- B. 401(k) Plan.  
Elective deferrals shall always be fully vested and non-forfeitable. Matching contributions are fully vested upon entering the Plan.

*Payment of Benefits*

On termination of service, due to death, disability, termination, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. The Plan allows for hardship distributions and in-service distributions if the participant has attained age 59½.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

*Forfeited accounts*

These accounts are used to reduce employer contributions and plan expenses in accordance with the Plan. The Plan used \$6 in forfeitures to offset plan expenses during the year ended December 31, 2024. The forfeited non-vested balance at December 31, 2024 was \$9,648. During the year ended December 31, 2024, the Plan had additional forfeitures of nonvested accounts of \$0.

*Date of Management's Review*

Subsequent events were evaluated through October 13, 2025, which is the date the financial statements were available to be issued.

*Estimates*

The preparation of the financial statements in conformity with generally accepted accounting principles requires the management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Basis of Accounting*

The financial statements of the Plan are prepared using the accrual method of accounting.

Separate account investments are record-kept using unit values.

The pooled separate accounts are invested in mutual funds at Net Asset Value ("NAV"). The allocation of these funds is based on the unit and unit value for each product and plan invested in the pooled separate account.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Statement of Changes in Net Assets Available for Benefits is prepared on a contract value basis.

*Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. Shares of pooled investment accounts are valued at the net asset value of shares held by the Plan at year-end. See Note E for valuation of the Plan's guaranteed investment contracts.

Purchases and sales of securities are recorded on a trade-date basis.

*Payment of Benefits*

Benefits are recorded when paid.

*Excess Contributions Payables*

Amounts payable to participants at December 31, 2024, and 2023 were \$0 and \$0, respectively for contributions in excess of amounts allowed by the IRS. The excess contributions are recorded as a liability, with a corresponding reduction to contributions for each year. The Plan distributed the excess contributions prior to March 15, of the following year.

*Late Contributions*

As of the date of the financial statements, the Company had delinquent employee contribution that totaled \$2,160 for the year ended December 31, 2024, due to the Company not properly auto enrolling employees into the plan. The Company is currently working with its Administrator to provide corrective action in the form of a qualified nonelective contribution in the 2025 Plan year.

The Company had one delinquent employee contribution that totaled \$3,080 for the year ended December 31, 2023, due to the Company not withholding retirement contributions on a bonus. The Company partially corrected \$1,296 of this contribution in 2024 and remaining \$1,784 is pending corrective action in Department of Labor's Voluntary Fiduciary Correction Program as of the date of these financial statements.

*Operating Expenses*

All expenses of maintaining the Plan are paid by the Company (see note K) or the Plan (see note M).

NOTE C - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value or contract value in the accompanying statements of net assets available for benefits. The method used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist

of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

The pooled separate accounts are based on quoted net asset values of the shares held by the Plan at year end.

During 2024, the net change in fair value of mutual funds and guaranteed investment contracts (including investments bought, sold, and held during the year) as determined by NAV was an increase of \$659,930.

NOTE E – INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan holds investment contracts that meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The Ameritas Guaranteed Account earns a declared interest rate for new deposits in each calendar quarter. Subsequent to the initial guaranteed period, a renewal guarantee is applied for deposits made in the calendar quarter in all prior years. For example, deposits made in the first quarter of 2024 will continue to receive the first quarter declared rate until December 31, 2024, at which time a renewal rate will apply

for the period January 1, 2025 until December 31, 2025. Similarly, deposits made in the second quarter of 2024 will continue to receive the second quarter declared rate of 2024 until March 31, 2025 at which time a renewal rate will apply for the period April 1, 2025 until March 31, 2026. Subsequent annual renewal rates will continue in future years.

Interest rate guarantees of the Ameritas Guaranteed Account are backed by assets held by the Ameritas general account. Credited rates are set based on yields earned on new purchases of fixed income securities for the general account for new deposits each quarter. Subsequent renewal rates are based on the investment performance of the general account at the time of renewal. Credited rates are guaranteed for the duration of the guaranteed period, and do not vary with the subsequent performance of assets of the general account which back these guarantees.

The contract value of funds held in the Ameritas Guaranteed Account generally represents principal plus accrued interest.

The weighted average interest crediting rate is the weighted average of all new and renewal rates of the contract for each calendar quarter. These rates are guaranteed for the entire duration of the guaranteed period and do not vary with the subsequent performance of assets of the Ameritas general account which back these guarantees.

Certain events may limit the ability of the Plan sponsor and/or Plan participants to transact at contract value with Ameritas. Examples of these events would include (but would not be limited to) premature termination of this contract and termination of the retirement plan. In these examples, the contract value could be reduced by any applicable surrender charges upon distribution of contract's funds.

Under no event may Ameritas terminate this contract and settle at an amount different from contract value.

The Ameritas Life Insurance Corp. is currently rated A+ (Strong) by Standard & Poor's and rated A (Excellent) by the A.M. Best Company.

The average yield for the Plan for the period January 1, 2024 to December 31, 2024 is 2.47%. The average yield for 2023 is 1.77%.

The weighted average interest crediting rate, as of December 31, 2023, is 3.6% and for December 31, 2023 is 3.67%.

NOTE G - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts. Any unallocated assets of the Plan shall be allocated to participants' accounts and distributed in a manner which is consistent with the Plan's distribution provisions.

NOTE H - TAX STATUS

The Company adopted an IRS preapproved plan on March 29, 2022, and an approved modification dated October 2024, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.
