INDEPENDENT AUDITORS' REPORT

To the Board of Trustees
Teamsters' Industry Welfare Fund

Opinion

We have audited the accompanying financial statements of Teamsters' Industry Welfare Fund (the "Fund"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and benefit obligations of the Fund as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF THE FUND AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following description of the Teamsters' Industry Welfare Fund (the "Fund") is provided for general information purposes only. Participants should refer to the Summary Plan Description for more complete information. The Fund was formed on June 1, 1953 by an Agreement and Declaration of Trust (Trust Agreement) to provide welfare benefits to eligible employees and families of eligible employees of participating employers. The Agreement and Declaration of Trust was most recently amended and restated on August 19, 2014. Contributions to the Fund are made by employers on the basis of agreements between various employers and local unions affiliated with Joint Council of Teamsters No. 40 of the International Brotherhood of Teamsters. The agreements provide, among other things, for employers of union members to contribute various amounts for each hour or period worked. Also, the agreements provide for elective union member contributions to either achieve eligibility, upgrade benefits, or extend coverage under the Fund pursuant to the Consolidated Omnibus Budget Reconciliation Act (COBRA).

The Fund has a fully insured agreement with the UPMC Health Plan to provide hospital, medical and surgical benefits. The renewal for the year ending December 31, 2025 provides for a 3% increase in premiums. The Fund is self-insured for vision, dental, disability, prescription drug and death benefits for eligible participants and their dependents. The Fund provides dental and vision benefits through access to the Delta Dental and VSP Vision Care networks, respectively. Post-retirement benefits are not provided under the Fund.

The Summary Plan Description was restated effective May 1, 2025. The restatement incorporates amendments from recent years, increases the maximum future benefits that can be accumulated by \$3,660 per participant, increases the annual maximum for dental benefits and increases the frame and elective contact lens allowances.

The Board of Trustees serves as the Fund administrator and controls and manages the operation and administration of the Fund. The Trustees do not receive compensation from the Fund. The Fund has an agreement with the Benefit Fund Service Company, which collects contributions, maintains eligibility records, and processes the payment of certain claims of the Fund in return for an administrative fee.

The Fund is subject to the provisions of the Employee Retirement Income Security Act of 1974 and is intended to be tax exempt under Section 501(c)(9) of the Internal Revenue Code.

Basis of Accounting - The financial statements of the Fund are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates - The preparation of financial statements in conformity with U.S. GAAP requires the use of estimates and assumptions that affect the reported amounts of assets and the actuarial present value of accumulated fund benefits at the dates of the financial statements and the reported increases in net assets available for benefits and benefit obligations during the reporting periods. Actual results could differ from the estimates.

The actuarial value of benefit obligations is prepared based on certain assumptions and employee demographics. Due to uncertainties inherent in the estimation and assumption process, it is at least reasonably possible that changes in these estimates and assumptions in the near term could be material to the financial statements. Additionally, the Fund's assets are comprised of various investment securities, which are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the near term could materially affect the net assets available for benefits.

Cash - The Fund maintains, at financial institutions, cash which may at times exceed federally insured amounts.

Investment Valuation and Income Recognition - Investments are reported at fair value. Purchases and sales of securities are reflected on a trade date basis. Income from investments is recorded when earned. The net appreciation or depreciation of the fair value of investments includes realized and unrealized gains and losses. Realized gains and losses on sales of securities are based on the specific cost of the security sold. Unrealized gains and losses are determined by the change in the current value of investments from the beginning of the year, if held for the entire year, or from the date of purchase to the end of the year. Fund investment policy does not permit investment in derivative instruments, the buying of securities on margin, short selling of securities, or the buying and selling of put and call options. The Fund did not hold any such prohibited investments as of December 31, 2024 or 2023.

U.S. GAAP establishes a framework for measuring the fair value of financial instruments, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Fund has the ability to access.
- Level 2 Inputs, other than quoted prices in active markets, that are observable either directly or indirectly.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Cash and Cash Equivalents: Valued at quoted market prices reported on the active markets in which the individual securities are traded (level 1 inputs).

Agency Bonds: Valued based on yields currently available on comparable securities of issuers with similar credit ratings (level 2 inputs).

Treasury Notes: Valued at the closing price reported on the active market on which the individual securities are traded (level 1 inputs).

Mutual Funds: Valued at the closing price reported on the active market on which the individual securities are traded (level 1 inputs).

There have been no changes in the methodologies used at December 31, 2024 or 2023. The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Trustees believe the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting dates.

Receivables - The Fund has receivables principally for monthly contributions due from employers as well as prescription rebates. A valuation allowance is provided, if necessary, for estimated credit losses. The allowance is determined based on historical write-off experience, how recently and how frequently payments have been received, the financial position of the participating employer, and specific consideration of accounts for which collection is doubtful; uncollectible accounts are written off and charged against the allowance. All of the December 31, 2024 and 2023 receivables were fully collected; accordingly, valuation allowances were not provided at either of the reporting dates.

Receivable from Teamsters Combined Fund LLC - Contributions for the Teamsters' Industry Welfare Fund and the Teamsters Construction and Miscellaneous Pension Fund are received by Teamsters Combined Fund LLC, which is also administered by Benefit Fund Services Company, and are periodically transferred to the respective funds. The receivable from the Teamsters Combined Fund LLC represents Teamsters' Industry Welfare Fund contributions received by the Teamsters Combined Fund LLC in excess of funds transferred to the Teamsters' Industry Welfare Fund. This excess was transferred to the Fund shortly after year end.

Due to Other Funds - Participating employers periodically remit amounts to the Fund which should have been sent to other funds. The Fund records these remittances as a liability pending remittance of the cash to the other fund.

Estimated Future Benefits Liability for Participants' Accumulated Eligibility - The Fund has received contributions that provide participants with coverage in periods subsequent to the end of its annual reporting period. The estimated cost of this coverage, computed by the Fund's consulting actuary utilizing accepted actuarial principles, on the basis of earned accumulated eligibility, is recognized as a benefit obligation of the Fund.

The \$3,660 increase in the maximum future benefit that can be accumulated resulting from the May 1, 2025 amendment of the Summary Plan Description served to increase the benefit obligation by approximately \$655,000 effective May 1, 2025.

Estimated Liability for Incurred But Not Reported Claims - The estimated liability for incurred but not reported vision, dental and prescription drug claims is computed by the Fund's consulting actuary, utilizing accepted actuarial principles, on the basis of the historical experience relative to the time lag between incurrence of claims and the reporting of such claims to the Fund.

Contribution Income - Employer contributions are recognized as revenue when earned by participants on the basis of hours worked. Employee contributions, received twice a year for optional upgrades of benefits and throughout the year for COBRA coverage, are recognized as revenue as received.

Benefits - Insurance premiums are expensed in the period to which coverage applies. Claims for self insured benefits are recorded as incurred and are net of prescription rebates, which are recorded as earned.

Professional Fees and Administrative Expenses - Professional fees and administrative expenses are expensed as incurred.

Subsequent Events - Management has evaluated subsequent events through October 7, 2025, the date which the financial statements were available to be issued.

Substantially all of the net appreciation in the fair value of investments for the years ended December 31, 2024 and 2023 relates to the fair value of investments measured by quoted prices in active markets.

3. EMPLOYER CONCENTRATION

Approximately 40% and 36% of contributions for the years ended December 31, 2024 and 2023, respectively, were attributable to three employers.

4. SELF-INSURED CLAIMS AND RELATED MATTERS

Claims for the self-insured benefits are net of prescription rebates, which were \$508,461 and \$570,460 for the years ended December 31, 2024 and 2023, respectively. At any point in time, there are claims outstanding as a result of patients or providers not submitting documentation regarding services provided and the related expense. As of December 31, 2024 and 2023, respectively, the Fund recorded estimated liabilities of \$28,500 and \$18,300, respectively, for claims incurred but not reported. The incurred but not reported claims were determined based on a runout period of actual claims and a completion factor assigned to these claims by the Fund's actuary.

5. INCOME TAX STATUS

The Fund requested and received tax-exempt status under Section 501(c)(9) of the Internal Revenue Code (IRC). In the determination letter dated March 22, 1955, the Internal Revenue Service (IRS) stated that the Fund, as then designed, was exempt from Federal income tax. The IRS most recently confirmed the exempt status of the Fund on October 26, 1977, subsequent to an amendment. The Fund has been further amended since that time for changes required by ERISA and other regulations. The Fund administrator believes that the Fund is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Fund's financial statements.

U.S. GAAP prescribes a comprehensive model for the financial statement recognition, measurement, presentation, and disclosure of uncertain tax positions taken or expected to be taken in income tax returns. The Trustees believe that there is no liability related to uncertain tax positions at December 31, 2024 or 2023. The Fund is no longer subject to tax examinations for the years before 2021.

6. FUND TERMINATION

While the Board of Trustees intends to continue the Fund indefinitely, it reserves the right to modify, amend or terminate all or part of the Fund at any time and cancel all or part of the coverage and benefits under the Fund for current and future participants, subject to the terms of applicable collective bargaining agreements. In no event shall the Board of Trustees cause any portion of the Fund's assets to be used for purposes other than for the exclusive benefit of participants and their beneficiaries (including payment of reasonable expenses for administering the Fund), nor may any portion of the Fund's assets become the property of the Board of Trustees. In the event that the Board of Trustees terminates the Fund, all eligible expenses for benefits that were earned and incurred by the Fund participants prior to the termination of the Fund would be a liability of the Fund on that date.
