Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Premier Home Health Care Services, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

1. Plan Description

The following description of the Premier Home Health Care Services, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution 401(k) plan covering non-union employees of Premier Home Health Care Services, Inc. and its wholly-owned subsidiaries (the “Companies” or “Plan Sponsor” or “Employer”), who are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Initial entry date into the Plan is permitted on the first day of each month after the participant has completed the necessary eligibility requirements. The Administrative Committee is responsible for oversight of the Plan, including the appropriateness of the Plan’s investment offerings and monitoring investment performance.

Contributions

Each year, participants may contribute up to 100% of their annual eligible compensation to the Plan on a pre-tax basis, up to a maximum allowed by the Internal Revenue Code (“IRC”). Participants are also permitted to make contributions as “Roth” contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Companies may make discretionary qualified nonelective contributions only to nonhighly compensated employees who had at least 500 hours of service during the Plan year. During the years ended December 31, 2024 and 2023, the Company elected not to make any employer contributions.

Participant Accounts

Each participant’s account is credited with the participant’s contribution. Allocation of the discretionary employer matching contribution is based on participant compensation. Allocation of the Plan earnings is based on participant earnings, account balances, or specific participant discretionary transactions, as defined in the Plan document. The benefit to which a participant is entitled is based on account balances that can be provided from the participant’s vested account.

1. Plan Description (*continued*)

Vesting

Participants are immediately vested in their voluntary contributions and rollover contributions, plus actual earnings thereon. Vesting in Company discretionary contributions plus actual earnings thereon are based on years of continuous service. Such contributions, if any, vest in accordance with the Plan's vesting schedule wherein after three years of service and a minimum of 1,000 hours per year, a participant is 100% vested.

Forfeitures

If a participant terminates their employment with the Companies, the non-vested contribution plus allocated earnings thereon may be used to reduce future employer contributions. Any remaining forfeitures not used to reduce employer contributions may be used to reduce administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited account balances held in non-participant directed accounts totaled \$15,034 and \$36. During 2024 and 2023, the Plan did not use forfeited amounts to reduce Company contributions or Plan expenses.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions to any of various investment options offered by the Plan.

Notes Receivable from Participants

Participant employees are allowed to borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the outstanding balance of any existing loans, or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with prevailing rates as determined by the plan administrator. Interest is charged at prime plus 1% at the date the loan is initiated. Loan terms range from 1 to 5 years or up to 10 years for the purchase of a participant's primary residence. Only two loans are permitted at a time. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Benefit payments are made upon normal retirement, death, disability or termination of service. The benefits are paid in a lump-sum payment or distributed in installments in accordance with the Plan document. In addition, the Plan allows hardship withdrawals, and if the participant has reached 59 ½, in-service distributions are also permitted. The Plan has a mandatory cash out provision if the participant terminates employment and the vested account balance does not exceed \$7,000.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value except for the investment in the custodial guaranteed interest contract. The custodial guaranteed interest contract is valued at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Purchases and sales are recorded on a trade-by-trade basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participant

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded, when a distributable event occurs.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan Sponsor and are excluded from these financial statements. Administrative fees for transaction charges are paid by the Plan. Investment related expenses are included in net appreciation in value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 14, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments held and notes receivable from participants held at December 31, 2024 and 2023, and interest and dividends, net appreciation in value of investments, and interest income on notes receivable from participants for the years then ended was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company, a qualified institution.

4. Fair Value Measurements

The Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC"), 820, "Fair Value Measurements", establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

4. Fair Value Measurements *(continued)*

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust funds: The fair value of the common/collective trust funds is based on the daily NAV of the units held by the Plan at year end. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value investments held by the fund less liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There are no unfunded commitments or redemption restrictions as of December 31, 2024.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Custodial Guaranteed Interest Contract

The Principal Fixed Income Guaranteed Option (the "PFIGO") is a guaranteed general account backed custodial guaranteed interest contract issued by Principal Life Insurance Company. Because the PFIGO is benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the PFIGO. Contract value represents contributions, plus earnings, less participant withdrawals and administrative expenses.

A rate of interest is contractually guaranteed by Principal Life Insurance Company and is credited to participant's account balances. The rate is reset on a semiannual basis.

5. Custodial Guaranteed Interest Contract (*continued*)

Benefit payments are made at contract value (i.e. no market value adjustments or surrender charge adjustments) for plan benefit events including: retirement, death, disability, termination of employment, loans, withdrawals, or Plan termination. An employer level liquidation or employer initiated transfer of the Plan's interest in the PFIGO will be subject to either a 12-month advance notice or a 5% surrender charge, whichever the Employer chooses. Notification of a plan's intent to terminate its interest may be revoked within 90 days of the receipt of such notice, after which time, the notice becomes irrevocable. A 5% surrender charge will also apply if the cumulative percentage of participant transfers from the PFIGO exceeds 20% of the Plan's interest in the contract during the 12-month period immediately preceding the employer-level surrender of the Plan's interest in the contract. If this scenario occurs, the surrender charge will be billed to the Employer. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

The credit risk of the issuer, Principal Life Insurance Company, was evaluated by nationally recognized statistical rating agencies as follows: Moody's Investors Service (A1 as of June 2025), Standard and Poor's (A+ as of April 2025), A.M. Best Company (A+ as of April 2025), and Fitch Ratings (AA- as of May 2025).

6. Party-In-Interest Transactions

Certain investments of the Plan are managed by Principal Trust Company, the trustee of the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain administrative functions are performed by officers or employees of the Companies. No officer or employee receives compensation from the Plan.

7. Plan Termination

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

8. Tax Status

The Internal Revenue Service (“IRS”) has determined and informed the volume submitter plan document preparer by an opinion letter dated June 30, 2020 that the Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended, the plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more than likely would be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

9. Prohibited Transactions

For the 2024 Plan year, the Company failed to remit to the Plan certain participants’ contributions and loan repayments within the period described by the Department of Labor regulations. Delays in remitting these amounts to the Plan were due to an administrative oversight. The Company made the necessary corrections during 2025 to satisfy both the Department of Labor and IRS guidance for this matter.

10. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
