### NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

#### NOTE 1 – DESCRIPTION OF THE PLAN

The following brief description of the Advanced Systems Group, LLC (the Plan Sponsor) 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering all employees of the Plan Sponsor who have completed three months of service and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan has no minimum age requirement, except that set forth by ERISA. The ERISA minimum age requirement is 21.

**Contributions:** Upon eligibility, participants are automatically enrolled in the Plan at a 3% deferral rate, unless an election to contribute a different amount, or not to participate, is made. Each year, participants may contribute up to 100% of pretax annual compensation as defined by the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers 31 mutual funds as investment options for participants. Contributions are subject to certain statutory limitations.

**Participant Accounts:** Each participant's account is credited with the participant's contribution and an allocation of the Plan's earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled are the benefits that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their deferred salary contributions plus actual earnings (losses) thereon.

**Payment of Benefits:** Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account or annual installments over a variety of periods, which the participant may choose. For termination of service due to other reasons, a participant may receive the value of the participant's vested interest in their account as a lump-sum distribution. An active employee may elect to receive an in-service distribution either upon attaining age 59½ or through a hardship withdrawal.

**Forfeitures:** Although participants are immediately fully vested, all the corrections, uncashed checks, and dividends are posted as forfeitures. As of December 31, 2024 and 2023, forfeitures from nonvested accounts totaled \$10,430 and \$5,309, respectively. These accounts will be used to reduce future plan expenses.

#### NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The significant accounting policies followed by the Plan are reflected below.

**Basis of Accounting:** The financial statements of the Plan were prepared under the accrual method of accounting.

**Use of Estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (US GAAP) requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

**Fair Value Measurement:** The Accounting Standards Codification establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

The three-tier fair value hierarchy includes the following categories:

- *Level 1* – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.
- *Level 2* – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following.
  - Quoted prices for similar assets and liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in markets that are not active;
  - Observable inputs other than quoted prices that are used in the valuation of the asset or liability (e.g., interest rate and yield curve quotes at commonly quoted intervals); and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- *Level 3* – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management’s own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Further, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- *Mutual Funds* – Valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. Mutual funds are classified as Level 1 measurements.

The Plan Sponsor’s financial instruments and other accounts that are subject to fair value measurement and/or disclosure are summarized in Note 3.

**Benefit Payments:** Benefits are recorded when paid.

**Subsequent Events:** The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

#### **NOTE 3 – FAIR VALUE MEASUREMENTS (CONTINUED)**

Gains and losses (realized and unrealized) included in changes in net assets available for plan benefits for the year ended December 31, 2024 are reported under net appreciation in fair value of investments.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, the Plan had no Level 3 investments.

#### **NOTE 4 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants will become 100% vested in their employer contributions, if any.

#### **NOTE 5 – TAX STATUS**

The Plan has adopted the Capital Group Retirement Plan Services Defined Contribution Pre-Approved Plan. The Internal Revenue Service (IRS) informed Capital Group Retirement Plan Services by a letter, dated June 30, 2020, that its Volume Submitter Plan was designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the adoption, the Plan Administrator believes that the Plan was designed and is currently being operated in compliance with the applicable requirements of the IRC and that the Plan is qualified and the related trust is tax exempt.

US GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

#### **NOTE 6 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain investments of the Plan are shares of mutual funds managed by Capital Bank and Trust Company. Capital Bank and Trust Company is the service provider, and therefore, these qualify as party-in-interest transactions. Fees paid by the Plan for administrative services amounted to \$81,957 for the year ended December 31, 2024. Fees paid by the Plan for the investment management services are included under net appreciation in fair value of investments.

The Plan Sponsor provides certain accounting and administrative services to the Plan for which no fees are charged. These expenses constitute exempt party-in-interest transactions under ERISA.

#### **NOTE 7 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

The Plan is required to disclose significant concentrations of credit risk regardless of the degree of such risk. As of December 31, 2024 and 2023, the financial instruments that potentially subject the Plan to a concentration of credit risk consist principally of cash and investments from participants.
