## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 (AUDITED) AND 2023 (COMPILED)

---

### 1. DESCRIPTION OF PLAN

The following brief description of Performance Systems Development of New York, LLC 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan available to all employees of Performance Systems Development of New York, LLC (the Company) who meet certain eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Eligibility**

Employees are eligible to begin making elective deferrals upon commencement of employment. Employees are eligible to receive employer contributions after attaining one year of service. The Plan entry date is the first day of the month coinciding with or next following the date the eligibility requirements are satisfied.

#### **Contributions**

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 3% of eligible pretax compensation. Participants may contribute a percentage of annual compensation, as defined in the Plan, on a pretax basis or Roth after tax basis (collectively, Elective deferrals), not to exceed the maximum contribution limits established by the Internal Revenue Code (IRC). There is no auto-increase provision included within the Plan. Participants may complete a salary deferral agreement to elect an alternative deferral amount or to elect not to defer under the Plan in accordance with the deferral procedures of the Plan.

The Plan also allows for discretionary matching contributions to be determined annually by Plan management. In 2024, Company matching contributions amounted to \$228,779.

Additional profit-sharing contributions may be made at the option of the Company's management. Contributions are subject to certain limitations. The Company did not make a profit-sharing contribution in 2024.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution, the employer's contributions, and Plan earnings/losses on all contributions. Allocations of earnings/losses and administrative expenses are based on account balances, according to specific terms provided by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## 1. DESCRIPTION OF PLAN(Continued)

### **Vesting**

Participants are immediately fully vested in their voluntary and profit-sharing contributions to the Plan. Employer matching contributions made by the Company are vested at the following percentages:

Less than 3	0%
3 or more	100%

### **Payment of Benefits**

On termination of service due to death, disability or retirement, a participant or beneficiary may elect to receive an amount equal to the value of the participant's vested interest in his or her account as either a lump-sum amount or installment payments.

Benefit payments from the Plan will be made if the balance is less than \$5,000 and the participant does not direct the Plan otherwise.

Hardship withdrawals are permitted by the Plan in the event of immediate financial need. Participants may withdraw elective deferrals, rollover contributions, and fully vested employer contributions plus their respective earnings.

In-service withdrawals are permitted for participants that are age 59 ½ or older.

### **Investment Options**

Investments are held within various investment options maintained by Ascensus Trust Company. Contributions are invested, at the discretion of the participant, in one or a combination of available investment options.

### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled to \$25,754 and \$2,536, respectively. These amounts are used to reduce future Company contributions. Company contributions were reduced by \$394 through the application of forfeitures in 2024.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors and qualified institutions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES(Continued)

### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the accompanying financial statements.

### **Payment of Benefits**

Benefit payments to participants are recorded when paid.

### **Administrative Expenses**

At the Company's discretion, administrative expenses of the Plan may be paid out of the Plan's assets or may be paid by the Company. Expenses paid by the Company may include expenses relating to the function of the Plan, including recordkeeping, accounting, legal, consulting, or other administrative expenses. Investment management fees are charged directly against the related investments of the Plan. Expenses related to distributions are deducted from those participant accounts as transactions occur.

### **Fair Value Measurement – Definition and Hierarchy**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

A description of where the Plan's investments fall within the ASC 820 hierarchy is provided in Note 4. There were no transfers between levels of the fair value hierarchy during 2024 or 2023.

### **Estimates**

The preparation of financial statements in accordance with GAAP requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### 3. CERTIFIED INVESTMENT INFORMATION

The Plan administrator has received a certification from Ascensus as agent for Ascensus Trust Company, the trustee of the Plan, that states that the following information is complete and accurate as of and for the year ended December 31, 2024.

### 4. FAIR VALUE MEASUREMENTS

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money Market Fund:* valued at cost plus accrued interest, which approximates fair value.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 5. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Ascensus Trust Company, which acts as the trustee as defined by the Plan. Ascensus, LLC is the Plan's third-party administrator. Transactions between these companies and the Plan qualify as party-in-interest transactions.

## 6. INCOME TAX STATUS

The Plan adopted a pre-approved plan offered by Ascensus, LLC. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and the related trust is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## 7. CONTINGENCY

As of the date of the Plan's 2024 financial statements, the nondiscrimination testing for the year ended December 31, 2024 has not been completed. At this time, it is not possible to estimate with any certainty the results of this testing, the timing and extent of any corrective actions that may be required, or the amount of liability, if any, of the Plan. If and when it is possible to make a reasonable estimate of the Plan's liability in these matters, the Plan will make an appropriate provision in its financial statements.

## 8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.
