## **INDEPENDENT AUDITOR'S REPORT**

To the Trustees of the  
Mallory Safety and Supply Employees Retirement Plan  
Longview, Washington

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

I have performed an audit of the accompanying financial statements of Mallory Safety and Supply Employees Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years ended December 31, , and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the 2024 and 2023 audits of Mallory Safety and Supply Employees Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ## **Basis for Opinion**

I conducted my audits in accordance with auditing standards generally accepted in the United States of America. My responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of my report. I am required to be independent of Mallory Safety and Supply Employees Retirement Plan and to meet my other ethical responsibilities in accordance with the relevant ethical requirements relating to my audits. I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my ERISA Section 103(a)(3)(C) audit opinion on the 2024 and 2023 financial statements.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Mallory Safety and Supply Employees Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audits of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of my report, my objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes my opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, I:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. - Conclude whether, in my judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Mallory Safety and Supply Employees Retirement Plan's ability to continue as a going concern for a reasonable period of time.

My audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

I am required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that I identified during the audits.

#### **Other Matters - Supplementary Schedules Required by ERISA**

The 2024 and 2023 supplementary schedules, Form 5500 - Schedule H, Line 4i – Schedule of Assets (Held at End of Year) and Form 5500 - Schedule H, Line 4a - Schedule of Delinquent Participant Contributions are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplementary schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplementary schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming my opinion on the supplementary schedules, I evaluated whether the supplementary schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Mallory Safety and Supply Employees Retirement Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### *General*

The Plan, established on January 1, 2011, is a defined contribution plan covering substantially all employees of Mallory Safety and Supply, LLC (the “Company” or “Plan Sponsor”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was last amended on April 28, 2022.

#### *Eligibility*

All non-excluded employees of the Company are eligible to participate in the Plan. In order to be eligible to participate in the Plan, employees must be twenty-one years or older and have completed six months of service. Once eligibility requirements are met, participants can enter the Plan in January or July.

#### *Contributions*

The Plan provides for pre-tax participant contributions up to the amount permitted by law, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contributions plans. The Company also has the option to make a discretionary non-matching contribution, as determined by the Company’s Board of Directors. Employer contributions are made in cash. Contributions are subject to certain limitations. The employee discretionary matching contribution for 2024 and 2023 was 50% of participant contributions up to 3% of annual compensation. The Company made discretionary matching contributions for years ending December 31, 2024 and 2023 of \$475,617 and \$424,488, respectively.

#### *Participant Accounts*

Each participant’s account is credited with the participant’s contribution as well as an allocation of (a) the Company’s contribution and, (b) Plan earnings or losses. Forfeited balances of terminated participants’ non-vested accounts can be used to restore forfeitures, to reduce future Company contributions, or pay Plan expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

#### *Vesting*

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s discretionary matching contributions plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

### NOTE 1. DESCRIPTION OF THE PLAN (Continued)

#### *Investment Options*

Upon enrollment in the Plan, participants may direct the custodian of the Plan as to the investment of their account balances in accordance with guidelines established by the Plan.

#### *Participant loans*

Notes receivable from participants consisted entirely of loans to participants. Participants may borrow from their fund account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate based on the Prime rate + 1% per year, at the time of the loan application. Principal and interest are paid ratably every pay period. At December 31, 2024 and 2023, the interest rates on notes receivable from participants ranged from 4.25% to 9.50%, for both years. As of December 31, 2024 and 2023, notes receivable from participants were \$135,088 and \$79,325, respectively.

#### *Payment of Benefits*

Distribution of the vested portion of a participant's account will occur upon the participant's termination, death, disability, hardship withdrawal or retirement, as defined in the Plan. A participant is entitled to receive a lump sum payment in an amount equal to the vested value of their account.

#### *Forfeitures*

Forfeitures are used to pay plan administrative expenses or to offset the employer's contribution. For the years ending December 31, 2024 and 2023, there were forfeitures of terminated participants' non-vested accounts of \$9,781 and \$14,187, respectively. As of December 31, 2024 and 2023, forfeitures available to reduce future Company contributions, or pay Plan expenses totaled \$2,428 and \$4,135, respectively. For the years ending December 31, 2024 and 2023, \$11,596 and \$19,714, respectively, of forfeitures were used to pay administrative expenses.

### NOTE 2. SUMMARY OF ACCOUNTING POLICIES

#### *Basis of Accounting*

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

#### *Investment valuation and income recognition*

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. Shares of mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

#### *Payment of Benefits*

Benefits are recorded when paid.

#### *Administrative Expenses*

Plan administrative expenses may be paid by either the Plan or the Company on a discretionary basis.

#### *Use of Estimates*

The preparation of financial statements in conformity with generally accepted accounting principles (GAAP) requires the Plan to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates.

#### *Credit risk*

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### *Plan Termination*

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### **NOTE 3. INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S CUSTODIAN**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Matrix Trust Company, the Custodian, held the Plan's investments as of December 31, 2024 and 2023. Accordingly, Matrix Trust Company has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the information reflected on the schedule of Form 5500 - Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024.

### **NOTE 4. FAIR VALUE MEASUREMENTS**

FASB ASC 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of fair value hierarchy are described as follows:

Level 1: Inputs using the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

### NOTE 4. FAIR VALUE MEASUREMENTS (Continued)

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of the unobservable inputs.

Following is a description of the valuation methods used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investments* – Valued at the quoted prices in active market of shares held by the Plan at year-end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### NOTE 5. TAX STATUS

The Internal Revenue Service has determined by letter dated March 31, 2014, that the adopted prototype plan is qualified under the appropriate sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC and that the Plan is qualified and the related trust is tax-exempt.

### **NOTE 5. TAX STATUS (Continued)**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the Department of Labor. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, no uncertain positions are taken or are expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for the years prior to December 31, 2021.

### **NOTE 6. DUE TO PLAN SPONSOR**

During the year ended December 31, 2020, the Plan sponsor remitted participant loan payments twice. These over-remitted amounts in the amount of \$1,929 are due back to the Plan sponsor and are included in the accompanying Statement of Net Assets Available for Benefits.

### **NOTE 7. EXCESS CONTRIBUTIONS**

During the years ended December 31, 2024 and 2023, there were excess contributions remitted to the Plan of \$-0- and \$3,172, respectively.

### **NOTE 8. PROHIBITED TRANSACTIONS**

During Plan years ending 2014 through 2020, the Plan experienced delays in remitting participant contributions and missed deferrals withheld from employees' wages to the Plan's trust. The total amount of delinquent contributions and deferrals was \$118,170. As of December 31, 2024, \$110,471 of these amounts have been remitted to the Plan. The remaining \$7,699, has not been remitted and is recorded in employer corrective contribution receivable in the Statement of Changes in Net Assets Available for Benefits.

The untimely remittance of participant contributions and missed deferrals constitutes nonexempt prohibited transactions under the Employee Retirement Income Security Act of 1974 (ERISA) and the Internal Revenue Code.

Pursuant to the Department of Labor's instructions for Schedule H, Line 4a – Schedule of Delinquent Participant Contributions, the entire amount of \$118,170 is reported as delinquent contributions until the failure is fully corrected, including the payment of lost earnings. Accordingly, although a majority of the contributions have been remitted, the total amount remains reportable until full correction is completed. These transactions are therefore reported as delinquent and pending correction.

### **NOTE 8. PROHIBITED TRANSACTIONS (Continued)**

The Plan Sponsor is actively working to resolve these delinquencies and is considering submission of a correction application under the Department of Labor's Voluntary Fiduciary Correction Program (VFCP) and the Internal Revenue Service (IRS) Employee Plans Compliance Resolution System (EPCRS). This process will include payment of lost earnings and any applicable excise taxes.

The Plan Sponsor has implemented measures to enhance internal controls and procedures to ensure timely remittance of participant contributions and deferrals going forward.

### **NOTE 9. MISAPPLIED CONTRIBUTIONS**

During the year ended December 31, 2024, management identified instances in which certain employee deferrals were incorrectly applied to outstanding participant loan balances rather than being allocated to the participants' elective deferral accounts as intended.

During the year ended December 31, 2023, management identified certain employee deferral and employer contribution amounts that were misapplied to participant accounts by the Plan's recordkeeping system. The errors primarily related to contributions that were posted to incorrect participant accounts.

Upon discovery, management, in coordination with the Plan's third-party administrator, performed a detailed review of all affected transactions and initiated corrective procedures in accordance with the Department of Labor's VFCP and the IRS EPCRS.

The Plan sponsor is in the process of reallocating contributions to the proper participant accounts and calculating any associated lost earnings due to the delays in crediting the affected accounts.

The misapplications did not have a material effect on the total Net Assets Available for Benefits as of December 31, 2024 and 2023. Any required adjustments or corrective contributions will be recorded in the period they are finalized.

As of December 31, 2024 and 2023, the net amounts of \$3,174 and \$2,106, respectively, related to these corrections are included in the accompanying Statement of Changes in Net Assets Available for Benefits as part of Employer corrective contribution receivable and Distributions payable for amounts that were over- or under-applied.

### **NOTE 10. SUBSEQUENT EVENTS**

Management has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.
