The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of **CCL Label de Puerto Rico, Inc. Retirement & Savings Plan** financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note (3) to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of **CCL Label de Puerto Rico, Inc. Retirement & Savings Plan** and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about **CCL Label de Puerto Rico, Inc. Retirement & Savings Plan's** ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

Other Matter - Supplemental schedules required by ERISA

The supplemental schedule, schedule H - Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

(1) Description of the Plan:

The following description of the CCL Label de Puerto Rico, Inc. Retirement & Savings Plan (“the Plan”) provides only general information. Participants should refer to the Plan Agreement for a complete description of the Plan’s provisions.

(a) General -

The Plan is a defined contribution profit sharing plan with cash or deferred arrangement, which became effective on January 1, 1997. The Plan was created for the purpose of providing additional incentive and retirement, death, and disability security for employees of CCL Label de Puerto Rico, Inc. (“the Plan Sponsor”) eligible to participate in the Plan. The Plan encourages and assists employees in adopting a regular savings program by means of payroll deductions through a plan that qualifies under the applicable laws of the Commonwealth of Puerto Rico. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

On May 8, 2015, the Plan Committee ratified and confirmed the following amendments to the Plan:

- Removal of the profit-sharing clause and replacement of the same with a basic contribution equal to 1.5% of eligible compensation (additional contributions), adopting the same beneficiary designation provision as the Plan Sponsor’s parent company (“CCL US plan”), effective January 1, 2015.
- Adoption of a new fund line-up, setting as default fund the Target Retirement Age-Based funds, effective January 1, 2016.
- Defining the eligible compensation to match the CCL US plan and changing the employer’s match benefit to 100% for each dollar of pretax contributions up to 2% of compensation and 50% for each dollar of pretax contribution between 2% and 6% of compensation, effective January 1, 2016.

There were 298 and 277 participants with account balances in the Plan as of December 31, 2024 and 2023, respectively.

(b) Eligibility -

The Plan covers substantially all salaried employees of the Plan Sponsor who are eighteen (18) or older. Three (3) months of service are required for purposes of employer contributions.

(c) Contributions -

Each year, participants may contribute up to \$15,000 of pre-tax annual compensation. Participants who have attained the age of fifty (50) before the end of the Plan year are eligible to make catch-up contributions of \$1,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers contributions).

Participants direct all or a portion of the investment of their contributions into various investment options offered by the Plan. The Plan currently offers thirty-one (31) mutual funds and one (1) fixed annuity investment option for participants.

The Plan Sponsor makes matching contributions equal to 100% of the pretax contributions up to 2% of compensation and 50% of pretax contributions between 2% and 6% of compensation.

The Plan Sponsor makes additional basic contributions of 1.5% of eligible compensation. During the year ended December 31, 2024, the Plan Sponsor made additional basic contributions amounting to \$125,733.

(d) **Participant accounts** -

An account is maintained for each participant, credited with the participant's contribution, and allocations of: (i) the employer's contribution, (ii) plan earnings, and (iii) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the vested portion of the amount accumulated in the participant's account.

(e) **Vesting** -

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Plan Sponsor's matching and additional contributions portion of their accounts is based on years of service. The contributions vest in accordance with the following schedule:

6 or more years	100%

Employees are fully vested in the Plan Sponsor's matching and additional contributions, regardless of years of service, upon attaining age sixty-five (65) while still employed by the Plan Sponsor, retirement at the normal retirement ages or becoming disabled in accordance with the provisions of the Plan and/or death while employed by the Plan Sponsor, termination of the Plan or complete discontinuance of contributions by the Plan Sponsor.

(f) **Forfeitures** -

Forfeitures of non-vested account balances in any given year may be used to reduce the Plan's administrative expenses or reduce employer's contributions. Forfeited non-vested accounts totaled \$72,474 and \$63,294 as of December 31, 2024 and 2023, respectively. No forfeitures were used during the year ended December 31, 2024.

(g) **Notes receivable from participants** -

Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at prime rate plus one (1) percent. The prime rate was 8.50% at December 31, 2024 and 2023, respectively. Principal and interest are paid through payroll deductions. A \$75 loan origination fee and an administrative fee of \$50 per year per loan is charged to the participant's account.

(h) **Payment of benefits** -

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum amounts equal to the value of the participant's vested interest in his or her account, or periodic installments.

(2) Summary of accounting policies:

(a) Basis of presentation -

The Plan's fiscal year ends on December 31st of each year. All references to years in these notes to financial statements represent calendar years unless otherwise noted. The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

(b) Basis of accounting -

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (US GAAP).

(c) Use of estimates -

The preparation of financial statements in conformity with US GAAP requires the management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(d) Investment valuation and income recognition -

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note (4) for discussion of fair value measurements.

The reported value for the fully benefit responsive investment contract is reported and presented in the face of the statements of net assets available for benefits at contract value.

Purchases and sales securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

(e) Benefits payments -

Benefits payments to participants are recorded when paid.

(f) Administrative expenses -

The Plan's expenses are paid either by the Plan or the Plan's Sponsor, as provided by the plan document. Expenses that are paid directly by the Plan's Sponsor are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investment presented in the accompanying statement of changes in net assets available for benefits.

(g) Notes receivable from participants -

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as a distribution based upon the terms of the plan document.

(h) **Excess contribution payable** -

Amounts payable to participants for contributions in excess of amounts allowed by the Puerto Rico Treasury Department are recorded as liability with corresponding reduction to contributions. See related Note (7).

(i) **Risks and uncertainties** -

The Plan invests in various investment securities which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes can materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(3) **Certified investments:**

The Plan Administrator having determined that it is permissible in the circumstances elected to have the audits of the Plan performed in accordance with ERISA section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the investments and notes receivable from participants' information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) were obtained or derived from information obtained by the Plan Administrator and certified as complete and accurate by Great-West Trust Company, LLC, qualified institution, and in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Great-West Trust Company, LLC, the trustee of the Plan, held the Plan's investment assets and executed investment transactions as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

Information obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Great-West Trust Company, LLC:

- Investments (at fair value and contract value), and notes receivable from participants, as shown in the statements of net assets available from benefits as of December 31, 2024 and 2023.
- Investment activity, as shown in the statements of changes in net assets available for benefits for the year ended December 31, 2024, as follows:
 - Interest and dividend income in the amount of \$181,839
 - Investment expenses in the amount of \$38,731
 - Net appreciation in fair value of investments in the amount of \$395,219
 - Interest income on notes receivable from participants in the amount of \$30,422
- The information for all investments and the participant loans listed in the schedule of assets (held at end of year) as of December 31, 2024 as shown in the ERISA-required supplemental schedule.

(4) **Fair value measurement:**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1- Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2- Inputs to the valuation methodology include:

- (a) Quoted prices for similar assets or liabilities in active markets;
- (b) Quoted prices for identical or similar assets or liabilities in inactive markets;
- (c) Inputs other than quoted prices that are observable for the asset or liability; and
- (d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic condition or model-based valuation techniques may require transfer of financial instruments from one fair value to another. In such instances, the transfer is reported at the beginning of the reporting period.

The Plan evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there was no transfer in or out of levels 1, 2 or 3.

(5) Guaranteed investment contract with insurance company:

The Plan entered into a fully benefit-responsive guaranteed investment contract with Great-West Life & Annuity Insurance Company (the Insurance Company). It covers its Key Guaranteed Portfolio Fund, which is a general account product. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The average interest earned by the Plan was 1.41% and 1.23% for the years ended December 31, 2024 and 2023, respectively. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Great-West Trust Company, LLC, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$1,072,848 and \$951,623, respectively. The crediting interest rate is compounded daily to the effective annual interest rate. The interest rate to be credited during the calendar year will be determined by Great-West Trust Company, LLC prior to the last day of the previous calendar year and shall be reset annually. The effective annual interest rate will never be less than 0%. The guaranteed investment contract does not permit the Insurance Company to terminate the agreement prior to the scheduled maturity date.

(6) Administrative expenses:

Administrative expenses paid from Plan assets mainly include fees for asset management, third party administrator services, and for guaranteed income features and amounted to \$36,884 for the year ended December 31, 2024.

The Plan Sponsor is assuming certain administrative expenses of the Plan without reimbursement. Total administrative expenses paid by the Plan Sponsor during the year ended December 31, 2024 amounted \$13,782. In addition, certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officers or employees received compensation from the Plan.

(7) Excess participants' contributions:

The Plan failed to pass the Average Deferral Percentage ("ADP") test for the years ended December 31, 2024 and 2023. As of December 31, 2024 and 2023, the accompanying statements of net assets available for benefits includes contributions payable amounting to \$6,475, corresponding to excess participants' refunds for the year 2024. As of December 31, 2023, contributions payable amounting to \$11,370, corresponding to excess participants' refunds for the years 2023 and 2020 in the amount of \$6,465 and \$4,905, respectively.

During September 2025, the Plan reimbursed \$6,475 of excess contributions payable recorded as of December 31, 2024.

During November 2024, the Plan reimbursed \$11,370 of excess contributions payable recorded as of December 31, 2023.

(8) Plan termination:

Although it has not expressed any intent to do so, the Plan's Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in the employer contributions, portion of their accounts.

(9) Party-in-interest investments and prohibited transactions:

The Plan's investment transactions are managed by the custodian, whose subsidiary is the record keeper of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined by ERISA. In accordance with the Department of Labor's Regulation 2510.3-102, an employer is required to segregate participants' contributions from its general assets as soon as practical but no later than 15 business days, when amounts are contributed by participants or withheld from their wages for a pension benefit plan such as the Plan. During the year ended December 31, 2024, there were no unintentional delays there were unintentional delays in the remittance of participants' contributions withheld.

The costs incurred by the Plan as a result of the unintentional untimely remittances of participants' contributions, as shown in the ERISA-required Schedule of Delinquent Participant Contributions, are absorbed by the Plan Sponsor.

(10) Tax status:

The Plan Sponsor has received its latest determination letter issued by the Puerto Rico Treasury Department (PRTD) dated September 16, 2016, effective on January 1, 2014, stating that the Plan is qualified under Section 1081 of the Internal Revenue Code for a New Puerto Rico and thereafter the related trust is exempt from taxation.

The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Management has evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no-provision or liability for income taxes has been included in the accompanying financial statements.
