Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Basis for Disclaimer of Opinion

The Plan does not have sufficient accounting records and supporting documents relating to certain employee records. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matter described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

Notes to Financial Statements

Note 1—Description of Plan

The following description of the Bonaventure 401(k) Plan (formerly known as the Bonaventure Property Management Services, LLC Retirement Savings Plan) (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General: Effective January 1, 2024 the Plan changed its name from the Bonaventure Property Management Services, LLC Retirement Savings Plan to the Bonaventure 401(k) Plan. The Plan began April 24, 2021 and serves the following related entities - Bonaventure Property Management Services, LLC, Bonaventure Shared Services, LLC and Bonaventure Executive Services, LLC all of whom are related through common ownership (collectively, the Sponsor). The Plan removed the Bonaventure Property Management Services, LLC entity effective January 1, 2024. The Plan is a defined contribution plan covering all employees of the Sponsor who have at least 1 month of service and who have attained the age of 18 years. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Each year participants may contribute a portion of their compensation, not to exceed the amount allowed under current law. Participants who have reached age 50 before the end of the Plan year are eligible to make catch-up contributions. The Sponsor provides a matching contribution based on the participant’s elective deferral. The Sponsor matches 50% of the Participants’ elective deferrals up to 6% of their compensation. The Sponsor may also make an additional discretionary contribution. Participants direct the investment of all contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

Administrative expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses related to the administration of notes receivable from participants and investment related expenses are charged directly to the participant’s account and are included in administrative expenses.

Participant accounts: Each participant’s account is credited with the participant’s contribution and an allocation of (a) the Sponsor’s matching contribution, (b) the Sponsor’s discretionary contribution, if any, and (c) Plan earnings. Each participant’s account is also charged with an allocation of administrative expenses, where applicable. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting: Participants are immediately vested in their contributions plus earnings thereon. Vesting in the Sponsor’s contribution is based on years of service, as defined.

Note 1—Description of Plan (continued)

Forfeitures: Forfeited non-vested accounts may be used to reduce contributions or pay Plan expenses. Forfeitures were used to reduce employer contributions or Plan expenses for the year ended December 31, 2024. During 2024, forfeitures of \$75,074 were used to reduce employer contributions. As of December 31, 2024 and December 31, 2023, there were \$198,687 and \$68,552 in forfeited non-vested balances outstanding.

Excess contributions payable: Amounts payable to participants for contributions in excess of amounts elected for deferral yet to be disbursed.

Payment of benefits: Distribution of a participant's account is in the form of a single lump sum payment in the amount of their fully vested balance.

Hardship distributions: Hardship distributions from the Plan are permitted for medical expenses, the purchase of a principal residence, tuition and other post-secondary expenses, amounts necessary to prevent eviction, funeral expenses and certain qualifying repairs to the participant's primary residence. Distributions for this reason are subject to approval by the Plan administrator.

Notes receivable from participants: Participants may borrow from their accounts up to \$50,000. Only two loans are permitted to be outstanding at one time. Interest rates on outstanding loans as of December 31, 2024 and 2023 ranged from 4.25 percent to 9.50 percent. Principal and interest are paid ratably through payroll deductions. The loans are secured by the participant's account balance in the Plan.

Note 2—Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (US GAAP) requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition: The Plan's investments are stated at fair value. In accordance with US GAAP, fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits: Benefits are recorded when paid.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Related party and party in interest transactions: Plan fees are paid to Fidelity Management Trust Company and ADP Retirement Trust Services, LLC, the trustees of the Plan. Meadows, Urquhart, Acree and Cook, LLP provides audit services to the Plan. Therefore, these transactions qualify as party-in-interest transactions. The Plan paid \$38,771 and \$47,422 to these parties for the years ended December 31, 2024 and 2023, respectively.

Plan termination: Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants would become 100 percent vested in their accounts.

ADP Retirement Trust Services, LLC, the trustee of the Plan, has certified that the following information is complete and accurate as of December 31, 2024, and for the year ended December 31, 2024:

Note 4—Summary of Fair Market Value Measurements

Fair value measurements: In accordance with US GAAP, a fair value hierarchy for inputs is used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the most observable inputs be used when available. Observable inputs are those that market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Plan or Trustee. Unobservable inputs reflect the Plan's assumptions about the inputs market participants would use in pricing the asset or liability developed based on the best information available in the circumstances. The fair value hierarchy is categorized into three levels based on the inputs as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets or quoted prices for identical or similar assets and liabilities in inactive markets.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. The funds are required to publish their daily net asset value (NAV). The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage account: Holds shares of registered investment companies and are valued at the closing price reported on the active market on which the individual securities are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5—Tax Status

The Internal Revenue Service (IRS) has determined and informed the Sponsor by the letter dated October 6, 2020 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of an asset, liability, or disclosure in the financial statement.

Note 6—Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and amounts reported in the statements of net assets available for benefits.

Note 7—Partial Plan Termination

During the year ended December 31, 2024, the Plan experienced a significant reduction in the number of participants as a result of employer-initiated terminations. Management has determined that this reduction constitutes a partial plan termination under Internal Revenue Code Section 411(d)(3). As a result, all affected participants became fully vested in their account balances as of December 31, 2024. There was no significant impact on plan assets or liabilities as a result of the partial termination.

Note 8—Subsequent Events

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 14, 2025, the date the financial statements were available to be issued.
