Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Zircoa, Inc. Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified to by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

Note 1. Plan Description

The following description of the Zircoa, Inc. Savings Plan (the "Plan") provides only general information. Zircoa, Inc. (the "Company") is the Plan sponsor. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan established to provide retirement benefits for substantially all salaried and hourly employees of the Company. The Zircoa, Inc. Retirement Plan Investment Committee (the "Committee") is responsible for the general administration of the Plan. John Hancock Life Insurance Company (U.S.A.) ("John Hancock") is the Custodian of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Contributions – Plan participants may contribute to the Plan, on a pre-tax or Roth basis, an amount not to exceed 50% of eligible gross compensation.

Participant contributions on the first 5% of eligible compensation for salaried employees are matched by the Company based on length of service, ranging from 50% to 100% of such contributions. In addition, the Company makes a nonelective safe harbor contribution equal to 3% of an eligible salaried employee's compensation, and may also make a discretionary profit sharing contribution which was 3% of an eligible salaried employee's compensation for 2024.

Effective January 1, 2017 through an amendment to the Plan, union employees receive 50% on the first 3% of their eligible compensation that is contributed to the Plan. In addition, the Company makes a non-discretionary contribution to union employees based on years of service, ranging from 3.0% to 5.5% of credited compensation, as defined by the Plan.

Effective January 1, 2016, the Plan amended and restated the Plan (effective for Plan years on or after January 1, 2016) to include a Special Non-Discretionary Profit Sharing Contribution ("SNPSC") for eligible union and salaried employees. The SNPSC shall be made in an amount equal to the aggregate Quarterly and Annual Shares, as defined in Amendment No. 1 to the Plan, and allocated to each eligible employee. Shares were contributed quarterly and range from \$-0- to \$7,500 (50% of the Shares allocated were contributed quarterly and the remaining 50% of the preceding quarters were contributed annually) based upon the Company's earnings before interest and taxes. Effective March 30, 2017, the Company amended the Plan such that the SNPSC shall no longer be made.

Effective January 1, 2018, the Company may, in its discretion, make a Special Discretionary Profit Sharing Contribution ("SDPSC") to the Plan, which is equal to the aggregate of Quarterly Shares and Annual Shares, as defined in Amendment No. 4 to the Plan, that are allocated, if any, to each eligible employee or eligible union employee. The Company approved a discretionary profit sharing contribution of \$500,000 for the 2024 Plan year.

Participants direct the investment of their contributions, any contributions made on their behalf, and actual earnings thereon into various investment options offered by the Plan.

Note 1. Plan Description (Continued)

Contributions (Continued)

Various Internal Revenue Code (the "Code") regulations concerning both employee and Company contributions may limit the contribution amounts defined above. The Company has the right to limit these contributions to conform to applicable regulations. In addition, participants who make elective deferrals and have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from certain other qualified defined benefit or defined contribution plans (rollover).

Participant Accounts – Each participant's account is credited with the participant's contributions, the Company's contributions, and an allocation of Plan earnings, and is charged with an allocation of administrative expenses. Allocation of Plan earnings is based on each participant's share of net earnings or losses of their respective elected investment options. Allocation of administrative expenses is based on the participant's account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – All participant contributions, Company basic contributions, Company safe harbor contributions, Company SNPSC, Company SDPSC, and actual earnings thereon vest immediately. The Company non-discretionary contributions for those participants employed as of June 1, 2011 shall at all times be nonforfeitable. For those employees hired subsequent to June 1, 2011, the vesting schedule for Company non-discretionary contributions and actual earnings thereon is based on years of credited service as defined by the Plan, and also become fully vested upon death, disability, or attaining age 55.

Administration – The Committee oversees the administration and investments of the Plan, including determining administrative actions and interpreting and applying the Plan's provisions. The Committee has the right to settle claims on debts and to defend any claims arising from operations of the Plan. The Committee, which consists of employees of the Company, oversees the investments of the Plan's funds through the Custodian and investment manager.

Notes Receivable From Participants – Participants are permitted to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants are permitted to obtain two loans a year; however, no more than two loans may be outstanding at any time. Loan terms range from one to five years, or more for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate determined by the Committee.

Payment of Benefits – Benefits are paid to participants upon their retirement, death, disability, or termination from employment. Participants may elect to receive either a lump sum or installment payments. Participants may also make in-service withdrawal amounts from their accounts under certain defined conditions.

Note 1. Plan Description (Continued)

Plan Termination – Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and applicable collective bargaining agreements. In the event of Plan termination, participants will become fully vested in their accounts and receive a total distribution of their account.

Forfeited Accounts – The Plan may pay reasonable administrative expenses from forfeited accounts or use forfeited accounts to reduce certain future Company contributions. At December 31, 2024 and 2023, there was \$31,944 and \$104,987, respectively, of unutilized forfeited non-vested accounts. \$132,109 of forfeitures was utilized during 2024 to reduce employer contributions.

Plan Expenses – Fees of the Plan are paid by the Company or the Plan at the discretion of the Company. Administrative expenses may be offset with funds made available by the Plan Custodian from fees it receives from investment fund managers. Net appreciation includes \$35,088 of John Hancock credits to participants for the year ended December 31, 2024.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting – The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and Custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits – Benefits are recorded when paid.

Use of Estimates – The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent Events – The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

Note 3. Unaudited Information

The Plan's management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, management received certifications from John Hancock Life Insurance Company (U.S.A.), the Custodian of the Plan, acknowledging the completeness and accuracy of all investments and notes receivable from participants reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the supplemental schedule of assets (held at end of year) as of December 31, 2024, the related investment and loan interest activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024, and investment related information in the accompanying notes to the financial statements. This information is unaudited by independent accountants.

Note 4. Fair Value Measurements

The Plan estimates the fair value of financial instruments using available market information and other generally accepted valuation methodologies. The inputs used to measure fair value are classified into three levels:

Level 1 – Quoted market prices in active markets for identical assets and liabilities

Level 2 – Observable market-based inputs or unobservable inputs that are corroborated by market data

Level 3 – Unobservable inputs in which little or no market data exists

The following is a description of the valuation methodology used for plan assets measured at fair value:

- The investments in pooled separate accounts are held and managed by John Hancock. The fair value of investments held in these accounts is based on their reported net asset value ("NAV"). The NAV is based primarily on observable inputs and the market value of the underlying investments, and is classified as Level 2.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. There have been no changes in the methodology used from 2023 to 2024. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Risks and Uncertainties

The Plan holds various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 6. Party-in-Interest Transactions

Plan investments are held in pooled separate accounts managed by the Custodian or its affiliates. In addition, certain administrative expenses were paid to the Custodian during the year ended December 31, 2024. These transactions qualify as party-in-interest transactions.

Note 7. Income Tax Status

The Plan received a favorable determination letter from the IRS dated March 16, 2018, stating that the Plan document, as then designed, was in compliance with the applicable requirements of the Code. The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

The Plan's management has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require such recognition or disclosure in the financial statements.


