**NOTE A | DESCRIPTION OF THE PLAN**

The following description of KIARA, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*1. General*

The Plan is a defined contribution plan covering all eligible employees of Prairie Cardiovascular Consultants, Ltd., LaSante, Inc., LaSante Wisconsin, Inc., and KIARA Clinical Integration Network, LLC. (the Companies).

The Plan was restated by the KIARA, Inc. 401(k) Profit Sharing Plan Board of Directors effective January 1, 2014. For employees hired prior to July 1, 2014 (effective date), the Plan covers all full-time employees of the Companies who are age 21 or older with one year of service. One year of service is met upon the completion of 1,000 hours of service prior to the completion of 12 consecutive months. For employees hired on or after the effective date, employees who are age 21 or older are eligible for participation in the Plan. The Plan does not include union, nonresident aliens, leased employees or PRN nurses and midlevel providers. Highly compensated employees hired prior to the effective date are also excluded from employer matching contributions. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). After eligibility requirements are met, participants may enter the Plan. The Plan was restated again effective January 1, 2022 to incorporate changes from mandatory and voluntary amendments.

The plan was restated and amended in December 2022 to freeze contributions into the Plan after December 31, 2022.

*2. Contributions*

Subsequent to December 31, 2022, contributions into the Plan are frozen.

*3. Participant Accounts*

Each participant's account is credited with the participant's allocations of Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**NOTE A | DESCRIPTION OF THE PLAN**

3. *Participant Accounts*

Participants could revoke their salary deferral election at any time during the Plan Year. Participants were able to make any other modification as of the first day of each calendar quarter. Any modification became effective as soon as administratively feasible after it is received by Administration.

4. *Vesting*

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Companies' matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of service. A participant hired prior to the effective date is 100% vested after three years of credited service. Participants hired on or after the effective date are immediately vested in the Companies' matching and discretionary contribution portion of their accounts plus actual earnings thereon.

5. *Notes Receivable from Participants*

Notes receivable from participants are not currently available to participants in the Plan. The existing notes receivable are from a merger of plans and have been grandfathered into this Plan.

6. *Payment of Benefits*

On termination of service due to death, disability or retirement, a participant or beneficiary automatically becomes 100% vested and may take a distribution equal to the value of the participant's vested interest in his/her account or partial withdrawals equal to minimum required distribution each year under IRS regulations. For termination of service due to other reasons, a participant will receive the value of the vested interest in his/her account as a lump-sum distribution if the vested account balance is equal to or less than \$ 5,000. If the vested account balance is greater than \$ 5,000, the participant may elect to receive a distribution of the entire amount as required per IRS regulations. Hardship withdrawals are also permitted by the Plan.

7. *Forfeited Accounts*

Forfeited nonvested accounts totaled \$ 42 and \$ 22 at December 31, 2024 and 2023, respectively. These accounts can be used to reduce employer contributions.

**NOTE B | SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*1. Basis of Accounting*

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

*2. Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

*3. Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*4. Notes Receivable from Participants*

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis.

*5. Payment of Benefits*

Benefits are recorded when paid.

**NOTE B | SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

6. *Expenses*

Certain expenses of the Plan are paid by the Plan unless otherwise paid by the Companies. Expenses paid by the Companies are excluded from the financial statements. Fees related to the payment of benefits are charged directly to participant accounts.

7. *Subsequent Events*

The Plan's management has evaluated subsequent events for recognition and disclosure in the financial statements through October 10, 2025, which is the date the financial statements were available to be issued. Through October 10, 2025, no subsequent events required recognition or disclosure in the financial statements.

**NOTE C | FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Valuation is based on quoted prices for identical assets and liabilities in active markets.

Level 2 – Valuation is derived from inputs, other than quoted prices included in Level 1, which are observable for the asset or liability either directly or indirectly. Investments classified as Level 2 are generally valued by benchmarking model-derived prices to quoted market prices and trade data for identical or comparable securities. The significant inputs used in this approach include interest rates, prepayment timing, yield spreads, maturities, credit losses and credit ratings of the securities.

Level 3 – Valuation is derived from unobservable inputs that are not corroborated by market data.

**NOTE C | FAIR VALUE MEASUREMENTS**

The Plan invests in a collective trust which is valued at the net asset value (NAV) of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Securities within the self-directed brokerage accounts are valued based on quoted market prices in active markets or on quoted market prices of similar assets in active markets.

Self-directed accounts consist of mutual funds, common stocks, preferred stocks, corporate bonds, certificate of deposit, and cash and cash equivalents. Fair values of self-directed accounts have been determined by the trustee from observable market quotations for both actively and inactively traded markets, when available.

Instead, the purchases and withdrawals occur with the collective trust, and in certain circumstances, those transactions are entirely controlled and/or restricted by the collective trust. The fair value of this investment is determined by the management of the collective trust and is reported to the Plan as the Plan's proportionate share of the net asset fair value of the entity. The table below provides information relative to this type of investment. Additional information on the investment, which is a direct filing entity, can be found by viewing its U.S. Department of Labor Form 5500.

**NOTE F | PLAN TERMINATION**

The Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants not fully vested will become 100% vested in their accounts. In 2020, the Plan experienced a greater than 20% reduction in active participants due to staffing reductions which were a result of the Coronavirus pandemic. All active participants hired after 2014 are immediately 100% vested in employer contributions and participants hired prior to that date have a 3 year vesting as such. Although a partial plan termination occurred, no changes to vesting of benefits was required. Effective December 31, 2022, the plan was frozen and contributions into the plan are no longer being accepted.

**NOTE G | TAX STATUS**

The Plan is intended to be qualified under Section 401(a) and tax exempt under Section 501(a) of the Internal Revenue Code (IRC). The Plan adopted a restated non-standardized pre-approved profit sharing plan with an opinion letter dated June 30, 2020. Although the Plan has been amended since receiving the latest determination, the Plan's administrator and the Plan's trustee believe that the Plan is designed, and is currently being operated, in compliance with applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

**NOTE G | TAX STATUS**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan was delinquent in filing complete Form 5500s and received a notice from the Department of Labor (DOL) dated January 6, 2020, regarding the 2018 filing. The Plan also received oral communication from the DOL regarding the 2018 – 2021 filings that were incomplete. By September 12, 2023, the Plan had completed the filings for the years 2018 – 2021. The Plan also received a notice from the DOL dated July 10, 2023 that an investigation of the Plan has been opened. The Plan received a notice from the DOL stating the investigation concluded February 22, 2024. The investigation pertained to the delinquent filings which were filed after notice of the investigation.

**NOTE H | RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

**NOTE I | PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Newport Trust Company. Newport Trust Company is the trustee of the Plan. The Newport Group is the recordkeeper of the Plan. These transactions qualify as party-in-interest transactions.
