Independent Auditor's Report

The Participants and the Plan Trustees

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Premier Integrated Medical Associates, Ltd. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Opinion

Basis for Opinion

Notes to Financial Statements

Note 1. Description of the Plan

The following description of the Premier Integrated Medical Associates, Ltd. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering employees of Premier Integrated Medical Associates, Ltd. (the Company or Employer) who have one year of service and are age 21 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was most recently restated effective January 1, 2023.

The Plan Administrator is responsible for the oversight of the Plan, including determining the appropriateness of the Plan's investment offerings and monitoring investment performance. The Plan Administrator has all powers necessary to carry out the provisions of the Plan and to satisfy the requirements of any applicable law. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Contributions: Participant contributions to the Plan are made by employees in whole percentages of compensation within limitations stipulated in Section 401(k) of the Internal Revenue Code. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct 100% of the investment of their contributions into various investment options offered by the Plan. The Company may provide a matching contribution equal to a percentage of each eligible individual's compensation. The exact percentage is determined each year by the Company's board of directors. Profit sharing contributions may be made at the Company's discretion. The Company will also provide a safe harbor nonelective contribution to the account of each eligible participant in an amount equal to at least 3% of the employee's compensation for the plan year. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans with approval from the Plan sponsor.

Participant accounts: Each participant's account is credited with his or her contribution, the Company's discretionary contribution, if any, and an allocation of plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contribution portion of their account plus actual earnings thereon is based on years of continuous service. Participants vest 20% per year of service after one year of service and are 100% vested after five years of service. Participants are also immediately vested in discretionary contributions which the Company designates as Qualified Matching Contributions or Qualified Non-Elective Contributions.

Payment of benefits: On termination of service, a participant may elect to receive a lump-sum cash distribution, periodic installments, or a direct rollover distribution equal to the value of the participant's vested interest in his or her account. Participants may withdraw their elective deferral account balance in the event of hardship as defined in the plan agreement.

The plan allows for automatic payment of the participant's vested balance upon termination, provided that the vested balance is less than \$7,000.

Note 1. Description of the Plan (Continued)

Notes receivable from participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. At December 31, 2024 and 2023, the notes bear interest between 5.25% and 10.50%, which commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Principal and interest is paid ratably through payroll deductions.

Note 2. Summary of Significant Accounting Policies

Forfeited accounts: At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$20,530 and \$16,322, respectively. These accounts are used to reduce future employer matching contributions or allocated to fees. During 2024, \$6,308 of forfeitures were applied to employer matching contributions.

Basis of accounting: The accompanying financial statements are prepared in conformity with accounting principles generally accepted in the United States of America (GAAP) in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain amounts and disclosures reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the trustee. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Capital gain distributions are included in dividend income.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expense and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan payments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Contributions: Participant contributions are recognized when earned. Employer matching contributions, employer safe harbor contributions and additional discretionary contribution are recognized on an annual basis. As of December 31, 2024, employer matching contributions, employer safe harbor contributions, and additional discretionary contributions totaled \$146,904, \$546,481 and \$56,615, respectively.

Payment of benefits: Benefits are recorded when paid.

Administrative expenses: A portion of the administrative expenses are paid by the Company. Expenses paid by the Plan for the year ended December 31, 2024, totaled \$35,895.

Subsequent events: The Plan has evaluated the subsequent events for potential recognition and/or disclosure through October 14, 2025, the date the financial statements were available to be issued.

Note 3. Certified Information

The information related to investments and notes receivable from participants that is included throughout the Plan's financial statements and supplemental schedule as of December 31, 2024 and 2023, and for the year ended December 31, 2024, was prepared or derived from information provided by the trustee, Empower Trust Company, LLC, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that the information provided to the Plan Administrator by the trustees related to these plan assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information in Note 8 and the supplemental schedule related to the Plan's assets.

Empower Trust Company, LLC also certified to the completeness and accuracy of \$2,786,170 of net appreciation in fair value of investments, \$1,561,637 of dividends related to investments, and \$12,313 of interest income from notes receivable from participants for the year ended December 31, 2024.

Note 4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions in accordance with ERISA.

Note 5. Tax Status

The Plan adopted a standardized form of a volume submitter plan sponsored by Empower Retirement, LLC. The volume submitter plan received an opinion letter dated November 14, 2022, from the Internal Revenue Service (IRS) as to the volume submitter plan's qualified status. The volume submitter plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator evaluated the Plan's tax positions and concluded that there are no uncertain tax positions that require recognition or disclosure in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by tax authorities for years before 2021.

Note 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 7. Party-in-Interest Transactions

Fees paid directly by the Plan to Fifth Third Bank and Empower Trust Company, LLC for trustee and record keeping services amounted to \$35,895 for the year ended December 31, 2024.

Note 8. Fair Value Measurements

The Plan has determined the fair value of certain assets and liabilities through application of accounting guidance that establishes a framework for measuring fair values. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under this standard are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine in the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
