

Notes to Financial Statements

1. Description of Plan:

The following description of Mayer Bros. Apple Products, Inc. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering employees of Mayer Bros. Apple Products, Inc. (the Sponsor) who have attained age 18 and six months of service. All newly eligible employees are enrolled into the Plan immediately under the Plan's default investment option unless another permitted percentage and/or investment option is selected by the participant. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions:

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Contributions are subject to certain limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Sponsor contributes 50% of participant contributions, up to 10% of compensation. Additional amounts may be contributed at the option of the Sponsor's board of directors.

The Plan allows for profit-sharing contributions, determined by the Sponsor's board of directors, for allocation to participants based on eligible compensation. The profit-sharing contribution for 2024 was \$468,814.

The Plan also allows for safe-harbor contributions. Amounts are determined by the Sponsor's board of directors, and the contributions are based on a percentage of participants' compensation. There was a 3% safe harbor contribution in 2024 totaling \$568,812.

Participant Accounts:

Each participant's account is credited with the participant's contribution and allocations of (a) the Sponsor's contribution and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are vested immediately in their contributions, the Sponsor's matching and safe harbor contributions, and actual earnings thereon. Vesting in the Sponsor's profit sharing contribution portion of accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

Investment Options:

A participant may direct contributions into a variety of proprietary mutual fund and common/collective trust accounts offered by Vanguard Fiduciary Trust Company (Vanguard), a trustee of the Plan.

Notes Receivable From Participants:

Participants may borrow from their fund accounts amounts equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms range from one to five years. The loans are secured by the balance in the participant's account and bear interest at the prevailing commercial rate for loans of similar types at date of issuance. Principal and interest is paid ratably generally through payroll deductions.

Payment of Benefits:

Upon termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, annual installments, or annuity options. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeitures:

Forfeited non-vested accounts are used to reduce future employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$17,051 and \$10,431. During 2024, employer contributions were reduced by \$19,178 from forfeited non-vested accounts.

2. Summary of Significant Accounting Policies:**Basis of Accounting:**

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition:

The Plan's investments are stated at fair value. Inputs to the valuation methodology for mutual funds are unadjusted quoted prices in active markets. The common/collective trust is reported at net asset value as a practical expedient to represent fair value. Net asset values are based on the aggregate fair values of the underlying investments. Participants may redeem shares at net asset value daily, without restriction.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon terms of the plan document.

Payment of Benefits:

Benefits are recorded when paid.

Administrative Expenses:

Certain expenses to maintain the Plan are paid by the Plan, unless paid by the Sponsor. Expenses paid by the Sponsor are excluded from these financial statements.

Subsequent Events:

The Plan has evaluated events and transactions for potential recognition or disclosure in the financial statements through October 14, 2025 (the date the financial statements were available to be issued).

3. Financial Information Certified by the Trustee (Unaudited):

In accordance with Department of Labor Regulation 2520.103-8, the plan administrator has obtained certified "Statements of Account" from Vanguard as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that the information summarized below is complete and accurate:

- Statements of Net Assets Available for Benefits – Investments and notes receivable from participants.
- Statement of Changes in Net Assets Available for Benefits – Investment income and interest income on notes receivable from participants.
- Supplemental Schedule of Assets (Held At End of Year) – all items.

4. Plan Termination:

Although it has no intent to do so, the Sponsor has the right to amend or terminate the Plan at any time. In the event the Plan is terminated or employer contributions are discontinued, all of the assets of the Plan will be distributed to participants based upon amounts outstanding to their credit as of the date of the liquidation.

5. Tax Status:

The Internal Revenue Service has issued a favorable opinion letter on the tax status of the Plan. Accordingly, no provision has been made for income taxes.

6. Risks and Uncertainties:

The Plan provides for various participant directed investment options. Investments are exposed to risks, such as interest rate, market and credit. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.



The Plan allows for profit-sharing contributions, determined by the Sponsor's board of directors, for allocation to participants based on eligible compensation. The profit-sharing contribution for 2024 was \$468,814.


