Note A. Description of the Plan

The following description of the Bermello, Ajamil & Partners, Inc. ("Company") Employees' Savings Investment Plan ("Plan") provides only general information regarding the Plan. Participants should refer to the Plan document for a more complete description of the Plan provisions.

General

The Plan's original effective date was July 1, 1994. The Plan is a defined contribution plan covering substantially all employees of the Company who have worked for three consecutive months during which the participants complete at least one hour of service and are at least age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Empower Trust Company, LLC, and Empower Annuity Insurance Company of America ("Empower") collectively serve as the Plan's custodian. Empower Annuity Insurance Company is the recordkeeper of the Plan. Management of the Company controls and manages the operation and administration of the Plan.

Plan Merger

On January 24, 2024, the Plan sponsor was acquired by another company in a stock purchase agreement. Effective August 10, 2023, the Plan sponsor approved a resolution to merge the Bermello, Ajamil and Partners, Inc. Employees' Savings Investment Plan into the Woolpert 401(k) Plan (Affiliated Plan). On October 1, 2024, most of the plan assets, totaling \$13,874,827 were transferred into the Affiliated Plan. As of December 31, 2024, the remaining balance in the Plan is from the guaranteed investment contract, which is under contract and cannot be liquidated/reregistered until June 20, 2025. See Note K.

Contributions

Each year, participants may elect to contribute to the Plan a portion of their total annual compensation, as defined by the Plan, not to exceed the maximum allowable contribution under the Internal Revenue Code (the "Code"). The maximum allowable contribution totaled \$23,000 and \$22,500 for years ended December 2024 and 2023, respectively, subject to certain discrimination tests prescribed by the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover contributions). In addition, participants who have attained age 50 before the end of the Plan year are eligible to make "catch-up" contributions up to \$7,500 for the years ended December 2024 and 2023. Participants may designate a portion or all of their deferral contribution as a Roth 401(k) contribution. The Company contributes 25% of the first 4% that a participant contributes to the Plan. Additional amounts may be contributed at the option of the Company's board of directors. Participants and employer contributions are held and managed (as directed by the participants), by the insurance company, which invests the cash received, interest and dividend income and makes distributions to participants. Effective July 1, 2024, all participant contributions or rollovers were made into the merged Plan.

Investment Options

Participants may direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers thirty-eight (38) variable annuities and one (1) guaranteed interest contract. Company contributions are invested in accordance with respective participant's investment allocation elections. At their discretion, participants may change their investment options and deferral percentages at any time.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions, (b) administrative expenses, and (c) investment earnings or losses. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service at the rate of 20% after two years, 40% after three years, 60% after four years, 80% after five years and 100% after six years of credited service.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative fees and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, provided the loan is adequately secured and bears a reasonable rate of interest commensurate with local prevailing rates. Repayment should take place within a specified period of time within a range of 5 years or up to 15 years for the purchase of a primary residence. Principal and interest are paid semimonthly through payroll deductions. The insurance company administers the notes receivable from participants.

There were no new notes receivable from participants as of September 24, 2024. Only loan payments were allowed into the Plan until October 1, 2024.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant could elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a specified period. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

In-Service Distributions

The Plan allows in-service distributions if the participant has a hardship, attained the normal retirement age or attained the early retirement age. In-service distributions are permitted if the participant is 100% vested in the amount being withdrawn.

Forfeited Accounts

If a participant terminates employment prior to becoming fully vested, the non-vested portion of the participant's account, as defined by the Plan, is forfeited. Participant forfeitures for the year ended December 31, 2024 and 2023 amounted to \$13,352 and \$5,617 respectively. The forfeitures may be used to pay administrative expenses, and to reduce future employer contributions, or reallocated to participant accounts on a pro rata basis. As of December 31, 2024 the Plan did not have any forfeited non-vested accounts. As of December 31, 2023 the Plan's forfeited non-vested accounts totaled \$23,218. During 2024, there were \$36,891 of forfeitures withdrawn from the Plan and presented on the statements of changes in net assets available for benefits as transfer of assets to the acquiring plan. During 2023, there were \$4,109 of forfeitures used to reduce Company matching contributions.

Note B. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

All investments in pooled separate accounts are recorded at fair value in these financial statements, as prescribed by Accounting Standards Codification No. 820, Fair Value Measurements, ("ASC 820"). ASC 820 defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Additionally, ASC 820 establishes a framework for measuring fair value and expands disclosures about assets and liabilities measured at fair value. For information related to the Plan's valuation methodologies under ASC 820, see Note D of these financial statements.

The Plan presents in the Statement of Changes in Net Assets Available for Benefits net appreciation (depreciation) in the fair value of its investments, which consist of realized gains or losses, represented as an excess (shortfall) over market values at the beginning of the year, and unrealized appreciation (depreciation) on investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions Payable

During 2024 there were excess employee contributions of \$4,149. The Plan recorded an excess contribution payable of \$4,149 as of December 31, 2024. Subsequent to year-end, following the transfer of the Plan's assets and obligations, the successor plan distributed the excess contributions within the required correction period. There were no excess employee contributions in 2023.

Payments of Benefits

Benefits payments to participants are recorded when paid.

Reclassification/Comparative Data

Comparative data for the prior year has been reclassified to conform to the current year presentation in order to provide a better understanding of changes in the Plan's financial statements.

Accordingly, Empower Trust Company, LLC, the Trustee for the Plan, has certified as to the completeness and accuracy of all the investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the supplemental Schedule H, Part IV, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reflected in the Statement of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023. At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

The Plan has investments that are held in a guaranteed investment contract directed by each participant. The annuity contract has a guaranteed interest minimum. The aggregate value of the minimum guarantee is \$54,948 and \$1,799,668 as of December 31, 2024 and 2023, respectively.

During 2024 and 2023, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$1,729,499 and \$1,834,695, respectively.

Note D. Fair Value Measurements

The FASB has established a framework for measuring fair value in ASC 820, Fair Value Measurements. That framework provides under ASC 820 a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

Pooled Separate accounts: Pooled separate accounts (PSAs) are valued at the net asset value of the units held. The NAV is based on the fair value of the underlying investments held by the PSA less its liabilities. The fair value of the underlying investments, which can consist of a single mutual fund or multiple securities, is determined using market quotations or prices obtained from independent pricing sources. The NAV, as provided by Empower Trust Company, LLC is used as a practical expedient to estimate fair value. NAV would not be used if it was probable that the investment would not be traded at NAV. The PSAs provide for daily redemptions by the Plan at reported NAV with no advance notice. There are no unfunded commitments related to these investments. These are direct filing entities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note F. Tax Status

The Plan adopted its latest Prototype Non-Standardized Pre-Approved Profit Sharing/Money Purchase with a cash or deferral arrangement developed by Empower Trust Company, LLC, which obtained a favorable IRS opinion letter on November 14, 2022 in which the IRS stated that the form of the underlying prototype plan was acceptable under provisions of the Internal Revenue Code ("Code") and that any employer adopting this form of the plan will be considered to have a plan qualified under the Code. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirement of the Code and, therefore believes that the Plan is qualified and the related trust is tax-exempt. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdiction; however, there are currently no audits for any tax periods in progress.

Note G. Guaranteed Investment Contract

The Plan has entered into a group annuity contract with Empower Trust Company, LLC, an insurance company totaling \$54,948 and \$1,799,668 for 2024 and 2023, respectively. The account is credited with participant contributions to the account and earnings on the underlying investments, and charged for participant withdrawals and administrative expenses. The crediting rate is compounded daily to the effective annual interest rate. The interest rate to be credited will be determined by Empower Trust Company, LLC prior to the last day of the previous calendar. The effective annual interest rate will never be less than 0%.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower Trust Company, LLC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) bankruptcy of the Plan's sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, (3) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transactions exemption under ERISA or (4) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contracts issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

Note H. Related Party and Party-in-Interest Transactions

The Plan's investments include pooled separate accounts and a guaranteed investment contract managed by Empower Trust Company, LLC, as included in the supplemental information in Schedule H, Part IV, Line 4i – Schedule of Assets (held at end of year). Empower Trust Company, LLC and Empower Annuity Insurance Company of America are collectively the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

The Plan issues notes receivable to participants, which are secured by the vested balances in the participants' accounts. Notes receivable from participants are also considered exempt party-in-interest transactions. There were no notes receivable from participants as of December 31, 2024. As of December 31, 2023, notes receivable from participants amounting to \$208,009 also qualify as party-in-interest transactions.

During the years ended December 31, 2024 and 2023, the Plan paid \$14,250 and \$13,398, respectively, in administrative expenses.

Note I. Contingencies

There were no unusual or infrequent events or transactions occurring subsequent to the balance sheet date that might significantly affect the usefulness of the financial statements in assessing the Plan's present and future ability to pay benefits.

Note J. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note K. Subsequent Events

For the year ended December 31, 2024, Plan management evaluated subsequent events for potential recognition and disclosure through October 13, 2025, which is the date the financial statements were available to be issued.

On June 20, 2025, the Plan officially transferred the remaining investment under contract to the acquiring company's existing retirement plan.
