Opinion

Note 1 Plan Description

The following description of Elliott Section 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions. Effective January 1, 2022, the Plan name was amended from Elliott Management Corporation Section 401(k) Plan. The Plan instrument has been amended effective January 1, 2024, to revise the definition of eligible employee. Effective April 1, 2024 the plan permits the Singer Family Charitable Foundation to adopt the Plan. Effective May 1, 2024, Evergreen Coast Capital Corp. has changed its name to EMCCA Corporation.

General

The Plan, adopted effective July 1, 1982, and restated effective January 1, 2022, is a defined contribution plan covering all eligible employees of Elliott Management Corporation (“EMC”). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (“ERISA”). The Plan has been amended as new employers have adopted the Plan subject to the same eligibility requirements. This includes EMC, EMCCA Corporation, Elliott Capital Advisors, Elliott Investment Management, EIMCT, LLC, EIMFL, LLC, EIMFL Sub, LLC, Elliott Management DC, PB Island Dreams, LLC, Hambledon Management, Paul E. Singer Family Office, LLC, Policy Communications LLC, Rocky Zone, LLC, Paul E. Singer Foundation and The Singer Family Charitable Foundation. All the entities above are collectively referred to as the “Group.”

Contributions

Eligible employees may elect to contribute voluntarily through payroll deductions, subject to certain limitations. In 2024, employees may elect to contribute up to \$23,000 and employees 50 years old and over may elect to contribute an additional \$7,500. Based on the election of participants, contributions to the Plan may be pre-tax pursuant to Section 401(k) of the Internal Revenue Code.

Participants may also elect to have contributions to the Plan treated as Roth deferrals, which are includible in participants’ taxable income at the time of deferral.

The Group does not make employer contributions; however, corrective contributions can be made by the employers when needed.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and an allocation of the Plan’s income, expense, gains, and losses. Allocations are based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Loans

The Plan does not permit participants to take loans from their accounts.

Vesting

Participants are immediately vested in their voluntary contributions plus or minus any appreciation or depreciation with respect thereto.

Payment of Benefits

On termination of service, the Plan provides for a participant to have the option to retain his or her account in the Plan or receive a lump-sum distribution. The Plan also allows for partial payments in the amount of Minimum Required Distributions under Code section 401(a)(9). Amounts are not distributed except by reason of retirement, death, disability, separation from service, hardship, or the attainment of age 59½. Effective April 15, 2018, the Plan was amended to allow terminated participants the option to take a partial distribution, subject to provisions as stated in the amendment.

Note 2 Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, which is verified annually by an independent appraisal company. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade date basis. Net appreciation includes the Plan's gains and losses on the investments bought and sold, as well as held, during the year by Elliott International Limited ("EIL").

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

The expenses that are paid from the Plan's assets will either be shared by all participants or will be charged directly to the account of the participant on whose sole behalf the expenses are incurred.

Subsequent Events

The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

Note 3 Investments

The Plan's assets are almost entirely invested in EIL, a Cayman Islands exempted company. Prior to 2019, the Plan was invested in Class A shares of EIL. Beginning in 2019, these Class A shares were transferred to Class A Series 1 shares which are not subject to the management fee of the annual allocation to the general partner. Any management fees or allocations to the general partner under the Class A shares prior to the transfer were remitted back to the Plan. As of July 2020, the Plan has elected to convert the Class A shares to Class B shares which are not subject to management fee or incentive allocation. EIL invests in a wide range of equity and debt securities, including public securities and other financial instruments. The purpose of EIL is to operate as an investment company and is an open-ended fund. As new investors enter and exit an open-ended fund, shares are issued and redeemed. Amounts deducted from participants' payroll payments are transferred to the Plan's cash account at Wells Fargo Bank, which are in turn transferred to EIL's cash account at Wells Fargo Bank on a quarterly basis.

During the 2024 financial year, the Plan's investments (including gains and losses on investments bought and sold, as well as held, during the year) appreciated in value by \$43,717,139. EIL employs a multi-strategy trading approach that encompasses a broad range of strategies, including, without limitation: equity-oriented, private equity and private credit, distressed securities, non-distressed debt, hedge/arbitrage, real estate-related securities, commodities trading and portfolio volatility protection.

Note 4 Disclosures About Fair Value of Plan Assets and Liabilities

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

Level 1 - Quoted prices in active markets for identical assets or liabilities

Level 2 - Observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities

Level 3 - Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

There have been no changes in the methodologies used at December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 Related-Party and Party -in- Interest Transactions

Parties-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

EIL is a limited partner in Elliott International L.P. (“EILP”), a Cayman Islands exempted limited partnership. EIMFL LLC serves as Plan sponsor, for which it does not receive any compensation. Elliott Management Corporation also provides administrative services to Elliott International Capital Advisors Inc., EILP’s investment manager, and other related entities. The Plan’s trustee is paid by the Group for its services to the Plan.

EIL may impose a capital surcharge on capital subscriptions and redemptions and subjects its shareholders to certain restrictions on redemptions. As a shareholder in EIL, the Plan is subject to the same (or more favorable) terms as other investors in EIL.

Note 6 Plan Termination

It is the intention of the Group to continue the Plan indefinitely. However, the Group has no contractual obligation to continue the Plan. In the event of Plan termination, the trustee would handle the distributions of account balances under the provisions of ERISA until all assets have been administered and distributed by the trustee.

Note 7 Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by The Retirement Advantage Inc. This prototype plan document has been filed with the appropriate agency. The Plan has obtained a determination letter dated June 30, 2020. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress

Note 8 Risks and Uncertainties

All financial instruments are subject to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain financial instruments, it is at least reasonably possible that changes in the values of these instruments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. The Plan's investments consist entirely of shares of EIL, which in turn invests solely in EILP, an investment partnership that trades in a diversified portfolio of financial instruments including, without limitation, equities, debt securities, and derivatives.
