### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of SharpSaver Defined Contribution Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). ## Notes to Financial Statements

### 1. Description of Plan

The following description of the SharpSaver Defined Contribution Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan documents for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan covering all eligible employees of Sharp HealthCare (the Principal Employer) and certain of its affiliated entities (the Affiliated Entities) that have met certain eligibility requirements. Eligible employee must be full- time, part- time, or per- diem employees.

The Plan provides employees with a salary deferral option pursuant to Section 401(a) of the Internal Revenue Code (the Code). The Principal Employer serves as the administrator of the Plan. The Plan engages Russell Investment Trust Company (Trustee) to hold and invest Plan assets and execute Plan transactions. The Plan is subject to the provisions of the Employees' Retirement Income Security Act of 1974, as amended (ERISA).

The Affiliated Entities, each of which is owned or managed by the Principal Employer, that also sponsor the Plan are as follows: Sharp Grossmont Hospital, Sharp Memorial Hospital, Sharp Chula Vista Medical Center, Sharp Health Plan, and Sharp Coronado Hospital and Healthcare Center. The Principal Employer and the Affiliated Entities are referred to together herein as the "Employers".

#### *Contributions*

Eligible employees may elect to defer up to 100% of eligible compensation after reductions for tax withholding, wage garnishments, deductions for employee benefits and other committed deductions, not to exceed statutory limits.

The Employers are required to make matching contributions equal to 50% of the first 5% of eligible participant's compensation deferred. For employees with 20 or more years of service, the Employers' required matching contribution becomes 80% for employees contributing 5% of eligible pay (as defined in the Plan document).

A participant may, with the consent of the Plan administrator, make a rollover contribution to the Plan that is not matched by the Employers. Rollover contributions are assets transferred to the Plan from a qualified retirement plan in which an employee participated prior to employment with the Employer.

The Employers may make a qualified non-elective contribution (QNEC) on behalf of non-highly compensated employees, to the extent necessary to satisfy the non-discrimination tests. For the year ended December 31, 2024, the Employers' qualified non-elective contribution was \$1,175,963.

Participant contributions are recorded and remitted to the Trustee each bi-weekly period and recorded in the year withheld from a participant's check. Matching contributions for all participants are also remitted to the Trustee each bi-weekly period.

### ***Participant Accounts***

Each participant's account is credited with the participant's contributions, employer contributions, and an allocation of net Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which participants are entitled is the vested portion of their accounts.

### ***Vesting***

Participants are immediately 100% vested in their employee deferral contributions plus actual earnings thereon. Vesting in the Employers' contributions and the earnings thereon, is based on years of service. Years of service for vesting purposes is based upon the completion of 1,000 hours of service within a plan year. Participant vesting is as follows:

Years of Service	Vested Percentage (%)
Less than 1	-
1 but less than 2	25
2 but less than 3	50
3 or more	100

Notwithstanding the preceding vesting schedule, if a participant attains the age of 55, dies, or terminates employment by reason of permanent disability, the Employer matching, and discretionary amounts become 100% vested without regard to years of service.

### ***Forfeitures***

Participants who are not 100% vested will forfeit the nonvested portion of the employers match and the earnings thereon upon termination of employment. Forfeitures will be used to reduce future employer contributions. Forfeitures of \$355,923 were used to reduce employer contributions for the year ended December 31, 2024. The forfeitures account balances were \$344,382 and \$333,880 at December 31, 2024 and 2023.

### ***Payment of Benefits***

Upon termination of service, if the participant's vested account does not exceed \$7,000, and the participant does not otherwise direct the plan administrator, then a distribution will be made through a direct rollover to an individual retirement account (IRA) in the participant's name (outside of the plan). If the participant's vested account balance exceeds \$7,000, the participant may defer receipt of payment according to plan provisions, elect to receive a lump-sum payment, or elect to receive fixed or calculated payments over a period not to exceed 20 years.

### ***Withdrawals***

Active participants may withdraw all or a portion of their account balances attributable to their own contributions. Withdrawals are generally subject to the withholding of income taxes and penalties, as specified by the Code. After making a withdrawal, a participant is prohibited from making contributions for at least six months and from making additional withdrawals for a 12-month period.

### 2. Summary of Accounting Policies

#### *Basis of Accounting*

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP), using the accrual method of accounting.

#### *Use of Estimates*

The preparation of financial statements in conformity with U.S. GAAP requires plan management to make estimates and assumptions that affect the reported amounts and disclosures at the date of the financial statements and reported amounts during the reporting period. Actual results could differ from the estimated amounts.

#### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Payment of Benefits*

Benefits are recorded when paid. At December 31, 2024 and 2023, there were \$2,581,592 and \$3,082,704, respectively, in distributions outstanding on accounts of participants who had elected to withdraw from participation in the Plan but had not yet been paid.

#### *Administrative Expenses*

Administrative expenses of the Plan are paid by the Employers, except for certain expenses that are charged to participant accounts, including certain withdrawal fees, plan administrative fees and investment management fees. Certain investment expenses which are charged within investments are presented net of the appreciation (depreciation) in fair value of investments. All other expenses of the Plan for the year ended December 31, 2024, were paid by the Employers and are excluded from these financial statements.

#### *Contribution Receivable*

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Non-elective/profit sharing contributions are recorded in the relevant period in accordance with the terms in the Plan document.

### 3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividend income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Russell Investments Trust Company, a qualified institution.

### 4. Fair Value of Investments

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

***Mutual Funds*** - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

***Collective Investment Funds (CIF)*** - Valued at the NAV of units of a collective investment fund. The NAV, as provided by the trustee of the CIF, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its

liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the CIF, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. These investments are direct filing entities.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Income Tax Status

The Plan received a favorable determination letter from the IRS dated May 20, 2014. The plan has since been amended; however, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

### 6. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

### 7. Related Party and Party-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by the Trustee or its affiliates. The Plan paid for certain third-party administrator fees, investment advisory, and certain management fees in the form of an expense ratio charged to each investment option are paid by the Plan and deducted from earnings on investments. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.
