Note 1 – Plan Description

The following description of the Lawrence Companies, Inc. Employee Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Lawrence Companies (the “Company”), who are age 18 or older and have completed six consecutive months of service. Employees are automatically enrolled in the Plan at 3% on the first day of the month after satisfying eligibility requirements, unless they elect otherwise. The deferral rate increases 1% annually, to a maximum of 5%. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute any percentage of their compensation, as defined by the Plan, as a pretax or Roth deferral, up to the maximum allowed by law. Participants who have attained age 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants may direct their contributions into various investments offered by the Plan. The Plan Sponsor determines the formula for matching contributions annually. For 2024, participants received a 50% employer match of deferral contributions up to 3% of eligible compensation, plus 25% of the next 2% of eligible compensation deferred. The employer match was suspended in August of 2024. Additional amounts may be contributed at the option of the Company’s Board of Directors. Contributions are subject to certain limitations.

In January 2025, the employer match was reinstated.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, Company contributions, and allocations of Plan earnings (losses) and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s discretionary matching and profit-sharing contributions plus earnings thereon is based on years of continuous service. A participant is 100% vested after five years of credited service.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum distribution or installment payments equal to the value of the participant’s vested interest in his or her account. In addition, in-service withdrawals are permitted upon reaching age 59 ½ or for hardships, as defined in the Plan agreement. For the year ended December 31, 2023, mandatory distributions were required for vested balances of \$5,000 or less when a participant separated from service. This amount increased to \$7,000 or less for the year ended December 31, 2024 under the SECURE 2.0 Act. Vested balances between \$1,000 and \$7,000 are automatically rolled into an IRA.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$30,841 and \$5,770, respectively. Forfeitures may be used to reduce future employer contributions, reduce Plan expenses, or allocated to participants in the Plan. In 2024, \$29,071 in forfeitures were used to pay Plan expenses.

Note 2 – Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Plan fees and administrative expenses are paid by the Plan and Company on a discretionary basis.

Subsequent Events

Subsequent events have been evaluated through October 14, 2025, the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

Level 1 Fair Value Measurements

The fair values of the mutual funds and certain common collective trust funds are based on quoted net asset values of the shares held by the Plan at year end.

Level 2 Fair Value Measurements

The fair value of the Morley Stable Value Fund is based on inputs that are observable for valuing the asset or liability, either directly or indirectly (i.e., interest rate and yield curves observable at commonly quoted intervals, default rates, etc.). Observable inputs include quoted price for similar assets or liabilities in active or non-active markets. Level 2 inputs may also include insignificant adjustments to market observable inputs.

The Morley Stable Value Fund invests in securities that have observable Level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets. While the underlying asset values are quoted prices, the NAV of a unit in this fund is not publicly quoted. Units can be issued and redeemed on any business day at the NAV. All earnings and losses are reflected in the computation of the NAV and are realized by the participant upon withdrawal.

Note 4 – Investment Contract

At December 31, 2024 and 2023, the Plan held investments in the Morley Stable Value Fund. Included in this collective investment trust fund were traditional guaranteed investment contracts, security backed investment contracts, and short-term investments. These contracts are considered to be benefit-responsive and since those contracts are purchased in the open market, are presented at fair value by the Plan. The objective of the Morley Stable Value Fund is to preserve principal and achieve stable returns through a diversified portfolio of high-quality investment contracts. The average yields for the Morley Stable Value Fund were as follows:

The percentage of contributions allocated to the stable value fund are determined by the participants.

Note 5 – Related Party Transactions

Certain administrative functions are performed by employees of the Company. These employees are also Plan participants. No such employee receives compensation from the Plan.

Ascensus, LLC is the recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions. One Digital Investment Advisors, the investment advisor, is also a party-in-interest. The Plan paid \$31,853 and \$20,883 in administrative fees in 2024 to Ascensus, LLC and One Digital Investment Advisors, respectively.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7 – Tax Status

The Plan is adopted under a prototype plan sponsored by Ascensus, LLC, as agent for Ascensus Trust Company. The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the *Internal Revenue Code (IRC)*. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
