Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Essendant 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 1 DESCRIPTION OF THE PLAN

General

Essendant 401(k) Savings Plan (the Plan) is a Section 401(k) plan with a discretionary employer contribution component. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. A brief description of the Plan is provided for general information purposes only. Participants should refer to the Plan document for more complete information, including funding, vesting, distributions, loans, and investment options.

Eligibility and Participation

The Plan covers substantially all full-time Essendant Co. (the Company) employees who are not covered by a collective bargaining agreement, unless the bargaining agreement provides for participation. Employees are eligible to participate on the first day after completing a consecutive 30-day period of employment with the Company.

Administration

The Company is the Plan Administrator and Plan Sponsor. Investment and policy decisions related to the Plan are the responsibility of the Company's Administrative and Investment Committees. Fidelity Management Trust Company (Fidelity) is the Trustee of the Plan.

Contributions

The Company and its Plan participants fund the Plan's contributions. Participants may elect to make pre-tax contributions of up to 75% of their eligible compensation, limited to the Internal Revenue Service (IRS) cap on pre-tax deferrals. In addition, participants may make after-tax contributions ranging from 1% to 10% of eligible compensation. Participants may also contribute amounts representing distributions from other qualified plans.

Additionally, employees who have reached age 50 during the Plan year may make catch-up contributions ranging from 1% to 75% of their eligible compensation, limited to \$7,500 in 2024.

The Plan provides for eligible participants to enroll automatically. Participants shall be deemed to have entered into a salary deferral agreement, whereby the Company will withhold and contribute an amount equal to 4% of their compensation. However, participants may revoke or amend such salary deferral agreement in accordance with the Plan document.

The Plan provides for a discretionary matching contribution by the Company. For 2024, the Company matched 50% of the first 8% contributed by participants.

Investments

Participants may direct all contributions to be invested in any of the Plan's investment options offered by Fidelity.

Participant Accounts

Each participant's account is credited with their contributions, the Company's contributions, and an allocation of the Plan's earnings, if any. A participant's account is charged with withdrawals, administrative expenses, and an allocation of the Plan's losses, if any. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company's contributions plus actual earnings thereon is based on the number of years of continuous service. Generally, participants become vested at a rate of 20% per year over five years. Participants who attain normal retirement age of 65, die, or become disabled, as defined, are vested immediately in the Company's contributions.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts amounted to \$400,660 and \$540,766, respectively. These amounts can be used to reduce future Company matching contributions and pay plan expenses. During 2024, forfeitures of \$621,787 were used to reduce contributions. No forfeitures were used to pay plan expenses.

Benefit Payments

Upon retirement, death, termination, or disability, participants or their beneficiaries receive a lump-sum payment or installment payments, which span over a period not to exceed 10 years or the participants' or participants' joint beneficiary's life expectancy.

NOTE 1 DESCRIPTION OF THE PLAN *(continued)*

Notes Receivable from Participants

Participants may apply for a loan up to 50% of their vested account balance, limited to a maximum of \$50,000. The Plan allows for a participant to only have one loan outstanding at a time. Loans are secured by the participant's vested account balance and bear interest at the prevailing interest rate established at the time the loan is approved. The Investment Committee establishes fixed interest rates which are reviewed on a quarterly basis in accordance to the Reuter's rate to ensure that loan recipients are being charged a reasonable rate. Both principal and interest are paid ratably through payroll deductions ranging from one to five years or, in the case of the purchase of a primary residence, the term may be extended to 10 years, as agreed to by the Administrative and Investment Committees.

NOTE 2 SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by its investment advisors, custodian and trustee. See Note 4 for further discussion and disclosures related to fair value measurements.

NOTE 2 **SIGNIFICANT ACCOUNTING POLICIES** *(continued)*

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation in fair value of investments includes the Plan's gains and losses on investments bought, sold, and held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator determines that a distributable event has occurred, the participant loan balance is reduced and a benefit payment is recorded. Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule, schedule H, line 4i—schedule of assets (held at end of year).

Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the participant contributions are withheld from compensation.

Benefits

Benefits are recorded when paid.

Administrative Expenses

Recordkeeping and trustee fees are paid by the Plan; all other administrative expenses of the Plan are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Expenses relating to purchases, sales, or transfers of the Plan's investments are deducted from the particular investment fund to which the expenses relate. The loan fees and distribution fees are paid by the participants.

Subsequent Events

Management evaluated subsequent events for the Plan through October 10, 2025, the date the financial statements were available to be issued.

NOTE 3 INFORMATION CERTIFIED OR PROVIDED BY FIDELITY

NOTE 4 FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy and prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

NOTE 4 FAIR VALUE MEASUREMENTS *(continued)*

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level in the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measure. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in methodologies used at December 31, 2024 and 2023.

Valuation methodologies used for each major class of assets measured at fair value are described as follows:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust fund at practical expedient: Valued at NAV of units of the common/collective trust fund. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Common/collective trust fund at readily determinable fair value: Valued based on Vanguard's daily published NAV per unit. The NAV is based upon the fair value of the underlying investments comprising the trust less liabilities.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

NOTE 4 FAIR VALUE MEASUREMENTS *(continued)*

Plan management evaluates the significance of transfer between levels based upon the nature of the investment and size of the transfer relative to the net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

NOTE 5 PLAN TERMINATION

Although it has not expressed any such intent, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon the termination or partial termination of the Plan, participants become fully vested in their account balances. The assets of the trust fund shall be liquidated and distributed in accordance with the terms of the Plan, the Internal Revenue Code (IRC), ERISA, and applicable regulations issued thereunder.

NOTE 6 TAX STATUS

The Plan has received a determination letter from the IRS dated December 14, 2016, stating that the Plan is qualified under Section 401(a) of the IRC, and, therefore, the related trust is exempt from taxation. Subsequent to this determination by the IRS, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan, as amended, is qualified and that the related trust is tax-exempt.

U.S. GAAP requires that Plan management evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more-likely-than-not, based on the technical merits, to be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 RISKS AND UNCERTAINTIES

Plan participants are able to invest in various investment securities that are exposed to risks, such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term. The changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 PARTY-IN-INTEREST TRANSACTIONS

The Plan holds certain investments which are managed by Fidelity, the Trustee of the Plan. The Plan also invests in certain mutual funds managed by Fidelity. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA. Fees paid by the Plan to Fidelity were \$161,111 for the year ended December 31, 2024.

NOTE 9 SUBSEQUENT EVENTS

Effective January 1, 2025, the Plan was amended to exclude interns who have not completed 1,000 hours of service in a plan year, as eligible employees.
