Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Mountain Capital Partners 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Mountain Capital Partners 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Mountain Capital Partners 401(k) Plan Notes to Financial Statements

Note 1 – Description of Plan

The following description of Mountain Capital Partners 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of Plan provisions. In 2017, the Plan name changed from Purgatory Recreation Management Retirement Plan to Mountain Capital Partners 401(k) Plan.

In 2023, Mountain Capital Partners, LLC (the Company), acquired Lee Canyon ski resort from POWDR. As part of the acquisition, the employees of Lee Canyon transferred to the Company and were eligible to participate in the Mountain Capital Partners 401(k) Plan, assuming eligibility criteria was met under the definitions of the Plan. Additionally, the investment balances of employees that were included in the acquisition of Lee Canyon, previously held within the POWDR Corp. 401(k) Plan, were transferred to the Plan on December 22, 2023, totaling \$115,792. As of December 31, 2023, these assets were held within the Voya Government Money Market Fund A holding account, as the Plan worked to allocate them to individual participant directed investment options. These investments were fully allocated in January 2024.

In May 2024, the Plan amended the adoption agreement, which changed the matching formula. Effective May 1, 2024, the Company matches contributions of 40% of employee contributions up to 5% of eligible compensation deferred to the Plan.

In May 2025, the Plan amended the adoption agreement, which changed the matching formula. Effective May 1, 2025, the Company matches contributions of 50% of employee contributions up to 5% of eligible compensation deferred to the Plan.

General – The Plan is a defined contribution plan and is subject to provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was established under the provisions of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as defined in Section 401(k) of the IRC, for the benefit of eligible employees of Mountain Capital Partners, LLC (the Company). The Company is the Plan's sponsor and serves as Plan administrator.

Eligibility – Employees of the Company are eligible to participate in the Plan upon reaching age 21 and after 30 days.

Contributions

Participant contributions – Each year, participants may contribute between 1% and 100% of pre-tax annual compensation, as defined in the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various pooled separate accounts and an insurance investment contract as investment options for participants.

Mountain Capital Partners 401(k) Plan Notes to Financial Statements

Employer match and profit-sharing contributions – As stipulated by the Plan, from January 1, 2024 to April 30, 2024, the Company matched contributions of 30% of employee contributions, up to 5% of eligible compensation deferred to the Plan. From May 1, 2024 to December 31, 2024, the Company matched contributions of 40% of employee contributions up to 5% of eligible compensation deferred to the Plan. The Company may also elect to make other discretionary matching and profit-sharing contributions to the Plan. Discretionary matching and profit-sharing contributions are allocated to participants in the same proportion as a participant's compensation bears to the total of all participants' compensation. There were no profit-sharing contributions for the year ended December 31, 2024. Contributions are subject to regulatory limitations.

Participant accounts – Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) plan earnings and losses and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. Participants vest in the Company's contributions based on the following schedule:

A participant becomes 100% vested upon death of the participant, attainment of normal retirement age, or becoming disabled, as defined.

Notes receivable from participants – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan, secured by the balance in the participant's account, and bear an interest rate of prime, plus 2%. The loan must be repaid in equal quarterly installments amortized over the term of no more than five years, unless the loan is for the purchase of a primary residence, in which case the repayment of the loan may not exceed ten years. Notes receivable are subject to certain restrictions as defined by the Plan document and applicable restrictions under the IRC. As of December 31, 2024, the rate of interest on outstanding loans ranged from 4.25% to 9.50%, with various maturities through February 2028.

Payment of benefits – A participant's benefit can be distributed as an installment payment, lump sum, or direct rollover to a qualified individual retirement account or another qualified plan. Under certain circumstances, hardship withdrawal payments are available at the participant's option.

Mountain Capital Partners 401(k) Plan Notes to Financial Statements

Forfeitures – Forfeitures are the non-vested portion of a participant’s account that is lost upon termination of employment. Forfeitures are retained in the Plan and will first be used to reduce future Company matching contributions to the Plan. As of December 31, 2024 and 2023, forfeited amounts used totaled \$41,290 and \$18,550, respectively, and forfeited non-vested accounts totaled \$16,613 and \$39,050, respectively.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

Use of estimates – The preparation of financial statements in conformity with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation – The investments are reported at fair value and contract value. The Plan’s custodian, Voya Institutional Trust Company (Voya), certifies the contract value of the guaranteed investment contract and the fair value of all other investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Contract value is the relevant measurement for assets invested in fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Notes receivable from participants – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan Agreement. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Administrative expenses paid by the Plan may include notes receivable and distribution fees charged to participants’ accounts and administrative Plan fees. Investment related expenses are included in net appreciation in fair value of investments.

Excess contributions payable – Excess contributions payable represent amounts refunded to participants after year end to comply with regulatory contribution limitations.

Subsequent events – Subsequent events are events or transactions that occur after the statements of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statements of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan’s financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statements of net assets available for benefits but arose after the statements of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

Investment contract – The Plan holds a group variable annuity insurance investment contract issued by Voya, which invests in pooled separate accounts, and the Fixed Account (see Note 4) maintained by Voya.

Pooled separate accounts – Units held in pooled separate accounts (PSAs) are valued using the net asset value practical expedient (NAV practical expedient) of the PSA as reported by the account managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding. These pooled separate accounts invest in single mutual funds reflected by the namesake of the account. The mutual funds seek fixed income, capital appreciation, or long-term growth. Each of these underlying funds’ prospectus discloses the investment strategy. These PSAs have no unfunded commitments, or redemption notice period, and are redeemable daily.

Note 4 – Fixed Account

Based on the terms of the group variable annuity insurance investment contract with Voya, certain Plan assets are held in the Fixed Account that is not a segregated fund but is held in the general account of Voya. The value of the Fixed Account reported by Voya is equal to the contract value. The contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Fixed Account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 3%. The crediting rate is reviewed on an annual basis for resetting. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract does not have a scheduled maturity date. The Plan administrator believes that the Fixed Account meets the requirements to be considered fully benefit-responsive.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on Voya's ability to meet its financial obligations, which may be affected by future economic and regulatory developments. Transfers to and from the Fixed Account may be limited at the discretion of Voya; limitations are generally subject to minimum investment balances. Surrender from the Fixed Account is subject to defined payment provisions.

Certain events limit the ability of the Plan to transact at contract value with Voya. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the Plan's ability to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

Note 5 – Tax Status

The Plan document is a prototype non-standardized profit-sharing, defined-contribution plan that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the plan, as then designed, was in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statements of net assets available for benefits.

Note 7 – Certified Investment Information

The following information related to investments was obtained by management and agreed to or derived from information certified as complete and accurate by Voya, a qualified institution:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of pooled separate accounts, interest income on the fixed account, and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at end of year).

Note 8 – Party-in-Interest Transactions

Certain Plan investments are managed by Voya. Voya is the custodian of the Plan and, therefore, transactions with these entities qualify as exempt party-in-interest transactions.

Note 9 – Plan Termination

Although it has not expressed any intention to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time. If the Plan is terminated, amounts allocated to a participant's account become fully vested.
