

Normal Retirement Benefit: The Normal Retirement Benefit shall equal the Accrued Benefit as of December 31, 2023 plus the Applicable Percentage of such Participant's Average Annual Compensation, multiplied by his Years of Credited Service subsequent to December 31, 2023. The Applicable Percentage for each Participant shall be determined as set forth below:

Average Annual Compensation: Average over highest three (3) consecutive years of service.

Normal Retirement Age: Later of age 62 or the 5th anniversary of the date he commenced participation in the Plan, whichever is later.

Accrued Benefit: The Normal Retirement Benefit accrued as of the date of separation from employment.

Ancillary Benefits:
