Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). As further discussed in Note B to the financial statements, the Plan Trustees terminated the Plan on June 28, 2024, and management determined that liquidation is imminent. As a result, the financial statements are presented on the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

NOTE A - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The audited financial statements of the Peripheral Vascular Associates 401(k) Plan are maintained on the liquidation basis of accounting for the years end December 31, 2024 and December 31, 2023 in accordance with U.S. generally accepted accounting principles.

Investment Valuation and Income Recognition: Investments are reported at fair value of the underlying investment. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Participants' Notes Receivable: Participants' notes receivable are stated at their unpaid principal balance plus any accrued interest. Interest is recognized as accrued. An allowance was not required at either year end. If a participant ceases to make a note repayment and the Plan administrator deems the participant note to be in default, the note balance is reduced and a benefit payment to the participant is recorded.

Benefit Payments: Benefits are recorded when paid.

Subsequent Events: Subsequent events have been evaluated by management through the date of the independent auditor's report, the date the financial statements were available to be issued. Material subsequent events, if any, are disclosed in a separate footnote to these financial statements.

Use of Estimates: The preparation of financial statements in conformity with the liquidation basis of accounting requires estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from these estimates.

NOTE B – PLAN TERMINATION AND LIQUIDATION BASIS OF ACCOUNTING

The Plan Sponsor ceased operations and the trustees elected to terminate the plan effective June 28, 2024. Accordingly, the Plan's financial statements as of December 31, 2024 and December 31, 2023 have been prepared on the liquidation basis of accounting. The liquidation basis of accounting is considered appropriate when, among other things, liquidation of an entity is probable, and the net realizable value of assets are reasonably determinable. Under the liquidation basis of accounting, assets are stated at their estimated net realized cash value and liabilities are stated at their anticipated settlement accounts. The estimated net realizable value for investments as of December 31, 2024 and December 31, 2023 is fair value.

NOTE B – PLAN TERMINATION AND LIQUIDATION BASIS OF ACCOUNTING – continued

Plan assets will continue to be held on behalf of participants and their beneficiaries until distributed in accordance with the Plan terms. Contributions under the Plan are permanently discontinued. Participants as of June 28, 2024, are 100% vested in their accounts.

NOTE C - DESCRIPTION OF THE PLAN

The following description provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan, established September 1, 1975, covering virtually all employees of Peripheral Vascular Associates (the Plan Sponsor) who have one year of employment and 1,000 hours of service within 12 consecutive months. The Plan is for the exclusive benefit of its participants and their beneficiaries. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Plan Restatement: The Plan was restated effective January 1, 2022, and has been amended with required regulatory changes including the most recent hardship distribution provisions and the SECURE 1.0 Act, and CARES act of 2020.

SECURE 2.0 Act: The Securing a Strong Retirement Act (SECURE 2.0 Act) was signed into law on December 29, 2022, and includes mandatory and optional provisions with varying effective dates in 2024 and later.

Contributions: Participants may contribute pretax from their annual compensation, as defined in the Plan. Participants direct the investments of their contributions into various investment options offered by the Plan. Participants may also contribute amounts representing distributions ("rollovers") from other qualified defined benefit or contribution plans. The Plan Sponsor may contribute a matching contribution as determined each year by its Board of Directors up to 5% of annual compensation. The Plan Sponsor, at its discretion, may also make a profit-sharing match.

Participant Accounts: Investments are participant directed. Each participant's account is allocated a percentage of a) the Plan Sponsor contributions, b) Plan earnings, and c) charged administrative expenses. Allocations are based on the participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are 100% vested at all times in their voluntary contributions and actual earnings thereon. A participant's interest in the discretionary contributions the employer makes to the Plan becomes 100% vested upon attaining the Plan's normal retirement age or if employment is terminated due to death or disability. If employment is terminated prior to normal retirement age for any reason other than death or disability, then the employee's interest in employer contributions becomes 100% vested following six years of employment in accordance with specific vesting schedules based on years of service as required by the Department of Labor Rules and Regulations.

NOTE C - DESCRIPTION OF THE PLAN - continued

Forfeitures: At the election of the Plan Sponsor, forfeitures may be used to pay administrative expenses of the Plan or allocated to participants. Forfeited non-vested accounts totaled \$0 at December 31, 2024 and 2023. The Plan used approximately \$22,789 in 2024 and \$102,800 in 2023 in forfeitures.

Participants' Notes Receivable: Participants may borrow from their fund accounts a minimum of \$500, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Interest rates are established daily by the Trustee. Principal and interest is repaid at least quarterly by payroll deduction.

Investment Options: Upon enrollment in the Plan, a participant may change their investment options daily and direct employee contributions in several investment options.

Payment of Benefits: Payment of the vested account balance is immediate when the participant reaches normal retirement age, dies or terminates employment. If the total vested account balance is less than \$5,000, the participant may receive a single lump sum payment. If the vested account balance is equal to or greater than \$5,000, various payment options are available and are described more fully in the Plan agreement. Hardship withdrawals are available to the Plan participants upon approval by the Plan Committee.

Tax Status: Peripheral Vascular Associates 401(k) Plan has adopted a volume submitter profit sharing plan with CODA. The volume submitter profit sharing plan has been approved by the Internal Revenue Service as qualifying under Section 401(a) of the Internal Revenue Code (IRC). The Plan has been amended since it was adopted; however, the Plan administrator believes the Plan is appropriately designed and is currently being operated in compliance with applicable requirements of the IRC. Management is not aware of any tax positions that would have a significant impact on its financial position. Its federal tax returns for the last four years remain subject to examination.

GAAP requires Plan management to evaluate tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023 there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the statute of limitations for the IRS to assess taxes on a plan expires three years from the due date of the return or the date on which it was filed, whichever is later.

The remaining investments and participant notes receivable totaling \$2,724,312 at December 31, 2024 and \$15,577,669 at December 31, 2023 are held in self-directed brokerage accounts and were not certified by the custodian. Income (loss) on these investments and participant notes receivable totaled \$1,092,438 in 2024 and \$3,468,345 in 2023. Auditing procedures applied to these investments were in accordance with U.S. generally accepted auditing standards (*non-section 103(a)(3)(C) procedures*).

NOTE E - TRANSACTIONS WITH PARTIES-IN-INTEREST

A related party is any party who can control or significantly influence Plan management or operating policies. Parties-in-interest are defined under DOL regulations as any employees of the Plan, fiduciaries of the Plan, service providers to the Plan, the employer whose employees are covered by the Plan, and certain significant owners of the employer and their relatives. Service providers may include, but are not limited to, the custodian, trustee, third-party administrator (TPA), investment managers, investment advisors, legal counsel, and Plan auditor.

During the year ended December 31, 2024 and 2023, the Plan made direct payments to certain parties-in-interest for administration and investment advisory fees, as allowed by ERISA. The Plan sponsor pays directly any other fees related to the operation of the Plan.

Fees incurred by the Plan for the investment management services are included in the net appreciation in fair value of the related investment, as they are paid using investment earnings rather than a direct payment.

NOTE F - FAIR VALUE MEASUREMENTS

In accordance with U.S. generally accepted accounting principles, the Plan utilizes a fair value hierarchy that prioritizes the inputs for the valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets
 - quoted prices for identical or similar assets or liabilities in inactive markets
 - inputs other than quoted prices that are observable for the asset or liability
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means
 - if the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Following is a description of the valuation methodologies used for various types of assets measured at fair value:

Pooled separate accounts: Valued at the quoted prices of the underlying investments (mutual funds) in the active market.

Self-directed brokerage accounts:

Cash and certificates of deposit: Valued at the contribution plus applicable interest.

Common stocks, mutual and exchange trade funds: Valued at the closing prices reported on the active market on which the individual securities are traded.

Government and Corporate bonds: Valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields currently available on comparable securities of issuers with similar credit ratings.

Alternative investments: Estimated based on appraisals or similar valuation techniques.
