Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Therapy Center of JDP 401(k) P/S (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS

Note 1. Description of Plan

The following description of The Therapy Center of JDP 401(k) P/S Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement, which was restated and amended March 26, 2022, for a more complete description of the Plan's provisions.

- A. General. The Plan is a defined contribution plan covering substantially all employees of The Therapy Center of Jeff Davis Parish, Inc. or its affiliates, who have adopted the plan, (the "Company") who are 18 years of age. During 2013, the Company amended its service eligibility requirement from completion of one consecutive month of service to completion of three consecutive months of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- B. Contributions. Each year, participants may elect to defer a percentage or flat dollar amount not to exceed the limit of the IRS yearly maximum. Participants' elective deferral contributions will begin on the first day of the month coinciding with or next following the date in which an employee meets eligibility requirements. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company may make a matching contribution to the Plan. Effective January 2012, the Company decreased the discretionary matching contribution from 3% to 1% of compensation that a participant contributes to the Plan. Contributions are subject to certain limitations set by law. The Company offers profit sharing contributions with eligibility requirements. Employee must be actively employed on the last day of the Plan year and must have completed at least 1,000 hours of service during the Plan year. The profit sharing contribution is discretionary and the amount is determined by the Company.

- C. Participant Accounts. Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- D. Vesting. Participants are immediately 100% vested in their contributions plus actual earnings and rollovers. Vesting in the Company's matching and profit sharing contribution portion of their accounts is based on vesting years of continuous service. During 2014, the Company amended its matching vesting from a participant being 100% vested at six years of credited service to a participant being 100% vested at three years of credited service.
- E. Notes Receivable from Participant. Under the terms of the Plan, participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to \$50,000 or 50%, whichever is less, of their vested account balance reduced by any outstanding loan balance. Loans are secured by the balance in the participants' accounts and bear interest at a rate reasonable at the time of application. Principal and interest is paid ratably through payroll deductions.

NOTES TO FINANCIAL STATEMENTS

- F. **Payment of Benefits.** On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive either a lump-sum amount equal to the value of the vested interest in his or her account or in partial withdrawals.
- G. **Investment Options.** Upon enrollment in the Plan, a participant may direct contributions in any of the investment options permitted under the Plan. Participants have the ability to change their investment option at any time they choose.
- H. **Forfeited Accounts.** At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,128 and \$68, respectively. These accounts will be used to reduce future employer contributions. Also, in 2024, employer contributions were reduced by \$3,598 from forfeited non-vested accounts.

Note 2. Summary of Accounting Policies

Basis of accounting:

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results may differ from those estimates.

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Investment valuation and income recognition:

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTES TO FINANCIAL STATEMENTS

Payment of benefits:

Benefit payments to participants are recorded when paid.

Expenses:

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) in the fair value of investments. Fees for administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

Date of management's review of subsequent events:

Subsequent events were evaluated through October 10, 2025, which is the date the financial statement was available to be issued.

Note 3. Investments (Participant-Directed)

Unaudited Information Certified by the Plan Custodian

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, LLC, the agent on behalf of Ascensus Trust Company and Newport Trust Company, LLC, qualified institutions and custodians of the Plan. The Plan Administrator has obtained certifications from the custodian that information provided to the Plan Administrator by the custodian related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 25020.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and ERISA-required supplemental schedule related to the following assets:

NOTES TO FINANCIAL STATEMENTS

Note 4. Fair Value Measurements

The fair value measurement accounting standards establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1) and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There were no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

Level 1 Fair Value Measurement

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered actively traded.

The Plan's policy is to recognize transfers of investments into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024, there were no transfers of investments into or out of Level 3.

NOTES TO FINANCIAL STATEMENTS

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will have a 100% vested interest in their accounts and all accounts will be available for distribution as soon as practical.

Note 6. Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2020.

Note 7. Related Party Transactions and Parties in Interest Transactions

Parties in interest as defined under ERISA include persons and entities such as the Plan sponsor, employers and Plan administrators, custodian and plan auditors among others. As custodian- Ascensus held all Plan investments throughout the year. In addition, the third party administrator providing recordkeeping services was Ascensus and is also considered to be a party-in-interest. Administrative fees paid to Ascensus totaled \$51,627 for the year ended December 31, 2024.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
