## INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees and Management  
BankWest 401(k) Plan  
Pierre, South Dakota

### **Report on the Financial Statements**

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of BankWest 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

#### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

#### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements were available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements, are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures related to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain other internal control-related matters that we identified during the audit.

***Supplemental Schedule Required by ERISA***

The supplemental schedule of Assets Held at End of Year is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

#### **(1) Summary of Significant Accounting Policies**

##### **Nature of Business of Plan Sponsor**

BankWest, Inc. (the Company) is a commercial bank based in South Dakota. The Company provides installment, commercial, and agricultural loans and offers insurance and trust services to customers located primarily in South Dakota.

##### **Basis of Accounting**

The financial statements of BankWest 401(k) Plan (the Plan) are prepared using the accrual method of accounting.

##### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the financial statements and accompanying notes. Actual results could differ from those estimates.

##### **Risks and Uncertainties**

The Plan provides for various investment options. Investments are exposed to various risks, such as interest, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

##### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value on a recurring basis as determined by the Trustees (Notes 4 and 7). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded when received. Dividends are recorded on the ex-dividend date.

##### **Net Change in Fair Market Value of Investments**

The net appreciation (depreciation) in fair market value of investments is composed of the realized gains and losses in securities that were sold or otherwise disposed of during the year and the unrealized gains and losses in securities held at the end of the year.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Subsequent Events**

The Plan has evaluated subsequent events through October 14, 2025 the date which financial statements were available for issue.

#### **(2) Plan Description**

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution plan covering substantially all employees of BankWest, Inc. The Plan, and the trust of which it is a part, are intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code and similar state tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### **Eligibility**

The Plan requires employees of the Company to attain age 21, complete one year of service and work 1,000 hours before becoming eligible to receive employer matching or discretionary profit-sharing contributions.

##### **Contributions**

Each year participants may contribute a percentage of their annual compensation, as defined in the Plan, subject to certain IRS limitations. The Plan provides for discretionary matching contributions by the Company equal to 25 percent of the participant's elective deferral contributions not exceeding 6 percent of their pretax annual compensation. The Plan also allows for additional discretionary profit-sharing contributions by the Company. The Company's profit-sharing contribution was approximately 2 and 4 percent of eligible compensation for the years ending December 31, 2024 and 2023, respectively. Additional amounts may be contributed at the option of the Company's Board of Directors. Contributions are subject to certain limitations. Participants may rollover amounts representing distributions from other qualified defined benefit or contribution plans.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 6 percent of eligible compensation and their contributions invested in the AT LifeStyle Moderate fund until changed by the participant.

The Plan allows Roth elective deferrals. Contributions to Roth 401(k) accounts are made on an after-tax basis and contributions to a Roth 401(k) account are included in the participant's gross income. Future distributions of Roth elected contributions and earnings thereon will not be taxed, if certain criteria are met. Roth elective deferrals to the Plan are permanently designated as Roth elective deferrals in participant accounts. The participant's Roth deferrals and gains and losses attributable to such deferrals are accounted for separately.

##### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's matching contribution, (b) the Company's profit sharing contribution, (c) Plan earnings or losses, (d) forfeitures of terminated participants' non-vested accounts, and (e) charged with distribution fees, if applicable. Allocations are based on participant earnings or account balances, as defined.

#### **(2) Plan Description**

##### **Vesting**

Participants are immediately vested in their contributions and employer matching contributions plus actual earnings thereon. Vesting in the Company's profit-sharing contributions plus actual earnings thereon is based on years of credited service. A participant is 20 percent vested after one year of credited service, and continues to vest at the rate of 20 percent for each successive year of service. A participant becomes fully vested after five years of credited service, or if less than five years, upon reaching normal retirement age, upon total disability, death, or upon termination of the Plan.

##### **Forfeitures**

Forfeited, non-vested account balances were \$19,320 and \$4,967 at December 31, 2024 and 2023, respectively. The Plan allocates forfeitures to remaining participant accounts, to pay administrative costs of the Plan, or to reduce employer contributions. Forfeited balances reallocated to remaining participants and used to offset employer contributions totaled \$5,221 for the year ended December 31, 2024.

##### **Investment Options**

Participants may change their investment options at any time throughout the year. Upon enrollment in the Plan, a participant must direct participant, employer matching contributions and the portion of the profit sharing contributions not allocated to the South Dakota Bancshares, Inc. common stock, to selected investments made available and determined by the Plan Administrator through the American Trust, held in a common collective trust fund. The Plan's appointed Trustees direct the investment of the South Dakota Bancshares, Inc. common stock pertaining to the profit sharing provision of the Plan.

##### **Payment of Benefits**

Participants with benefits in excess of \$5,000 may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants with benefits not greater than \$5,000 may receive a rollover distribution into an individual retirement account set up by the Plan Administrator upon termination of employment, death, disability or retirement. The Plan also allows in-service withdrawals, subject to Plan provisions. Benefits are recorded when paid.

##### **Administrative Expenses**

The Company pays for certain administrative expenses pertaining to the Plan. Certain administrative functions are performed by officers and employees of the Company. No such officer or employee receives compensation from the Plan. The Company has, at its discretion, absorbed certain other administrative expenses pertaining to the Plan. If not paid by the Company, these administrative expenses become the responsibility of the Plan.

**(3) Income Tax Status**

South Dakota Bancshares, Inc. is tax structured as a C-Corporation. As a Subchapter C filer, South Dakota Bancshares, Inc. is responsible for income taxes due.

Effective January 1, 2021, the Plan adopted a non-standardized form of prototype plan sponsored by Corporate Benefit Administrators. The prototype plan received an opinion letter from the Internal Revenue Service as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by the Plan. The Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**(4) Investments - Information Certified by Trustees**

The Plan's investments are held by American Trust and BankWest, Inc. Trust Department, the Trustees. The Plan Administrator has obtained certification from the Trustees that the investment assets, transactions, income, and schedule of investments are complete and accurate.

In accordance with Section 2520.103-8 of the United States Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan administrator has received certification from the Trustees as of and for the years ended December 31, 2024 and 2023 as to the accuracy and completeness of certain financial information of the Plan. Information contained in the following has been certified by the Trustees:

Market volatility of equity-based investments may substantially impact the value of such investments at any given time. It is possible that the value of the Plan's investments, both in total and in individual participant accounts, has changed significantly since December 31, 2024.

During plan years ended December 31, 2024 and 2023, no new shares were issued. During the year ended December 31, 2024, the Company repurchased and retired 150 shares of common stock at fair market value of \$1,499,370. **(6) Participant Withdrawals**

Vested, undistributed account balances of separated Plan participants totaled approximately \$18,061,000 and \$18,634,000 at December 31, 2024 and 2023, respectively.

**(7) Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level One: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level Two: Inputs include
  1. quoted prices for similar assets or liabilities in active markets;
  2. quoted prices for identical or similar assets or liabilities in inactive markets;
  3. inputs other than quoted prices that are observable for the asset or liability;
  4. inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level Three: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following methods and assumptions were used to determine fair value:

*South Dakota Bancshares, Inc. Common Stock:* The fair value is based on an independent appraisal which considered the nature and history of South Dakota Bancshares, Inc., the competitive and economic outlook for the trade area, the banking industry in general, and the financial condition of South Dakota Bancshares, Inc. among other factors.

*Common Collective Trust:* The underlying investments of the Common Collective Trust are primarily contracts that are backed by high-quality bonds, bond and securities trusts, and mutual funds. The investments are valued based on the aggregate market values of the included investments.

*Money Market:* Valued at \$1 per share.

**(8) Related Party Transactions**

Fees for legal and professional services rendered to the Plan may be paid by the Company at its discretion. The Plan invests in Company common stock. One of the Plan's trustee is also a party-in-interest under ERISA. Certain Plan investments are managed by and funds of American Trust Company. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**(9) Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their account balance.
