Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of 403(b) Thrift Plan of Girl Scouts of Greater Los Angeles (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the 403(b) Thrift Plan of Girl Scouts of Greater Los Angeles (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan under Section 403(b) of the Internal Revenue Code (the "Code") covering all eligible employees of Girl Scouts of Greater Los Angeles (the "Organization"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees.

Eligibility: Employees may enter the Plan on the first day of each pay period and there is no minimum age or service requirement to contribute to the Plan. Employees are eligible to receive Organization contributions the first day of the month after completing one year of employment with a minimum of 1,000 hours of service and must be age 21 or older.

Contributions: Each year, participants may elect to contribute up to 100% of their pre-tax annual compensation, as defined in the Plan. However, contributions are subject to certain Internal Revenue Service ("IRS") limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Based on the participant's elections, contributions and income are invested in the Mutual of America General Account and Mutual of America Separate Account No. 2 ("Separate Account No. 2"). Contributions to the Separate Account No. 2 are allocated to Separate Account Funds that correspond to the name of an underlying mutual fund. Contributions must be made in whole percentages and allocations can be changed at any time.

There are no Organization matching contributions under the Plan; however, the Organization may make a discretionary contribution. Discretionary contributions are to be allocated based on a percentage of employee compensation to total compensation. For the year ended December 31, 2024, the Organization made a contribution to the Plan of \$278,196. Participants also direct the investment of Organization contributions.

Participant Accounts: Each participant's account is credited with the participant's contributions, as well as allocations of the Organization's discretionary contributions and Plan earnings. Allocation of Plan earnings is based on the proportion that each participant account balance has to the total of all participant account balances.

Investment expenses charged by the pooled separate accounts in which the Plan invests are paid directly from the underlying assets of the respective investment and are included in the net appreciation in fair value of the pooled separate accounts in the statement of changes in net assets available for benefits. Substantially all other administrative expenses are paid by the Organization.

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Organization's contribution portion of participants' accounts is based on years of continuous service. A participant is 100% vested after three years of credited service.

NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

Plan Loans: Participants may borrow from Mutual of America Life Insurance Company ("Mutual"), the trustee of the Plan, using their Plan accounts as collateral (see Note 5).

Payment of Benefits: On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a 10-year period. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Accounts with values less than \$1,000 will be distributed to the participant. In addition, hardship distributions are permitted if certain criteria are met.

Forfeited Accounts: Forfeitures of terminated participants' nonvested accounts arising from the Organization's discretionary contributions will be used first to pay certain Plan expenses and then any remaining amount will be used to reduce Organization contributions to the Plan. As of December 31, 2024 and 2023, forfeited balances totaled \$6,042 and \$20,018, respectively. For the year ended December 31, 2024, \$20,162 of the forfeitures were used to reduce employer contributions.

Plan Termination: Although it has not expressed any intent to do so, the Organization has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Organization contributions and earnings thereon.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Organization and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's dividends (if any) and gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Subsequent Events: The Plan has evaluated subsequent events through September 24, 2025, the date the financial statements were available to be issued.

NOTE 3 – CERTIFIED INFORMATION

Certain information related to investments in the accompanying financial statements and ERISA required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividend income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America Life Insurance Company, the trustee of the Plan.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

NOTE 4 – FAIR VALUE MEASUREMENTS (Continued)

Pooled Separate Accounts: The fair values of participation units held in pooled separate accounts are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. Each pooled separate account provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund's net asset value per unit. Eleven of the pooled separate accounts held by the Plan are passively managed funds that invest in a single open-ended mutual fund. The underlying investment composition of these funds are target date mutual funds. The remaining pooled separate accounts are passively managed funds that invest in a variety of funds depending on the specific strategy for each pooled separate account. Generally, the types of funds invested include equity securities, debt securities, common stock, and U.S. government securities. Total pooled separate accounts of \$8,049,886 and \$6,613,913, as of December 31, 2024 and 2023, respectively are held by the Plan.

General Account: The General Account consists of the Interest Accumulation Account and is valued at amortized cost which approximates fair value. Total interest accumulation account balances of \$410,097 and \$375,966, as of December 31, 2024 and 2023, respectively are held by the Plan.

NOTE 5 – PLAN LOANS

Participants are allowed to borrow against their account balance in the form of a plan loan. Plan loans are issued directly from funds owned by Mutual and not directly from the participant's account. Adequate security is required and a portion of the participant's account is reserved, or held in collateral, to cover 120% of the outstanding loan in case of default. The collateral is held in the Mutual General Account (Interest Accumulation Account). As of December 31, 2024 and 2023, the total of outstanding plan loans collateralized by individual participant accounts was \$80,574 and \$78,854, respectively. As of December 31, 2024, there were no plan loans in default. At December 31, 2023, there was one plan loan in default in the amount of \$4,904.

NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Organization. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Organization. The Plan holds units of pooled separate accounts managed by Mutual and an interest accumulation account with Mutual. Mutual is a service provider to the Plan and, therefore, these transactions and the Plan's payment of fees to Mutual qualify as party-in-interest transactions.

NOTE 7 – INCOME TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the IRS Code. The underlying nonstandardized prototype plan obtained its latest opinion letter on March 31, 2017, in which the IRS stated that the nonstandardized prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (the "Code"). The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for Plan participants under Section 403(b). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code.

NOTE 7 – INCOME TAX STATUS (Continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 8 - RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500
