Report of Independent Auditors

To the 401(k) Investment Committee of Cenlar Capital Corporation:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Cenlar Capital Corporation 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes (collectively referred to as the “financial statements”).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTE 1: PLAN DESCRIPTION

A) General

The Plan is a participant-directed, defined contribution plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan Trustees are responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Trustees.

B) Eligibility

An employee is eligible to participate in the Plan if they are at least 21 years of age and may enter the Plan on the first day of the month following their 21st birthday or date of hire.

C) Contributions

The amount participants can contribute to the Plan is subject to an annual limit of the lesser of 60% of eligible compensation or \$23,000 and \$22,500 for 2024 and 2023 respectively for participants under age 50, or \$30,500 and \$30,000 in 2024 and 2023 respectively for participants age 50 or older. Excess contributions above Plan limits are refunded to participants.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Participants are eligible to receive employer-matching contributions after one year of service. Cenlar Capital Corporation (Company) matches 100% of a participant's contribution up to 3% of compensation and 50% of a participant's contribution for the next 2% of compensation. The annual compensation limit was \$345,000 in 2024 and \$330,000 in 2023. The maximum match was \$13,800 in 2024 and \$13,200 in 2023.

D) Funding

Employee contributions are funded through bimonthly payroll deductions, and employer matching is determined and funded monthly.

E) Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions as well as allocations of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

F) Vesting

Participants are fully vested at all times in their contributions and Company contributions and earnings or losses thereon.

G) Investment Options

The Plan currently offers participants a diverse group of investment fund options. The investment selections are made by the participants.

- The Galliard Stable Return Fund - Class C seeks to provide investors with a moderate level of stable income without principal volatility. The Fund is designed for investors seeking more income than money market funds without the price fluctuation of stock or bond funds.
- American Century Investments Inflation Adjusted Bond Fund Investor Class invests 80% of its assets in inflation-adjusted debt securities. It may invest up to 20% of its assets in traditional U.S. Treasury, U.S. government agency or other government securities that are not inflation-adjusted.
- JP Morgan Core Bond Fund Class R6 invests in investment grade bonds and debt securities.
- Fidelity Global ex U.S. Index Fund invests at least 80% of assets in securities included in the MSCI Emerging Markets Index and in depository receipts representing securities included in the index.
- Fidelity Government Money Market Fund Class K6 seeks as high a level of current income as is consistent with preservation of capital and liquidity. The Adviser normally invests at least 99.5% of the fund's total assets in cash, U.S. Government securities and/or repurchase agreements that are collateralized fully.
- State Street S&P 500 Index Fund N seeks to replicate as closely as possible the performance of the Standard & Poor's 500 Index. The Standard & Poor's 500 Index is a well-known stock market index that includes common stocks of 500 companies from a number of sectors and that measures the performance of the large-cap sector of the market.
- Fidelity Blue Chip Growth Fund Class K6 seeks growth of capital over the long term and normally invests at least 80% of assets in blue chip companies.
- Loomis Sayles Small Capital Growth Fund Institutional Class invests in "small-cap companies", including preferred stocks, warrants, securities convertible into common or preferred stocks and other equity-like interests.
- Dodge & Cox International Stock Fund X offers investors a highly selective, actively managed core international equity fund that typically invests in companies in developed markets, (excluding the U.S.), and emerging markets, based on our analysis of companies' fundamentals relative to their current valuations.
- Oppenheimer International Growth Fund Class Y invests in the common stock of growth companies that are domiciled or have their primary operations outside of the United States.
- JP Morgan SmartRetirement Fund Class R5 (2020, 2025, 2030, 2035, 2040, 2045, 2050, 2055) invest in a combination of JP Morgan Funds and is generally intended for investors based upon their targeted retirement date.
- JP Morgan SmartRetirement Income Fund Institutional Class Shares are designed to provide exposure to a variety of asset classes through investments in underlying funds, with an emphasis on fixed income funds.

- American Funds Washington Mutual Investors Fund Class R-6 invest primarily in common stocks of established companies that are listed on, or meet the financial listing requirements of the New York Stock Exchange and have a strong record of earnings and dividends.
- The Fidelity U.S. Bond Index Fund invests at least 80% of the fund's assets in bonds included in the Barclays U.S. Aggregate Bond Index.
- The Loomis Global Bond Fund N will invest in fixed-income securities and its investment objective is high total investment return through a combination of high current income and capital appreciation.
- Goldman Sachs Small Cap Value Fund invests in a diversified portfolio of equity investments in small-cap issuers with public stock market capitalizations within the range of market capitalization of companies constituting the Russell 2000. The fund seeks long-term capital appreciation.
- Carillon Eagle Mid Cap Growth Fund Class R6 invests at least 80% of its net assets in the equity securities of mid-capitalization companies. The fund will invest primarily in the equity securities of companies that have the potential for above-average earnings or sales growth, reasonable valuations and acceptable debt levels.
- Allspring Special Mid Cap Value Fund Class R6 seeks long-term capital appreciation by principally investing in mid-capitalization companies and using a disciplined, consistent process that focuses on valuation and stocks with high reward-to-risk ratios.

H) Payment of Benefits

Distributions of vested benefits normally are made upon a participant's retirement, death or permanent disability and are recorded when paid. Distribution of vested benefits may be made to terminated employees prior to the date such amounts would normally be distributed; however, such earlier distribution is at the election of the terminated employee. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in their account or annual or more frequent installments over a period of time.

I) Plan Termination

Although it has not expressed any intent to do so, the Company has reserved the right to terminate the Plan, to reduce or cease contributions at the discretion of the Company's Board of Directors, or to amend the Plan at any time and in any respect. In the event the Plan should terminate, each Participant affected by such termination shall have a vested interest in his/her account of 100 percent. The Plan Administrator will facilitate the distribution of account balances in single lump sum payments to each Participant in accordance with Plan provisions until all assets have been distributed by the Trustee. Each Participant in the Plan upon Plan termination will automatically become 100% vested in his/her account balance.

J) Notes Receivable from Participants

Participants in the Plan are eligible to borrow from their vested Plan account. Two types of loans are permitted and they include:

1. General-purpose loans – these loans may be used for any allowable purpose and must be repaid within five years.
2. Principal residential loans – these loans are available only for the purchase of the participant's principal residence and must be repaid within a period of ten years.

The maximum amount of the aggregate of all loans outstanding to a participant is the lesser of:

- a. \$50,000 or reduced in accordance with the Plan provisions; or
- b. 50% of the participant's account.

The loans are secured by the balance in the participant's account and bear interest. The interest rate for notes receivable from participants is the prime rate plus one percent at the time of granting of the loan. The interest rate on outstanding notes receivable from participants ranged from 4.25% to 9.50%. Principal and interest is paid ratably through monthly payroll deductions.

K) Withdrawals

During employment, Plan participants are allowed to withdraw all or a portion of their vested account balance provided they attained the age of 59 ½ or they qualify for a financial hardship. A financial hardship withdrawal will prevent participant contributions to the Plan for a six month period.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A) Basis of Presentation

The accompanying financial statements of the Cenlar Capital Corporation 401(k) Savings Plan (the Plan) have been prepared on an accrual basis and present the net assets available for benefits and changes in those net assets.

B) Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

C) Administrative Expenses

Except for participants' transaction charges, the administrative expenses of the Plan are generally paid by the plan sponsor, Cenlar Capital Corporation (the Company). Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's

account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

D) Valuation of Investments and Income Recognition

The Plan's investments are reported at fair value. Mutual funds are stated at fair value based on current market quotations. Collective trust funds are stated at fair value using the net asset value per share of the investment. See Note 5 for further discussion of fair value measurements. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded when earned.

E) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

F) Risks and Uncertainties

The Plan invests in certain investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Plan Benefits.

The Plan's investments may directly or indirectly include securities with contractual cash flows, such as asset backed securities, collateralized mortgage obligations and commercial mortgage backed securities. The value, liquidity and related income of these securities are sensitive to changes in economic conditions, real estate values and delinquencies and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates.

G) Payment of Benefits

Payment of benefits are recorded when paid. At December 31, 2024 there were no balances elected for withdrawal or payment.

H) Related Party and Party-in-Interest Transactions

Fidelity Investments (Fidelity) is the trustee as defined by the Plan and therefore is a party in interest. Notes receivable from participants and certain Plan investments managed by Fidelity qualify as related party transactions. The forgoing transactions are not deemed prohibited party-in-interest transactions, because they are covered by statutory and administrative exemptions for the code and ERISA's rules on prohibited transactions.

NOTE 3: INCOME TAX STATUS

The underlying pre-approved plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the plan is qualified under Section 401 of the Internal Revenue Code (the Code) and, therefore, the related trust is tax-exempt. The plan administrator has determined that it is eligible to, and has chosen to, rely on the current IRS pre-

approved plan opinion letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4: INVESTMENTS

The Plan's investments are held in a trust administered by the Trustee.

NOTE 5: FAIR VALUE MEASUREMENT

The Plan follows FASB ASC Topic 820, *Fair Value Measurement and Disclosures*, which defines fair value, establishes a framework for measuring fair value, and requires disclosures about fair value measurements.

Fair Value is the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust funds: represents fair value units owned by the Plan at NAV based upon the underlying investments of the fund less liabilities as valued by the issuer of the fund divided by the units outstanding. There are no redemption restrictions.

As required, the level in the fair value hierarchy within which the fair value measurement of the asset or liability in its entirety is classified is based on the lowest level input that is significant to the fair value measurement in its entirety. The following table sets forth the plan investment assets at fair value by level within the fair value hierarchy as of December 31, 2024 and 2023:

NOTE 7: SUBSEQUENT EVENTS

In connection with the preparation of the financial statements, the Plan has evaluated subsequent events after December 31, 2024 through October 9, 2025, which was the date the financial statements were available to be issued, and concluded that the change in employer match was required. For the Plan Year 2025, the company's contribution will be made in a lump sum to a participant's account once per calendar year, funded in the first quarter of the following plan year (e.g., the match for 2025 will be funded in first quarter of 2026). You must be a Cenlar employee on December 31st of the plan year to be eligible for the match.
