Report of Independent Auditors

Scope and Nature of the ERISA Section 103(a)(3)(C)

We have performed audits of the financial statements of Premium Transportation Group, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

NOTE 1 -- DESCRIPTION OF PLAN

The following description of the Premium Transportation Group, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a 401(k) salary deferral and profit sharing plan covering employees of Premium Transportation Group, Inc. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility: Employees of the Company are eligible to participate in the Plan upon hiring and attaining the age of 21.

Participant contributions: Participants can elect to have up to 100% of their pre-tax annual compensation contributed to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Participants may designate a portion of their salary deferral as Roth contributions, which are made on an after-tax basis. No after-tax contributions, other than Roth contributions to the Plan are permitted.

Employee contributions: Company contributions to the Plan are made at the discretion of the Company's Board of Directors. The Company may make additional voluntary profit-sharing contributions. The Company elected not to make either a matching or profit-sharing contribution for 2024 and 2023. Contributions are subject to regulatory limitations.

Participant accounts: Each participant's account is credited with the participant's contributions, employer contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into various investment options offered by the Plan.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their account plus actual earnings thereon is based on years of service as follows:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 2 years	0%
2 but less than 3 years	20%
3 but less than 4 years	40%
4 but less than 5 years	60%
5 but less than 6 years	80%
6 years or more	100%

Payment of benefits: On termination of service, death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or optional defined types of annuities. Hardship and other in-service distributions are allowed, as defined in the Plan document. Vested account balances of \$5,000 or less are subject to additional payment provisions, including mandatory distribution of amounts defined in the Plan.

Benefits are recorded when paid.

Notes Receivable from Participants: Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan agreement. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Forfeited accounts: Forfeitures of Company contributions are used first to reduce expenses related to Plan administration and then to reduce employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$0 and \$300, respectively. During December 31, 2024 and 2023, \$300 and \$1,600, respectively, of forfeitures were used.

Plan expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and an allocation of recordkeeping expenses are charged directly to the participant's account and are included in administrative expenses. Investment related expenses for the mutual funds are included in net appreciation (depreciation) of fair value of investments and expenses for the guaranteed investment contract are netted in interest on guaranteed investment contract.

Subsequent Events: Management has performed an evaluation of subsequent events through October 15, 2025, which represents the date the financial statements were available to be issued.

NOTE 2 -- SUMMARY OF ACCOUNTING POLICIES

Basis of accounting: The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America, using the accrual method of accounting.

Investment valuation: The investments are stated at fair value and contract value. The Plan's trustee certifies the contract value of the guaranteed investment contract and the fair market value of all other investments. If available, quoted market prices are used to value investments.

Use of estimates: The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of Plan assets and liabilities, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported increase and decrease of net assets available for benefits during the reporting periods. Accordingly, actual results may differ from those estimates.

NOTE 3 -- CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2023, was obtained by management and agreed to or derived from information certified as completed and accurate by Lincoln National Life Insurance Company.

At the request of the Plan Administrator, the Plan's independent auditors did not perform audit procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information in the financial statements, including reading the disclosures related to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP, and the required supplemental schedules, including assessing whether the supplemental schedules are in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 4 -- TAX STATUS

The Plan utilized a non-standardized prototype plan of Massachusetts Mutual Life Insurance Company. A determination letter, dated April 23, 2002, has been received from the Internal Revenue Service indicating that the non-standardized prototype plan as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2022.

NOTE 5 -- PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 6 -- TRANSACTIONS WITH PARTIES-IN-INTEREST

Lincoln National Life Insurance Company was the trustee of the Plan from January 1, 2022 to December 31, 2024 and accordingly any transactions with them qualify as party-in-interest.

NOTE 8 -- RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9 -- FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

- Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quotes prices for identical or similar assets or liabilities in active markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Pooled separate accounts ("PSA") are privately managed through investment companies and are not publicly quoted. PSAs are comprised primarily of shares of registered companies held through sub-accounts of an insurance company. The PSAs are valued using net asset value ("NAV") as a practical expedient to estimate fair value where NAV is based on the value of the underlying investment assets held through sub-accounts of a separate account of an insurance company. This practical expedient is not used when it is determined to be probable that the account will sell the investment for an amount different than the reported NAV. The Plan has concluded that the NAVs reported by the investment companies approximate the fair value of the investments.

NOTE 10 -- STABLE VALUE FUND

The Plan's investment in the SVF is a group annuity contract issued by Lincoln National Life Insurance Company (Lincoln), which is a fully benefit-responsive investment. Contract value represents the principal invested plus interest earned under the contract. The issuer is contractually obligated to repay the principal at a specified interest rate that is guaranteed to the Plan. The SVF's interest rates are adjusted to market quarterly.

The minimum interest rate under the SVF contract is 1.00%. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The guarantee is based on Lincoln's ability to meet its financial obligations from its general assets. Lincoln's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events that might limit the ability of the Plan to transact at contract value with the contract issuer include the following:

- Plan termination of the contract;
- Plan termination or merger;
- Company layoffs;
- Company mergers; and
- Bankruptcy of the Company

The Plan has made no plans to engage in any of the above events for the near future. No events are considered probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and participants.

Certain transfer limitations may apply to the SVF as described in the contract. However, no transfer restrictions were enacted during 2024.
