### INDEPENDENT AUDITOR'S REPORT

#### Scope and Nature of the ERISA Section 103(a)(3)(C)

We have performed audits of the financial statements of **Attebury Grain, LLC 401(k) Plan** (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from Nationwide Trust Company, FSB as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### Opinion

**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Attebury Grain, LLC 401(k) Plan (the Plan) is provided for general information purposes only. For more complete information, participants should refer to the current Plan documents.

**General**

The Plan is a defined contribution retirement plan which provides for the participation of the employees of the controlled group that includes Rockrose Development Company, LLC, Attebury Group, Inc. and Attebury Grain, LLC (collectively the Company), who have completed one year of service and attained the age of 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended, and is intended to qualify under Section 401(k) of the Internal Revenue Code (IRC). Under the Plan, each participant has an account for his/her salary deferral contributions, any rollover contributions and for Company matching contributions.

**Nationwide Trust Company, FSB** serves as the Plan's recordkeeper and custodian and is responsible for executing all investment transactions.

**Contributions**

Participants may make salary deferral contributions through payroll deductions of up to 100% of their compensation, as defined in the Plan documents (limited to certain amounts under the IRC). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Additionally, the Company makes a contribution of 3% of each participant's annual compensation, as defined by the Plan, to the Plan as a safe-harbor non-elective contribution. The Company may also make additional discretionary contributions if approved by the Company. Employees must attain the age of 21, complete 1,000 hours during the year, and be employed on the first day of the last quarter of the plan year to be eligible for discretionary contributions. Participant and Company contributions are subject to the provisions of the IRC and related regulations. There were no additional discretionary contributions made during 2024.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of (a) Company contributions, if any, and (b) Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on account balances or compensation, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are vested immediately in their salary deferral contributions and the Employer's non-elective contributions, plus actual earnings thereon. Participants vest in the Employer's discretionary profit sharing contribution plus actual earnings thereon gradually beginning with their 2<sup>nd</sup> year of service (20%) ending at their 6<sup>th</sup> year of service (100%).

**Forfeited Accounts**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$10,000 and \$10,000, respectively. Forfeited balances of terminated participants' non-vested accounts are used to reduce the Employer non-elective contribution in the year subsequent to the year in which the forfeitures occur. Approximately \$19,700 in forfeitures were utilized to reduce employer safe harbor contributions during 2024.

**Loans to Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. Loan terms range from 1 to 5 years. The loan interest rate, determined at the time of loan funding, is set at a rate determined by the Plan Administrator based on rates that would be charged by persons in the business of lending money for loans under similar circumstances. As of December 31, 2024, interest rates ranged from 4.25% to 9.50% on participant loans. Principal and interest is paid ratably through payroll deductions.

**Payment of Benefits**

On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his or her account or partial withdrawals or installments but only with respect to minimum required distributions, over a period of not more than your assumed life expectancy (or the assumed life expectancies of the participant and beneficiary).

**Investment Options**

Upon enrollment in the Plan, a participant may direct his/her contributions in any of the investment options currently offered by the Plan's investment custodian. The Plan currently offers various mutual funds and fixed annuities as investment options for participants, as well as the option to invest in self-directed brokerage accounts. Participants may change their investments daily.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Presentation**

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

**Administrative Fees**

Third party investment advisory fees are paid directly by the Plan and allocated to participant accounts. All other costs of the Plan are paid by the Plan's sponsor and are not reflected in these financial statements. Administrative expenses other than the elective investment management fees and investment advisory fees, are included in net appreciation of fair value in investments.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan document.

**Payment of Benefits**

Benefit payments are recorded when paid.

**Contributions**

Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

**Investment Valuation and Income Recognition**

Investments are stated at fair value, as determined by the investment custodian. Investments are recorded at the value reported to the Plan by the Plan's investment custodian. In accordance with stating investments at fair value, net unrealized appreciation or depreciation is reflected for the year on the Statement of Changes in Net Assets Available for Benefits. Notes receivable from participants are reported at amortized cost, which approximates fair value. In accordance with stating assets at fair value, net unrealized appreciation or depreciation is reflected for the year on the Statement of Changes in Net Assets Available for Benefits. See Note 7 for disclosure of fair value measurements.

Gains or losses on security transactions are recorded as the difference between proceeds received and the carrying value of the investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Investment dividends and interest received are reinvested in the corresponding accounts.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes in net assets available for benefits therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Subsequent Events**

The Plan Administrator has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued. See Note 11 for managements evaluation of subsequent events.

**NOTE 3 - INFORMATION CERTIFIED BY INVESTMENT CUSTODIAN**

The following is a summary of the investment information as of December 31, 2024 and 2023, included in the Plan's financial statements and supplemental schedule that was prepared by or derived from information provided by the custodian Nationwide Trust Company, FSB and furnished to the Plan Administrator. The Plan Administrator has obtained a certification from the custodian that the information provided to the Plan Administrator by the custodian related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following assets:

The investment custodian also certified to the completeness and accuracy of \$644,963 of net appreciation in fair value of investments and \$53 of interest and dividends related to the aforementioned investments for the year ended December 31, 2024.

**NOTE 4 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company reserves the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, participants will become 100% vested in their accounts and the Plan assets will be distributed in a manner approved by the Internal Revenue Service.

**NOTE 5 - TAX STATUS**

The Plan has not received a determination letter on their adoption of the pre-approved plan document. In accordance with Revenue Procedure 2003-6, the Plan administrator has chosen to rely on the advisory letter, dated June 30, 2020, that has been issued to the pre-approved plan. Once qualified, the Plan is required to operate in conformity with the Internal Revenue Code (the Code) to maintain its qualification. The Plan administrator believes the Plan is being operated in compliance with applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and has taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2021.

**NOTE 6 - TRANSACTIONS WITH PARTIES IN INTEREST**

At December 31, 2024 and 2023, the Plan had investments held by the custodian and participant loans with a value of approximately \$7,292,000 and \$6,864,000, respectively, which investments are managed by the participants. Thus, transactions within these plan assets qualify as party-in-interest transactions as defined by ERISA.

Administrative fees incurred and paid by the Plan to the administrator and investment advisor aggregated to \$59,209 in 2024. Transactions involving the administrator qualify as party-in-interest transactions.

**NOTE 7 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2            Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Investment Funds:* Value based on the NAV of units of the collective investment fund. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust, less its liabilities.

*Self-directed brokerage accounts:* The fair value of equity securities held in self-directed brokerage accounts is the market value based on quoted market prices, when available, or market prices provided by recognized broker dealers.

In determining the appropriate levels, the Plan performs a detailed analysis of the assets and liabilities that are subject to fair value measurement. The following table summarizes the financial assets and liabilities measured at fair value on a recurring basis at December 31:

**Changes in Fair Value and Related Gains and Losses**

During 2024, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year, interest and dividends) appreciated in value by \$728,715.

**NOTE 8 - FIXED GUARANTEED ACCOUNT WITH NATIONWIDE TRUST COMPANY, FSB**

The Plan maintains a traditional fully benefit-responsive guaranteed investment contract with Nationwide Trust Company, FSB (NW) with an outstanding balance of \$675,642 and \$684,763 as of December 31, 2024 and 2023, respectively. NW maintains the contributions in a general account. The account earns interest at the higher of the rate guaranteed under the contract or the current rates established and declared in advance by NW. Interest rates for new contributions are declared prior to the beginning of a calendar quarter and are applicable to all contributions received in that quarter until the end of the calendar year next following the current year.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by NW, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan’s ability to transact at contract value with participants, is probable.

The Fixed Guaranteed Account has no maturity date and continues until all assets have been distributed, or no further payments are due.

**NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

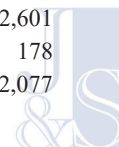
