Opinion

We have audited the accompanying financial statements of the Employee Health and Welfare Benefit Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Employee Health and Welfare Benefit Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

NOTE A - DESCRIPTION OF THE PLAN

The following description of the Employee Health and Welfare Benefit Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a complete description of the plan provisions.

General: The Plan provides health benefits covering eligible employees of The Edward Thomas Hospitality Corporation (the Sponsor) and its affiliates, as defined by the Plan, and their designated dependents. The Plan and related trust were established on September 1, 2010 and began operations on December 1, 2010. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan is a self-funded group health plan but, it carries an excess risk policy.

Benefits: The Plan provides health benefits (medical and prescription) to eligible employees of the Sponsor who work a minimum of 30 hours per week and complete a 90-day employment waiting period. A family member of an employee, as defined by the Plan, becomes eligible for dependent coverage on the first day that the employee is eligible for coverage and the family member satisfies the requirement for dependent coverage.

The Plan also provides medical and prescription benefits to participants during periods of unemployment, pursuant to COBRA, if so elected by the participant.

Participant claims are processed by a third-party administrator. However, the responsibility for payments to participants and providers is retained by the Plan.

Contributions: Funding for benefits is derived from the Sponsor and from contributions made by the covered employees. The Plan offers four benefit options with varying levels of co-payments, covered charges, and employee contributions. Employee contributions to the Plan are based on the benefit option selected and the number of covered dependents.

Receivable from Plan Participants: The receivable from plan participants consists of amounts withheld from participants but not yet remitted to the Plan.

Administrative Expenses: The sponsor absorbs significant costs of plan administration.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared using the accrual method of accounting.

Fair Value: The Plan has adopted FASB ASC 820-10, Fair Value Measurements. ASC 820-10 introduces a framework for measuring fair value and expands required disclosure about fair value measurements of certain assets and liabilities. ASC 820-10 defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. ASC 820-10 also establishes a fair value hierarchy which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The standard describes three levels of inputs that may be used to measure fair value, whereby level 1 uses quoted prices and active markets for identical assets or liabilities when determining fair market value; level 2 uses non active quoted prices for similar assets and liabilities that can be corroborated with market data; and level 3 uses unobservable information with little or no market data. The carrying values of the Plan's assets and liabilities approximate fair value.

Use of estimates: The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan trustees to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, incurred-but-not-reported claims, and claims payable. Actual results could differ from those estimates.

NOTE C - FUNDING AND OPERATION OF THE PLAN

Funding of the Plan: Sponsor contributions to the Plan and employee payroll deductions are held in a non-interest bearing bank account.

Administration: The Plan has contracted with a third-party administrator to provide claims administration, network rental, and utilization review.

The Plan has obtained an excess risk insurance policy for the plan. The insurance reimburses the plan for medical and prescription drug benefits that exceed \$225,000 per covered person during the policy period for the plan years ended December 31, 2024 and 2023, respectively. Reimbursements under the policy totaled \$679,981 and \$41,403 for the plan years ended December 31, 2024 and 2023, respectively.

NOTE D - BENEFIT OBLIGATIONS

Benefit obligations consist of the Plan's liability for claims incurred as of December 31, 2024 and 2023 but not yet reported and the Plan's liability for claims reported of December 31, 2024 and 2023 but not yet processed. The Plan's liability for claims incurred but not reported is estimated by the third-party

NOTE E - CONCENTRATION OF RISK

The Plan manages the deposit concentration risk by placing cash, money market accounts, and certificates of deposit with financial institutions believed by the plan to be creditworthy. At times, amounts on deposit may exceed insured limits or include uninsured investments in money market mutual funds. To date, the Plan has not experienced losses in any of these accounts. Credit risk associated with accounts receivable and promises to give are considered to be limited due to high historical collection rates and because substantial portions of the outstanding amounts are due from members, governmental agencies, and foundations supportive of the Plan’s mission. Investments are made by diversified investment managers whose performance is monitored by the Plan. Although the fair values of investments are subject to fluctuation on a year-to-year basis, the Plan believes that the investment policies and guidelines are prudent for the long-term welfare of the organizations.

NOTE F - INCOME TAXES

Accounting principles generally accepted in the United States of America require the Sponsor to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Sponsor has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods. No interest or penalties from federal or state tax authorities were recorded in the accompanying financial statements.

NOTE G - PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the Plan assets would revert to the Plan Sponsor.

NOTE H - RELATED PARTY

Certain administrative functions of the Plan are performed by officers or employees of the Sponsor. These officers or employees do not receive any compensation from the Plan.

NOTE I - SUBSEQUENT EVENTS

In preparing the financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 9, 2025, the date that the financial statements were available to be issued.
