## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

#### NOTE 1 – DESCRIPTION OF PLAN

The following description of the Ultra Pro International, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all employees of Ultra Pro International, LLC (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Eligibility:** To be eligible to participate in the Plan, an employee must be at least 18 years of age and have completed three months of service. Residents of Puerto Rico, independent contractors, employees whose employment is covered by a collective bargaining agreement, leased employees and certain nonresident aliens with no earned income from sources within the United States are not eligible to participate in the Plan. Employees may enter the plan on the first payroll date feasible but not later than the later of two pay periods or two weeks after the employee completes the eligibility requirements.

**Contributions:** Participants may make voluntary pre-tax or after-tax (Roth) contributions, by means of a salary deferral agreement of up to 100% of their compensation, subject to IRS limitations for the Plan year. The Plan provides for automatic enrollment upon eligibility and, accordingly, employees are treated as having elected 6% of their compensation as a pre-tax 401(k) contribution unless an election is made for a different amount or an election is made not to participate. Plan participants over the age of 50 are also permitted to make additional pre-tax and Roth catch-up contributions up to a maximum of \$7,500 in 2024. The Plan also permits rollover contributions from other qualified pre-tax retirement plans. Participants direct the investment of contributions into various investment options offered by the Plan. The Company makes safe harbor matching contributions equal to 100% of the first 1% of compensation plus 50% of contributions exceeding 1% not to exceed 6% of compensation. The Company may also make discretionary matching, discretionary profit-sharing and qualified non-elective contributions which are determined annually and announced in advance of each Plan year. No discretionary matching, discretionary profit-sharing or qualified non-elective contributions were made in 2024.

**Participant accounts:** Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, if any, and (b) plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting in the Company's safe harbor matching, discretionary matching, discretionary profit-sharing and qualified non-elective contributions, if any, is based on years of service with the Company, based on a two-year cliff-vesting schedule. Participants will become fully vested upon death or total and permanent disability.

**Notes receivable from participants:** The Plan allows participants to obtain loans from the Plan. These loans are subject to the following general provisions: the maximum amount of loans outstanding is equal to the lesser of \$50,000 or 50% of the participant's account balance with a minimum of \$1,000. The term of any loan may not exceed five years unless the purpose of the loan is to purchase the participant's primary residence, in which case the term of the loan may not exceed ten years. The loans are secured by the participant's account balance and bear interest at a rate equal to the prime rate (7.50% and 8.50% at December 31, 2024 and 2023, respectively) on the loan issuance date, plus 1.00%. Principal and interest is paid ratably through payroll deductions.

If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**Payment of benefits:** Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or, in the case of required minimum distributions, payment in annual installments not to extend past the lives or life expectancies of the participant and spouse. In case of hardship, a participant may apply for a distribution, minimum of \$1,000, described in the Plan agreement. Lump-sum distributions are required if the vested balance is \$5,000 or less. Actively employed participants may begin receiving distributions at age 59½.

**Forfeited accounts:** There were no forfeited nonvested accounts at December 31, 2024 and 2023. During 2024, amounts forfeited from accounts totaled \$11,153, all of which was used to reduce Company matching contributions.

## NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of accounting:** The financial statements are prepared on the accrual basis of accounting.

**Use of estimates:** The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain amounts reported in the financial statements and accompanying notes. Accordingly, actual results could differ from those estimates.

**Notes receivable from participants:** Notes receivable from participants are recorded at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are written off when deemed uncollectible.

**Investment valuation and income recognition:** Investments are reported at fair value using methodologies described in Note 3. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date.

Purchases and sales of investments, including gains or losses, are recorded on a trade-date basis. Interest income is recorded when earned, dividends are recorded on the ex-dividend date and capital gain distributions are included in dividend income. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Benefit payments:** Benefit payments to participants are recorded when paid.

**Administrative expenses:** Substantially all administrative expenses of the Plan are paid by the Company, unless otherwise paid for by the Plan, and are included in the statement of changes in net assets available for benefits.

**Subsequent events:** In preparing the financial statements, management has evaluated events and transactions for potential recognition or disclosure through October 10, 2025, the date the financial statements were available to be issued.

### **NOTE 3 – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – inputs to the valuation methodology include:

- a) Quoted prices for similar assets or liabilities in active markets;
- b) Quoted prices for identical or similar assets or liabilities in inactive markets;
- c) Inputs other than quoted prices that are observable for the asset or liability;
- d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value.

1. *Mutual funds (registered investment companies)*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively-traded.

The following table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

#### NOTE 4 – INCOME TAX STATUS

The trust established under the Plan, which holds the Plan’s assets, is qualified pursuant to the appropriate section of the Internal Revenue Code, and accordingly, the trust’s net investment income is exempt from income taxes. The Plan, as adopted, is a pre-approved plan, which does not require an application for a determination letter from the Internal Revenue Service (“IRS”). The pre-approved plan has received a favorable opinion letter from the IRS dated June 30, 2020. The Plan has not individually sought its own determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for the income taxes has been included in the Plan’s financial statements.

## NOTE 5 – INFORMATION CERTIFIED BY CUSTODIAN

In accordance with 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator has elected to restrict the scope of the auditor’s examination with regards to statements or information prepared and certified by Benefit Trust Company. The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified as complete and accurate by Benefit Trust Company, the custodian:

## NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

A certain employee of the Company is the trustee of the Plan, as defined in the agreement. The Plan issues loans to participants, which are secured by the balances in the participants’ accounts. These transactions qualify as party-in-interest transactions.

## NOTE 7 – OPERATIONAL ERROR

During 2024, the Company applied improper compensation base when calculating certain deferrals and employer matching contributions resulting in a missed deferral opportunity. The Company evaluated the missed deferral opportunity and determined that a qualified non-elective contribution totaling \$35,150, plus earnings, is necessary in order to correct the operational error. This amount is included in the employer contribution receivable on the accompanying 2024 statement of net assets and will be credited to the affected participants’ accounts in 2025.

## NOTE 8 – RISKS AND UNCERTAINTIES

The participants direct the Plan to invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

## NOTE 9 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company reserves the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully-vested in their employer contributions.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

#### NOTE 1 – DESCRIPTION OF PLAN

The following description of the Ultra Pro International, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all employees of Ultra Pro International, LLC (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Eligibility:** To be eligible to participate in the Plan, an employee must be at least 18 years of age and have completed three months of service. Residents of Puerto Rico, independent contractors, employees whose employment is covered by a collective bargaining agreement, leased employees and certain nonresident aliens with no earned income from sources within the United States are not eligible to participate in the Plan. Employees may enter the plan on the first payroll date feasible but not later than the later of two pay periods or two weeks after the employee completes the eligibility requirements.

**Contributions:** Participants may make voluntary pre-tax or after-tax (Roth) contributions, by means of a salary deferral agreement of up to 100% of their compensation, subject to IRS limitations for the Plan year. The Plan provides for automatic enrollment upon eligibility and, accordingly, employees are treated as having elected 6% of their compensation as a pre-tax 401(k) contribution unless an election is made for a different amount or an election is made not to participate. Plan participants over the age of 50 are also permitted to make additional pre-tax and Roth catch-up contributions up to a maximum of \$7,500 in 2024. The Plan also permits rollover contributions from other qualified pre-tax retirement plans. Participants direct the investment of contributions into various investment options offered by the Plan. The Company makes safe harbor matching contributions equal to 100% of the first 1% of compensation plus 50% of contributions exceeding 1% not to exceed 6% of compensation. The Company may also make discretionary matching, discretionary profit-sharing and qualified non-elective contributions which are determined annually and announced in advance of each Plan year. No discretionary matching, discretionary profit-sharing or qualified non-elective contributions were made in 2024.

**Participant accounts:** Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, if any, and (b) plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting in the Company's safe harbor matching, discretionary matching, discretionary profit-sharing and qualified non-elective contributions, if any, is based on years of service with the Company, based on a two-year cliff-vesting schedule. Participants will become fully vested upon death or total and permanent disability.

**Notes receivable from participants:** The Plan allows participants to obtain loans from the Plan. These loans are subject to the following general provisions: the maximum amount of loans outstanding is equal to the lesser of \$50,000 or 50% of the participant's account balance with a minimum of \$1,000. The term of any loan may not exceed five years unless the purpose of the loan is to purchase the participant's primary residence, in which case the term of the loan may not exceed ten years. The loans are secured by the participant's account balance and bear interest at a rate equal to the prime rate (7.50% and 8.50% at December 31, 2024 and 2023, respectively) on the loan issuance date, plus 1.00%. Principal and interest is paid ratably through payroll deductions.

If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**Payment of benefits:** Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or, in the case of required minimum distributions, payment in annual installments not to extend past the lives or life expectancies of the participant and spouse. In case of hardship, a participant may apply for a distribution, minimum of \$1,000, described in the Plan agreement. Lump-sum distributions are required if the vested balance is \$5,000 or less. Actively employed participants may begin receiving distributions at age 59½.

**Forfeited accounts:** There were no forfeited nonvested accounts at December 31, 2024 and 2023. During 2024, amounts forfeited from accounts totaled \$11,153, all of which was used to reduce Company matching contributions.

## NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of accounting:** The financial statements are prepared on the accrual basis of accounting.

**Use of estimates:** The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain amounts reported in the financial statements and accompanying notes. Accordingly, actual results could differ from those estimates.

**Notes receivable from participants:** Notes receivable from participants are recorded at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are written off when deemed uncollectible.

**Investment valuation and income recognition:** Investments are reported at fair value using methodologies described in Note 3. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date.

Purchases and sales of investments, including gains or losses, are recorded on a trade-date basis. Interest income is recorded when earned, dividends are recorded on the ex-dividend date and capital gain distributions are included in dividend income. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Benefit payments:** Benefit payments to participants are recorded when paid.

**Administrative expenses:** Substantially all administrative expenses of the Plan are paid by the Company, unless otherwise paid for by the Plan, and are included in the statement of changes in net assets available for benefits.

**Subsequent events:** In preparing the financial statements, management has evaluated events and transactions for potential recognition or disclosure through October 10, 2025, the date the financial statements were available to be issued.

### **NOTE 3 – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – inputs to the valuation methodology include:

- a) Quoted prices for similar assets or liabilities in active markets;
- b) Quoted prices for identical or similar assets or liabilities in inactive markets;
- c) Inputs other than quoted prices that are observable for the asset or liability;
- d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value.

1. *Mutual funds (registered investment companies)*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively-traded.

The following table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

#### NOTE 4 – INCOME TAX STATUS

The trust established under the Plan, which holds the Plan’s assets, is qualified pursuant to the appropriate section of the Internal Revenue Code, and accordingly, the trust’s net investment income is exempt from income taxes. The Plan, as adopted, is a pre-approved plan, which does not require an application for a determination letter from the Internal Revenue Service (“IRS”). The pre-approved plan has received a favorable opinion letter from the IRS dated June 30, 2020. The Plan has not individually sought its own determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for the income taxes has been included in the Plan’s financial statements.

## NOTE 5 – INFORMATION CERTIFIED BY CUSTODIAN

In accordance with 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator has elected to restrict the scope of the auditor’s examination with regards to statements or information prepared and certified by Benefit Trust Company. The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified as complete and accurate by Benefit Trust Company, the custodian:

## NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

A certain employee of the Company is the trustee of the Plan, as defined in the agreement. The Plan issues loans to participants, which are secured by the balances in the participants’ accounts. These transactions qualify as party-in-interest transactions.

## NOTE 7 – OPERATIONAL ERROR

During 2024, the Company applied improper compensation base when calculating certain deferrals and employer matching contributions resulting in a missed deferral opportunity. The Company evaluated the missed deferral opportunity and determined that a qualified non-elective contribution totaling \$35,150, plus earnings, is necessary in order to correct the operational error. This amount is included in the employer contribution receivable on the accompanying 2024 statement of net assets and will be credited to the affected participants’ accounts in 2025.

## NOTE 8 – RISKS AND UNCERTAINTIES

The participants direct the Plan to invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

## NOTE 9 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company reserves the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully-vested in their employer contributions.
